

Childhood Vaccinations

Though realized by very few people, every shot on the Michigan childhood vaccination schedule can be refused by the signing of a simple waiver; though this waiver is virtually never mentioned as an option. It is up to parents to determine if their child(ren) should have all or o f the 3 2 none "required" vaccinations. The state health agencies and school systems have led the public en mass to believe that their children will not be allowed into schools or daycare facilities without them.

Due to this erroneous belief, countless parents have allowed their children to be mass vaccinated without really knowing the truth about what is in the vaccines or what these vaccines actually do to their forming brains and bodies.

Of the many shocking ingredients on the list in these seemingly innocent injections, which include aluminum, formaldehyde, anti-freeze, animal organ cells and human aborted fetal tissue, the most alarming is the preservative used to keep the vaccine serum from becoming contaminated by bacterial growth. This preservative is called Thimerosal and is nearly 50% ethyl-mercury. Mercury is one of the two most lethal substances known to man. Second only to uranium.


Mercury is highly poisonous and is well-known as a neurotoxin (meaning toxic to the brain and nervous system) according to the government's own documentation.

As the number of shots increased on the vaccination schedule, so concurrent was the rise in a whole host of neuro-developmental disorders, including ADD, ADHD, learning disabilities, speech delays, behavioral disorders, emotional disturbances and autism (to name a few).

In a decades time, from 1994 to 2003, Michigan's childhood vaccination compliance went from 61% to 81%, and the cases of full-blown autism rose 1,538%. Michigan went from being last place in the country for vaccine compliance to fourth, and we are now officially the fourth highest state for autism. Less than two decades ago, in this country, the rate of autism was 1 in 10,000 births.

Today it is 1 in 166. It is much more prevalent in boys, giving them now a rate of 1 in 33.

It has never been necessary to have the mercury-laden Thimerosal preservative in vaccinations to begin



with. It is far more profitable for the pharmaceutical companies to produce vaccines in multi-dose vials rather than single-dose vials. This allows one large vial to be drawn from, through a rubber stopper, numerous times as opposed to a single tiny vial discarded after one use.

More money for the pharmaceutical companies; more autistic children for America. Mercury-laced apple pie anyone?

IP/LSLC, TNC close on first stage of Keweenaw land sale

Editors Note: The following article was printed in KeweenawNow in January, <u>2002</u>. This was one of the beginning initiations by TNC and other eventual land-grabbing schemes by TNC across the U. P. and northern lower Michigan.

What is most intriguing, disturbing and of particular interest is the final paragraph in this article inserted by the author. This all reminds me of the Twilight Zone episode called "To Serve Man". The huge book was brought to earth by aliens, who showed humans how to thrive, raise crops and live in virtual comfort. At the end, one of the researchers discovered that the book, "To Serve Man", was really an alien cookbook on how to prepare man to eat.

HOUGHTON -- On Thursday, Jan. 3, 2002, International Paper/Lake Superior Land Co. (IP/LSLC) and The Nature Conservancy (TNC) closed on the first part of the Keweenaw Tip land sale totaling 4,069 acres for \$5.72 million. The second part of the transaction, totaling 2,206 acres for \$6.33 million, will close in December 2002.

Under the purchase agreement, TNC will purchase a total of 6,275 acres at the Tip of the Keweenaw Peninsula and hold it until state funds become available for purchase by the Michigan Department of Natural Resources (DNR). The project will conserve the forested character of the land and protect important recreational and ecological resources, including 6.5 miles of Lake Superior shoreline, 4.8 miles of inland lake shoreline and 3.5 miles of Montreal River shoreline.

Jeff Knoop, director of land protection in TNC's Upper Peninsula office in Marquette, said the \$12 million land sale is one of the most significant acquisitions that the State of Michigan DNR and The Nature Conservancy have ever done under a cooperative agreement.

"This acquisition protects some of the most wild and pristine lands remaining in the Upper Peninsula of Michigan (and) connects to approximately 2,500 acres already owned by the DNR," Knoop said on Jan. 3, after the closing. "It also connects to 1,500 acres already owned by TNC."

Knoop said the connecting lands bring the total of protected Lake Superior shoreline to about 12.5 miles. He noted also that the purchase will protect wildlife -- including lynx, possibly wolves and many rare and endangered birds, fish and other mammal species. Knoop said he spotted a lynx on a visit to Hoar Lake, one of the areas included in the first part of the land sale.

Rolf Peterson, professor of wildlife ecology at Michigan Technological University, said he was unaware of any lynx in the Upper Peninsula, but the land sale could secure wolf habitat for the future. Although the amount snow in the area presently limits the number of deer and therefore the number of wolves, Peterson noted, the Tip of the Keweenaw provides habitat for snowshoe hares (which are prey for many carnivores and critical for lynx), bobcats, fisher and marten. The fisher (of the weasel family) and the marten were formerly extinct in Michigan but reintroduced in the 60s and 80s, respectively, he added.

"It's certainly potential moose habitat, but to my knowledge there aren't any moose out there yet," said Peterson, who has done longterm research on moose and wolves in Isle Royale National Park. Peterson called the land purchase by the state through TNC a wonderful idea.

"It's time somebody came to the table to secure valuable land for public use," he said.

Dave Lieser, IP's region manager of the Northern Operations for Forest Resources, said the company's economic goals and the conservation of natural resources are not mutually exclusive.

"This land sale to The Nature Conservancy provides yet another example of how economic and resource conservation goals converge to benefit the public, the environment and our company," Lieser said.

TNC will transfer the first part of the land purchase to the DNR in February 2002, when the Michigan Natural Resources Trust Fund money becomes available. On Sept. 12, 2001, the Trust Fund Board recommended \$5 million for the Keweenaw Tip project and also committed to recommending the remaining \$7.5 million in 2002 to complete the purchase by the state. The final transfer of the remaining acreage from TNC to the DNR is anticipated for August 2003.

Jim Ekdahl, DNR Upper Peninsula field deputy in Marquette, said public support and public patience played a big role in this project, which started as a land exchange proposal several years ago.

"This is a great day for all of us who care about natural resources in Michigan," Ekdahl said on Jan. 4. "It's really satisfying for all of us to see the kind of resolution we were able to achieve. We knew there was a better way to acquire this property than was presented by the exchange. It's particularly satisfying that in this situation we have a net gain of public land and natural resources, rather than having to give up one valuable area for another."

Michigan Rep. Rich Brown, D-Bessemer, who has been a supporter of the land sale, was happy to hear of the closing.

"This is a great way to start out 2002 with the finalization of a project that has been in the works for years," Brown said. "A lot of people deserve congratulations on their hard work and dedication to this purchase. I am glad I could at least play a small part in making this a reality."

The purchase will include sand and gravel rights, but in a separate agreement, International Paper will negotiate the potential sale of deep mineral rights on these lands exclusively with the State of Michigan. Through the Sustainable Forestry Initiative (SFI) program, the company will continue to own and manage some 109,000 acres of forestland above the Portage Canal in the Keweenaw Peninsula.

Founded in New York State 50 years ago, The Nature Conservancy is the world's largest private conservation organization. Its mission is to protect plants, animals and ecosystems by preserving the lands and waters they need to survive.

International Paper is the world's largest paper and forest products company. Businesses include paper, packaging and forest products. As one of the largest private landowners in the world, the company has managed its forests under the principles of the SFI program, a system that ensures the perpetual planting, growing and harvesting of trees while protecting wildlife, plants, soil, air and water quality. Headquartered in the United States at Stamford, Conn., International Paper has operations in nearly 50 countries and exports its products to more than 130 countries.



"The Victimization of Valerie Lantz"

Valerie Lantz is a single, well-educated 56 year-old woman farming 79 acres high on a hill in the Keweenaw Peninsula west of Calumet, MI. This woman, who long ago enjoyed a professional career in the Land of Lincoln, loves her farm, once unencumbered by lien.

Entire life investments wasted on attorneys and others with their own environmental agenda, Val is now reduced to using food stamps whenever she can bum a ride to town. Truck needs repair, one tractor has died, and she owes for her hay because all income must satisfy debt incurred through treachery of those wanting her land and those others willing to help them get it.

When she bought and the moved to her farm, Val didn't know she'd nested among un-neighborly neighbors, some now identified as active members of the pyramiding land grabbing and controlling organizations throughout the U.P.

These neighbors, and others a bit further away, have victimized Valerie for well over a decade, making false claims of animal neglect, having her fence too close to the road and allowing beavers to set up housekeeping on her property, among several other things. No doubt beaver dams despoil the Nature Conservancy's wetland in their Keweenaw Peninsula watershed, located not too far from the U. N. and TNC Biosphere at Isle Royale.

Countless claims of cattle running loose, pigs on the prowl, and then finding unexplained breaks in the two-strand electric fence that interrupts the "Open Spaces" Valerie's neighbors wanted her to learn about at their eco-brainwash

meetings. She was invited to attend soon after being hauled off her farm in handcuufs because of a farm fence issue one of them had raised.

Val's best friend is her protector, a very friendly working farm dog named "Spirit" who heads and heels her cattle and watches that her pot-belly pigs and chickens don't come to harm.

Spirit, who looks like a healthy Shetland Sheepdog-Heinz mix, wards off wolves, coyote, cougar, and other predators that threaten his master and "their" animals. Deer are also unwelcome visitors. They can't be allowed on the farm to dine with livestock because of the T.B. threat and other diseases. However, Spirit doesn't try to run them down and kill them; he just chases them out of the pasture.

Val just spent ten months finding a ride to the Houghton Co. Courthouse to defend herself and Spirit from yet another trumped up charge. Spirit, the neighbors say, was seen viciously attacking a fawn in the ditch out in front of Ina & Joe Weiss' property by Ina & Suzanna (Sue) Raker.

He growled savagely at Sue, menacingly stalking all three, even Ina & Joe whom he'd known for 5 years, as the grievously wounded fawn was moved to shade or sun, depending on whom one wishes to believe. Val, however, with veterinary supplies at hand, wasn't even allowed to see the poor thing, as it lay wounded somewhere on the Weiss property.

Judge Kukkonen should have immediately dismissed the case upon learning that investigating officer, Dep. Mark Bukovich, who owns a "nature photography" business, left a sloppily penned and undated note, without compliment of envelope, in Valerie's mailbox summoning her to a court appearance on June 30, '04.

Bukovich, it seems, didn't notify the DNR, but he did find the time to call Mr. Weiss who <u>told</u> him the deer had died the next day. Val, however, has yet to see a ticket for allowing Spirit to stray, as he worked with her along the road front fence line facing the Weiss property.

Valerie refused to plead guilty, and after seven hearings at taxpayer's expense, the case went to jury trail on April 27, '05. She tried, but was no match for Watershed Council donator, Prosecutor Strome, who so thoroughly inflamed the jury at closing that they returned a guilty verdict within an hour's time.

Although Raker described a much different dog, and despite the fact that reasonably controlled farm dogs need not be leashed, Valerie Lantz has committed the crime of allowing Spirit to be unleashed that fatal day.

Val must now pay a \$210 fine plus a \$120 6-month probation fee. However, when she breaks probation, as one or more of her "Open Space" eco-system neighbors surely will claim she has, Val will sit in jail for 90 days while her livestock, and Spirit, get hauled away because she's no longer there to care for them.
