

CONFESSIONS OF AN ECOLOGIST BY JIM HAFEMAN

In the latter part of the 1960s and well into 1972 before I went active in the Marine Corps, I was a young ecologist. My Conservation teacher, Mr. Hemmila, was my ninth grade inspiration. By the 10th grade, and at the coaxing of Mr. Muehrcke, my biology and Earth Sciences instructor in High School, I headed up one of Michigan's first recycled paper drives. At a beer party in a little corner of a farmer's field, I was ridiculed for picking up the bottle caps before we left in the morning. My sense of environmental duty went with me throughout my Marine Corps years and continues to this day.

During my mid-life years we still recycle and enjoy the benefits of the U. P., except I haven't hunted since before I went overseas. Times in the woods have changed. During the last ten minutes of firearms deer season in 1969 or 1970, my brother and I watched as an exhausted, huge buck, cross M-35 north of Rock. A man in a Volkswagen jumped out of his car, loaded his rifle and shot the buck on the railroad tracks. Not what we would call a sportsman.

As a police officer, I witnessed young liberals walking from the store, stuffing candy bars into their mouths and summarily dropping the wrapper, at times only a few yards from a trash can. I investigated reports of trash being dumped in the woods. After a half hour or so I usually came up with something to identify the culprits.

The first ecology symbol was a take-off of the peace symbol and then evolved into two "e" letters, one reversed; eventually the ecology flag was born.





Escanaba Timber Sells UP Forestland to Plum Creek

On October 4th Escanaba Timber LLC, formerly MeadWestvaco, announced its sale of 650,000 UP forestland acres to Plum Creek Timber Co. for \$345 million big ones. The deal, expected to close in the fourth quarter, will make Plum Creek the biggest private landowner in the state, bringing its northern Wisconsin and the UP holdings to about 1.2 million acres of forestland. Plum Creek now owns about 8 million acres of timberland in 19 states. International Paper's 475,000 acres is apparently still on the market.

Plum Creek is what's known as a Real Estate Investment Trust, but it doesn't just look at timber, it looks at what lies beneath the ground. Most of its property is commercial forest that will be used to grow timber, but thousands of acres are valuable because of other resources, namely coal, gas and gravel, among other things. Other acres have more potential as residential or recreational properties. Still more acres have notable environmental features and, in those cases, Plum Creek may sell either the land or development rights to conservation groups.

In fact, Plum Creek has done business with the Nature Conservancy so many times in the past that it hardly seems likely Governor Granholm need worry about how terribly hard she'll have to fight to save Yooperland for eco-tourists and Yooper sheeple.

In southeast Georgia, Plum Creek Timber is part of the Altamaha River Cooperative for Stewardship and Research along with International Paper, TNC, and the Georgia DNR. The Cooperative maintains a 300-foot wide buffer strip that's contiguous to the river and extends through the Plum Creek and International Paper properties.

In North Carolina, a "suite" of ecological sites is conserved under a Memorandum of Understanding between Plum Creek Timber, the NC Dept. of Environment and Natural Resources, and TNC to provide "protection" of natural areas under

Plum Creek's ownership.

In South Carolina, TNC has purchased 2,378 acres near the Santee River from Plum Creek Timber Co. This initial acquisition, which cost \$3,213,000, includes six tracts. The Conservancy plans to resell five tracts to the Forest Service. The 505 acre sixth tract will be sold to a "conservation buyer" subject to a conservation easement. In a press release accompanying the announcement of this deal, Plum Creek's Southeast Region V.P. and general manager said, "Plum Creek is pleased to work with the Nature Conservancy."

In Montana on October 10, 2003, Plum Creek Timber announced plans to sell almost 41,000 acres scattered throughout the Blackfoot River Valley for \$30 million to TNC, which also has the option to purchase another 47,900 acres within the next few years for about \$38 million. As of last September, all former Plum Creek land owned by TNC had been posted with specific public use regulations, which included walk-in access for hunting, non-motorized recreation and personal-use firewood gathering of dead or down wood. TNC plans to re-sell the land to government agencies that own adjacent lands, and the remaining properties will go to private landowners with conservation easements attached.

In Louisiana, Plum Creek sold 4,750 acres to TNC at about \$1,832 per acre for a total of \$8.7 million. TNC planned to transfer this land to the US Fish and Wildlife Service over a period of five years beginning in 1999.

In Wisconsin on October 1, 2003 TNC announced that it had successfully negotiated for the right to purchase 21,322 forest acres from Plum Creek for \$4.5 million. The land was located on the reservation of the Bad River Band of the Lake Superior Tribe of Chippewa Indians and TNC immediately transferred its purchase right to the Bad River Band. It also sold to the tribe, at

cost, another 2,366 acres that had been purchased from Stora Enso North America in December of 2000.

According to their press release regarding the WI sale to the tribe, TNC states it has worked with Plum Creek and other corporate forest owners in other states across the South and New England. TNC and the tribe signed a Memorandum of Understanding, which describes the two parties' working relationship of this and future conservation projects. It was also noted that Wisconsin Governor Doyle applauded TNC, the Bad River Band, and Plum Creek for working together.

No doubt, in months to come, we'll hear about how hard the governor and TNC are scrambling to negotiate a deal with Plum Creek regarding its new UP purchase, but the facts support the theory that TNC and Plum Creek have been and continue to be cozy bed partners, just as it is with Forestland Group. What, pray tell, is going to happen when a buyer is found for the 475,000 acres now being sold by International Paper? Will there be a third sequel to Granholm's "Big UP Land Deal"?

The continuously putrid smell wafting to the UP from Lansing seems to be carrying the seeds of a set-up job to convince Michiganders that yet another conservation easement will be necessary to save Yooperland from the big bad developers...again.

It's the "Dear me, the sky is falling mentality", and it's getting to be old hat to some who would like to see at least some development, even if that development is a few million dollar homes along waterfront that's already zoned residential. Certainly, this isn't something that TNC didn't do, themselves, when they ruined some of the beaches in Virginia by selling land to the fat cats.

In a recent edition of the Marquette Mining Journal, a ditzy woman from Newberry was quoted as saying she didn't see why TNC shouldn't just be given the 1.1 million acres. How-



ever, those who believe in the sanctity of private property rights and traditional access question why a tax-exempt "alternate" conservation organization with billion dollar assets doesn't cough up their own money if they want to be in the land-use control business, particularly when a great deal of the land they want to control sits on top of globally coveted gas and oil reserves and vast mineral deposits.

Property with conservation easements on it must be policed to make sure the owners are in compliance with the terms of the easement. Who, we ask, is going to foot the bill for that on thousands and thousands of public acres? Will it become the onus of private property owners of adjacent lands, as has happened in other areas? Further more, why is the state entertaining more conservation easements and land acquisitions when the DNR can't possible maintain what they already have?

Over the years, Michigan has come to own lands that the DNR is now assessing for value. Earlier this year, after reviewing only the first group of ten counties, the DNR has already decided to keep or transfer 698 parcels, many along the coast of Lake Michigan, to a conservation agency, and will sell another 327 parcels. The review is ongoing and there's likely to be more palmed off to this unnamed conservation agency in the future.

If anything, public land should be turned over to the county in which it lies, and not to some non-profit, non-tax-paying, internationally IUCN partnering conservation organization. After all, the land belongs to the people, not the DNR or the Governor, does it not?



FENCING THE SOUTHERN BORDER

Support for the building of a fence along the U.S.-Mexico border is growing among Americans, asserts a group dedicated to passing federal legislation that would fund the erection of such a barrier.

We-Need-A-Fence says it began a television advertising campaign this week to push its idea of a 2,000-mile-long fence on the southern border.

"The first priority of the federal government is national security. National security is inherently incomplete if it does not include border security," the group states on its website.

Those behind the effort point to a recent CNN online poll showing 87 percent of respondents supporting the building of a security fence. Television ads for the effort are scheduled to run on CNN and Fox News Channel, according to the group.

http://weneedafence.com/ stresses the security danger of unimpeded illegal

immigration, noting that more than 100,000 "Other Than Mexican" illegals have crossed the border this year, including nearly 500 individuals from federally designated "special interest countries."

Speaking of the fence, the group states, "The multi-layered barrier would accommodate commerce, tourists and legitimate commuters with controlled crossings. With a price tag of \$8 billion, We-Need-A-Fence maintains that building a fence is a relatively inexpensive way to prevent the kind of inhumane and costly terrorist attacks that the nation has already suffered."

The activists say to properly patrol the border without a fence, the current number of 11,000 federal agents would have to be increased to 150,000 to 200,000 – at a cost of \$5 billion to \$10 billion annually.

The group is pushing for a barrier similar to the one used by Israel that would include:

* A ditch * Coils of barbed wire * Two tall, sturdy wire fences, with sensors to warn of any incursion. * A patrol path for vehicles between the fences * A smoothed strip of sand that runs parallel to the fence, to detect footprints, and * Closed circuit TV cameras and motion detectors.

We-Need-A-Fence is supporting a bill in Congress sponsored by Rep. Steve King, R-Iowa, that calls for the building of a border fence. The group hopes that any immigration law passed by Congress this fall will include a fence provision.

Editor's Note: The idea of a 2,000 mile fence is long overdue, but what about taking a little raft around the Gulf side or past San Diego? The aspect of tunneling is still alive and well also, so we need to have rods that extend a minimum of six feet below the fence line—the rods need to have magnetic detection that would enable the border patrol to identify changes that would occur during a tunnel excavation.
