I asked how much Lagasco was charging and he replied, "For you, \$1.89. For others, \$2.30."

"What, I exclaimed, "You mean you have one price for me and you're ripping off all the old grayhaired ladies all along the route to my place?"

"Well, the boss is afraid of you," he said. "Besides, gas at LaCourt's in Baraga is going for \$1.84 a gallon and the boss has to be competitive out here. So he's charging you \$1.89."

"Well, I don't want any today, and I think it's terrible to rip off the old folks living on cat food, and I don't want a fill," I said.

But, he said he might as well take a look because the boss would ask why he didn't, so I made him promise not to sue me for my wood stove if he broke his neck getting over the snow banks to the tank. As it turned out, we could have taken maybe 100 gallons, but I sent Joe Friendly on his way after we chatted for a short while about the pet-eating wolves in Tapiola and how life was treating us in general.

This problem with Lagasco (All Star Gas then) came to the surface a couple years ago when another driver drove in when early summer days were getting warmer. For some reason he stuck his head in the door first, and I asked how much they were charging. Believing it was much higher than what my neighbor had just paid LaCourt for a delivery, I said I thought we could make it through the summer with what we had. He went out to the truck and was going to leave, or so I thought.

Several minutes later there was a knock on the door and he popped his head back in and said, "Lady, have I got a deal for you today!"

He said he'd called the boss and I could have a discount that day. Since I'd called my hubby in the meanwhile, who thought gas might be higher in the fall and questioned my decision, I accepted a couple hundred gallons of "on sale just for you" liquid gold.

Then the last winter, we were away when a delivery was made and came home to find the bill stuck in the door. Again, I thought it was way out of line, and next day called LaCourt and talked to the boss, who didn't want to tell me how much he was charging his customers. When I explained that I was getting mighty fed up with the Chassell rip-off artists and why, and might be thinking of changing companies, I found out his gas was quite a bit cheaper.

Next, I got Joe Friendly delivery guy's boss on the phone and said, "Buddy, you and I have to talk. La-Court was charging \$1.21 for gas yesterday when you made a delivery here. I'm sick of you ripping me off,

and ripping gray-haired ladies and poor folk off, and as far as I'm concerned, next summer, you can get your tank out of here!"

## Fur Flies Over UPPCo Land Sale By C. J. Williams

Boy, what a catfight ensues when environmentalists get into a hissing contest with developers wanting to make a fortune preparing land for ritzy vacation homes in the north woods! It's sort of like the infighting within the sportsman's community, one faction pitted against the other for the spoils of the hunt.

Yes, I'm writing about UPPCos land sale to Naterra Land Company, particularly the property at Ontonagon County's Bond Falls Reservoir, which the restricted-use, eco-environmental developer and no-land-use Wildlanders are haggling over.

All heck is breaking loose and the anti-development Wildlanders now have the Federal Energy Regulatory Commission (FERC) all riled up through a letter writing campaign. Could be only rumor, but the scuttlebutt is that FERC may put the skids on the whole shebang. Then there's that matter of the Wildlanders' goal to reestablish "old growth" forests, which means no tree cutting and no "viewshed" to the ole Bond Falls water hole.

To top off FERC's involvement, the DNR is also now involved because some re-wilders believe land being eye-balled for development may actually be habitat set aside for wolves. Throw into this mix the DEQ, and you've got quite an Alphabet Soup. But, while they're all still hissing at one another, let's examine some background about this three-ring circus.

WPS Resources is a holding company based in Green Bay, and its principal subsidiary is the Wisconsin Public Service Corporation. Its other subsidiaries include UPPCo and WPS Energy Services.

On December 8, 2004, UPPCo filed an application with the Michigan Public Service Commission (MPSC) for approval of the disposition of net proceeds expected to result from sales of certain of its U. P. land holdings.

In its application UPPCo indicated to the MPSC that it owned approximately 7,300 acres of undeveloped and partially developed land adjacent to its AuTrain, Bergland, Bond Falls, Cataract, Prickett, and Victoria hydroelectric facilities, which the FERC determined was unnecessary for hydroelectric operations.

According to the "Opinion and

Order" issued by MPSC, and subsequently signed on April 28, 2005, UPPCo also indicated that it was "exploring the sale of the lands with both the State of Michigan and private investors", stating that the "sale of the lands to the State would enhance the preservation of existing pristine lands and/or create additional recreational areas, and sales of the lands to private investors for development would have a revenue-producing impact, thereby improving the general economy of the area".

It's stated in that document that the Commission found that "the settlement agreement was reasonable and in the public interest, and should be approved. Sales of the lands, either to the State of Michigan and/or private investors for development purposes should result in improvements to the local and State economy".

However, a May 5th WPS Resources press release padded the potential buyer list by telling the public that UPPCo had indicated to the MPSC that it was "exploring the sale of the lands to governmental agencies, conservation groups, and private investors."

Conservation groups? As in protectors of Upper Peninsula "pristine" UN Bio-reserve acres, like The Nature Conservancy, which just can't seem to get its glommers on enough access to more and more U. P. land to control?

Sure enough! TNC was offered the parcels, but since the tax-exempt and unlicensed real estate broker, creatively partnering with the State, can't use its own billions to buy its own bio-reserve acres, they just had to say, "No thanks."

Now that fur is flying, UPPCo has disclosed that they did, indeed, offer it to the State, Feds, TNC, and the Tribes, but all declined so they took Naterra's offer. Set up job, perhaps?

According to Ontonagon radio station Y-101 news, UPPCo has sold only a little over 1,000 acres to Naterra, leaving another 6,200 acres to peddle.

Surely the State won't want that either, especially since the Natural Resources Trust Fund just coughed up mega-millions for the conservation easement on Granholm's U. P. Big Deal, plus a couple more deer yards to manage, etc., and also since Gran-

holm is considering picking up a conservation easement on some former Mead (now New Page) acres, and maybe even some of the International Paper forestland now on the market. Nothing like shopping in the forest, eh?

Anyway, it looks like it'll be up to Naterra or another eco-land development outfit to get the north woods primed for elitist get-a-ways tucked in amongst the trees in planned little sustainable vacation settlements far from the maddening Sheeple crowds in urban Eco-Ville.

Naterra Land Company is a Minneapolis-based outfit, owned by Phil Taylor, who hopes to connect a million people to nature within the next 25 years. Of course, he's likely also planning to get filthy rich doing it.

About a year ago, Taylor consolidated all his businesses into one company and christened it Naterra, a combination of the word "nature" and "terra", the Latin word for land, which he felt better reflected the company's commitment to nature.

Prior to consolidation, Taylor Investment Corporation did business as Taylor Investment and Four Season Realty in MN, WI, and MI, specializing in lakeshore property. In the southern states, Tennessee and Georgia mountain property, as well as Texas hill-country home sites, were offered under the name Taylor Investment and Four Seasons Properties.

Perhaps anticipating a successful bid for the UPPCo property, as well as other Yooperland waterfront, hilly, or mountainous acres that just might become available, Naterra is opening an office in Marquette next spring, after which it plans to launch four "projects". Meanwhile, they've set up shop in a temporary office in Marquette and also have an office in Watersmeet.

Naterra already offers some Marenisco-Gogebic area home sites on Stateline Lake at the "Red Maple Landing" project. Lot sizes vary from 1.6 to 2.7 acres with from 100 to 895 feet of lake frontage, and the lots are priced from \$94,950 to \$199,950.

Another Naterra development "project" now offering lots is "Keweenaw Hideaway" on Mud Lake, east of Lake Linden. The guaranteed build-able lots range from 1 to 3 acres

with 116 to 221 feet of water frontage, and are being offered from \$52,950 to \$54,950. Prices are, however, subject to change.

Protective environmental "covenants" apply to both of the projects, just as they do on other property Naterra readies for buyers of eco-lots.

According to information cited on Naterra's Keweenaw Hide-ehole Website page: "Covenants, Conditions, and Restrictions (CCR's) are beneficial because they protect your property from unwanted use. Most importantly, they provide rules for how your neighbors can and can not use their property, which makes it harder for them to do something that would depreciate the value of your property...Properties with CCR's tend to hold their value much better than properties without." (Ya, right. Restrictions are all the rage!)

Lots being developed by Naterra at their northeastern Minnesota "Voyager's Retreat" project carry covenants, too, including a minimum house size of 1,500 square feet, what sorts of other structures can be built on the lots, and mandated setbacks from the lakeshore. It's also possible that surface water use will be limited. Then there'll likely be mandates for "rain gardens" and "no-mow" zones along the waterfront to protect the shoreline and provide habitat for crawling things, like wood ticks and eco-neighbor

So there we have it folks. The eco-twits wanting no land-use, no more roads, and a return to pre-1492 times are having a hissing contest with the dictatorial restricted land-use developers reaching out to fat cats with more money than brains. What ever happened to normal, as in none of the above?
