The imposition of the graduated income tax, which garners a higher percentage of taxes based on income levels, has helped keep the middle classes in check. Lower middle class citizens may also get more money back from their taxes than they paid-in because of the graduated tax rates.

Middle and upper middle income families may give as much as 51% of what they earn toward various taxes. The tax liabilities that most middle class families endure results in ever-decreasing discretionary funds while the wealthy have sizable deductions to help keep them wealthy. Deductions are subjective.

The predisposition suggests the income

gap between the poor and wealthy is getting bigger. In reality the gap between the middle class and the wealthy has grown exponentially over the last decade, but the middle class has come a lot closer to those who are living near the poverty line. The reality is that the redistribution of wealth only goes two ways; to the poor and to the wealthy.

Generally, and incidentally, distributions are conducted through the government by way of hand-outs or through tax relief, the award of contracts, or other exchanges. The wealthy also enjoy tax loop-holes while the middle class has few obvious deductions.

At this point the U. S. economy is really booming. However, if you ask a person of modest means whether the economy is booming or not, the answer will be that it isn't. The perceptions are different; those who have investments in the stock market and oil have a perception that the economy is doing quite well while those who work from pay-check to pay-check are victimized the most at the gas pumps, which in turn affects the cost of food and utilities and has diminished middle-class discretionary funds by an average of 20 to 30% since gasoline prices went above \$1.50 per gallon.

Middle-income wage earners are targeted by insurance companies as well. Much of what middle-income workers pay for their insurances are based on their household incomes, which is not necessarily comparable with their ability to pay. Another obvious issue is the wage-earners privacy rights. Most harmful to the economic situation is the minimum wage. Entry-level employees who work 40-hours a week in Michigan now earn \$7.15 and on July 1, 2008 they will earn \$7.40.

Small business owners with two or more employees are left with only two options; they may reduce the wages that could be earned through promotions or they may lay-off those extra hands. Most employers will opt to layoff extra workers as the distance between what the entry-level employees and the supervisors earns become more narrow. The minimum wage has effectively done-away with two substantial work incentives; pay increases based on productivity and promotions based on performance.

Union workers also experience the staggering discrepancies as well. No matter how skilled and dedicated a worker is today, he or she won't earn any more than the most incompetent and lazy person among all of them; it's a system adopted by our government and has been adapted quite effectively by our politicians as well. Those who consider themselves progressives are far from being progressive, especially within our freemarket based society. Paper mill union workers are told to vote Democrat by their union leadership. Environmentalists, who also vote Democrat, are working to keep the loggers out of the woods. None of this makes any sense to the common man or woman, but to progressives, it's a natural way of life.

## More Illegal Immigrants, More Seats in Congress? By Candice Miller (R-Michigan)

The Sept. 6 editorial " Count Them In" played down the effect that illegal immigration has on congressional apportionment and the damage it does to fair representation for American citizens.

Every Election Day, non-citizens infringe on the right to proper and proportional representation for U.S. citizens as a result of the 14th Amendment, which requires that those in our country illegally be counted when seats are apportioned for Congress. I have introduced H.J. Res. 6 to correct this technical error by replacing the word "persons" in the amendment with "citizens." This would give American citizens, both native born and naturalized, fairer representation. The Census Bureau would still conduct a complete count of all people in the United States, but only the number of citizens in each state would be used for apportionment.

States with large populations of illegal immigrants receive a disproportionate

number of seats in the House of Representatives because non-citizens are included with citizens. For example, Montana has one representative for a population of about 895,000 citizens. The 34th District of California has one representative but fewer than 420,000 citizens.

Policies emerging from the debate on illegal immigration must reflect the will of U.S. citizens and should not be affected by those here unlawfully.

## Cuckoo for Conservation By C. J. Williams

DNR warns of cutbacks unless fees are raised: <u>http://www.mininggazette.com/stories/articles.asp?articleID=9147</u>

One of the front-page headlines greeting readers of the Oct. 12th edition of the Michigan Outdoor News screams in big, bold face print, "Legislature cuts tax hike for conservation".

At first glance one thinks, "Uh-oh, what did the dirty beggars do now?" But, after a couple readthroughs and a little common sense, comes the understanding that it's most likely a good thing that not all of the Michigan lawmakers are cuckoo for conservation or they'd have driven the tax knife even further into state residents' pockets.

The informative article written by Editor Bill Parker explains that when the legislators were hunkered down at the 11th hour, deciding how best to stick Michigan citizens with tax hikes on Oct. 1st, they elected to remove a "conservation amendment' to the income tax increase proposed by Rep. Matt Gillard, D-Alpena.

Gillard's amendment would have fattened the state's Game and Fish Protection Fund to the tune of \$42 million annually, and, according to Parker, it's that fund, which legislators are constitutionally forbidden to raid, that provides much of the DNR's operating budget.

Had it survived, the earmark would have directed 0.025 of 1 percent of the tax hike into the Game and Fish Protection Fund that's tapped to pay for conservation officers and wildlife management, making all taxpayers liable for some of the MI-DNR's budget instead of just sticking hunters, fishermen, and trappers with the financial onus.

But, stick us they will and since someone has to make up the projected \$8 million deficiency in the DNR's fiscal year 2008 budget, which began Oct. 1st, the state's olive drab clad agency plans to cajole our lawmakers into approving a 50 percent incremental hike for sportsmen's license fees over the next four years.

That's right, folks, as yours truly types this article on Oct. 23rd, the State of Michigan already has another budget crisis, and I don't mean just with the DNR, even though the tax-alcoholics haven't yet completely resolved the one for FY 2007.

DNR spokesperson Mary Dettloff told Michigan Outdoor News that Gillard's earmark would have eliminated the need for a license fee increase and that the DNR's budget for 2008, which was approved by the Governor and Legislature, is based on some sort of incremental license increase.

Clearly, the Governor and lawmakers put the cart before the horse when approving the DNR's 2008 budget with an already known \$8 million shortfall, and rather than sending the DNR budgeteers back to the drawing board, they opted, instead, to give a nod of approval and let the chips fall where they may.

As of FY 2003, the State of Michigan had a surplus of at least \$10.13 Billion in taxpayer money that the government wasn't using, and unless the Granholm administration has blown it all away.

most should still be there, particularly the seed money that's been salted away in restricted funds.

According to information found on the CAFR Network Website at carfman.com, "the budget only covers a small portion of the State's financial condition. There are a group of funds not part of the budget process. The complete list of funds and budgetary requirements are found in the Comprehensive Annual Financial Report (CAFR). This report depicts the complete financial status of the State. The actual budget covers only a portion of the financial resources of the government."

In other words, when Gov. Granholm and the Lansing legislators were publicly crying the blues because they'd blown their wad through overspending, and were threatening to shut down necessary services to resolve the '07 budget crunch, they kept mum about other revenue. And, instead of making a "tough" decision to come to the taxpayers with a request to get at that other revenue, they opted to get tough with state citizens and tax the heck of them.

As of 2003, there were a total of 81 government funds that had cash and investment reserves that weren't being used. Since then, additional funds have been set up, including the Fire Protection Fund padded with excess "Driver Responsibility Fees".

Some examples of the '03 funds posted on the CAFR site are:

The Game and Fish Protection Fund, a Special Revenue Fund and part of the budget, had net expenditures of \$8.5 million, but also had cash and investment reserves of \$37 million.

The Bottle Deposit Fund, also part of the budget, had net expenditures of \$3.3 million and reserves of \$125 million.

The Michigan Natural Resources Trust Fund, a Permanent Fund and not part of the budget, made a profit of \$37 million in '03 and had reserves of \$321 million.

The Michigan Unemployment Compensation Fund, an Enterprise Fund, had net expenses of \$665 million, but also reserves of \$1.7 billion.

All totaled, in 2003 there was a collective surplus of a little over \$361 million in just the eleven conservation, environmental, and recreation related funds alone, and that's in addition to surpluses of \$321 million in the Natural Resources Trust Fund, \$141.5 million in the State Park Endowment Fund, and \$20.5 million in the Michigan Civilian Conservation Corps Endowment Fund.

It's interesting to note that on Sept. 27, 2007 Sen. Michael Switalski (D-Dist. 10) proposed Senate Bill 799 to appropriate \$20 million from the Michigan Civilian Conservation Corps Endowment Fund to the General Fund as a measure to close the gap between expected FY 2007-2008 revenue and spending in other areas of state government. Though this would essentially have had the effect of ending the depression-era program that still pays some 18-25 year olds a minimum wage to help out at state parks, an amendment to require the DNR to find other ways to fund it, such as corporate sponsorships, was added before the legislation passed in the Senate two days later on Sept. 29th.

So you see, there are ways to get at the hoarded surplus of taxpayer money purportedly earmarked to pay for this program and that project. And, since everything government does is supposed to be done by law, it is the legislature that can change those laws having to do with money hoarded in cash and investment funds if the lawmakers really want to make a tough decision instead of taking the easy way out by sticking it to taxpayers, many who are also sportsmen who'll get a double whammy once license fees go up.

In his Outdoor Observations column in the Oct 12th Michigan Outdoor News, Bill Parker wrote that "of the DNR's \$288 million annual budget, only about 9 percent (\$25.3 million) comes from the state General Fund, and half of that is designated specifically for payments in lieu of taxes to local units of government.

Well, cry me a river and sing the blues til you're hoarse, but a simple fix is to require the Natural Resources Trust Fund board to cease and desist with buying more state land to make PILT payments on and quit with the grants for more conservation easements on property somebody else owns. Put some money from the fund toward the DNR budget when the state is strapped.

Considering that in 2003 there was about \$682 million in surplus dollars sitting in various and sundry "cuckoo for conservation" funds, perhaps it's time to use the interest generated and/or part of the capital for something other than Gang Green's agenda. Perhaps now is a good time to put surplus state revenue toward necessary services like funding schools, police and fire departments, and prisons, and not toward yet another special fund such as the "Wildlife Action Opportunity Fund", which the Michigan United Conservation Clubs is now proposing.

At this point, when there isn't enough money to steer the Ship of State off the shoals of financial ruin without stabbing taxpayers in the back and/or increasing sportsmen's license fees, the citizens of Michigan simply can't afford to be cuckoo of conservation.  $^{\sim}CJ$

Fraud is rampant, even here in the Upper Peninsula. Theft of identity is on the rise. The problem is that it isn't really a local issue, but a world-wide problem. Your information is stored on computers owned and operated by the government and businesses.

In one case scenario a US citizen's Social Security number had been stolen and used 42 times—the Social Security Administration had not noticed the various transactions.

Your government is quite capable of taking a photo of a license plate from 120 miles up in space and listening to multiple telephone calls at once. Yet, even though some private businesses like FedEx and UPS can track millions of packages all at once, your own government isn't capable of keeping an eye on 900 FBI files or tracking visa holders who overstay their welcome.

The wife of a friend of ours received a Sears credit card bill. She hadn't used the card in nearly 20-years. The charges were for about \$12, but she immediately called Sears.

The company went out-ofits-way to rectify the situation and handed her case over to a fraud agency. A private company sponsored by the Citi Identity Theft Solutions, handled the case very professionally. The toll free number at the beginning of this article will get you started with a monitoring and check-up of your credit report; it's free for 90 days.

In an earlier fraud case through Radio Shack, a physician in the UP ended up with over \$200 worth of charges. Radio Shack was hell-bent on making the doctor pay the charges. Two companies; two different approaches. The doctor had to hire a lawyer to fight Radio Shack's incompetence.

Although we aren't thrilled that Citigroup has provided over \$300,000 to the top two Democrat presidential candidates, the company does serve a purpose. Identity theft is very real and a few companies are growing by leaps and bounds by simply offering credit monitoring. They also monitor Social Security numbers, which really shouldn't be their job since the SSA is the agency that issues the numbers and oversees their use. And, if you think we have problems with ID theft now, wait until the feds takes over your health care system.

Remember the information that was on the laptop computer that a VA employee took home and then had stolen from his home?

Recent discoveries also indicate that the communist Chinese have been infiltrating our governments' computer networks, including the FBI. Like the Clintons, they could easily extort a citizen through manipulations and the same types of threats of public disclosure.

Telephone scams are also a reality here in the UP. Senior citizens are targeted mostly because they're too trusting; they also think that the FDR democrats are alive and well.
