## HOW TO RECALL ENEMY SYMPATHIZERS IN MICHIGAN

### OFFICERS SUBJECT TO RECALL

All elective officers in the state, except judicial officers, are subject to recall by the voters of their respective districts. An officer who is being recalled may continue to perform the duties of his or her office until the result of the recall election is certified (168.951).

### TIME OF FILING

A recall petition cannot be filed until the officer whose recall is sought has served at least six months in his or her current term of office. It may be necessary for the county clerk to check state and local statutes to determine the exact date when the officer's current term began.

A recall petition cannot be filed during the last six months of an officer's term of office (168.951).

### SPONSOR OF RECALL WORDING

- Must be a registered voter in the same district as officeholder to be recalled.
- County Clerk issues a receipt for recall wording.

### CLARITY REVIEW

County Election Commissioners are required to review the language of a recall petition before the petition is circulated.

### Submission of Language

Sponsors of a recall effort submit language of their petition to the Board of Election Commissioners in the county where the officeholder resides (168.952(2)). The Board is comprised of the county clerk, county treasurer and chief judge of probate (168.23). Under normal circumstances, the language is submitted to the county clerk in a letter or on the proposed recall petition form. A separate submission must be made for each officer whose recall is sought. The county clerk accepting the petition language issues a receipt to the sponsor of the language, which shows the sponsor's name, address, phone number, and the date of the filing. The county clerk retains a copy of the receipt for the Board's records.

### Scheduling Clarity Review

The Board is required to meet sometime between the 10th and 20th day after the filing of the recall language to conduct the clarity hearing.

When the required meeting is held, the function of the Board is TO DETERMINE WHETHER EACH REASON FOR THE RECALL STATED IN THE PETITION IS OR IS NOT OF SUFFICIENT CLARITY TO ENABLE THE OFFICER WHOSE RECALL IS SOUGHT AND THE ELECTORS TO IDENTIFY THE COURSE OF CONDUCT WHICH IS THE BASIS FOR THE RECALL. The officer whose recall is sought and the sponsors of the petition may appear at the meeting and present arguments on the clarity of the petition language (168.952(3)).

### Clarity Determination

It is important to emphasize that only the clarity of the recall language is subject to review by the Board; the Board does not have the authority to rule on the reasons for the recall 168.952(3).

### PREPARATION AND CIRCULATION OF RECALL PETITIONS

As soon as the sponsors of a recall effort have the clarity of their petition language approved by the appropriate Board of County Election Commissioners, they are free to circulate their petition.

### The Petition Form

Recall petitions must conform to the specifications prescribed by the Secretary of State (168.952a).

A separate petition must be circulated for each officer who is being recalled (168.958a). Recall language printed on the recall petitions that are circulated must be the same language approved by the Board of County Election Commissioners (168.952(2)). Circulation of Recall Petitions

Recall petitions are circulated within the district represented by the officer whose recall is sought (168.954).

Circulators of recall petitions must be registered to vote in the electoral district of the official whose recall is sought (168.954).

Before a recall petition can be circulated, the circulator must complete the "heading" of each petition sheet by filling in the following:

1. the county and city or township where the sheet will be circulated, or
2. the village where the sheet will be circulated

The sheet may not be circulated outside of the jurisdiction listed in the sheet heading. (NOTE: recall petitions may not be circu-

lated on a "countywide" basis.)

The circulator may not leave a recall petition unattended in a public place; all signatures must be signed in the presence of the circulator (168.957).

The circulator must complete and date the certificate on the bottom of the petition sheet after gathering the last signature he or she intends to collect on the sheet. Signatures on a sheet, which are dated after the date on the circulator's certificate, are not counted (168.958).

### Signers of Recall Petitions

Signers of recall petitions must be registered to vote in the electoral district of the official whose recall is sought.

Each signer must list his or her signature, address, post office and the date of signing. If the recall petition is circulated within a city or school district that crosses county lines, each signer must be instructed to execute his or her signature on a petition sheet bearing the name of his or her county of residence in the heading (168.954).

All signatures must be signed in the presence of the circulator (168.957).

A signer is not permitted to sign for anyone else. For example: a wife may not sign for her husband (168.957).

Number of Signatures Needed; Signature "Ripeness"

The number of signatures needed to recall an officer is 25% of the votes cast in the officer's district for all candidates for the office of Governor at the last November general election. Upon written request, the county clerk is required to supply the minimum number of valid signatures needed to recall an officeholder. The figure must be calculated and delivered to the requester within 5 days after the county clerk's receipt of the request. (If the 5th day falls on a Saturday, Sunday or holiday, the county clerk has until the following business day to honor the request.) (168.955)

Signatures on a recall petition dated more than 90 days before the filing of the petition are invalid (168.961). Petition language is valid for a period of 180 days from the date of Board approval.

*Editor's Note: Signed recall petitions should not be filed with the State until after the elected official has had 6 months in office. Staring the process and getting signatures in 90 days is the most difficult task.*

## GORE'S GLOBAL WARMING GARBLE BY C. J. WILLIAMS

Former Vice President Al Gore, long a champion of environmentalism, recently won an Oscar for his documentary, "An Inconvenient Truth", which primarily is footage of Gore giving a power point presentation – a slide show – related to his take on the science of global warming.

For several years Gore has been traversing the country with his slide show, beating the drum for "sustainable development" and conservation of our natural resources. Now the traveling slide show has been immortalized in a Hollywood documentary.

Using the ramifications of global warming as a fear factor, Gore puts the major blame for global warming on mankind, not on forces of nature over which the common man has little control, though, in truth, people aren't the primary culprit; Mother Nature is, especially when she's being manipulated by research and developers wanting to test new weather modification technologies.

To mitigate global warming, Gore wants the Americans to downsize and conserve on energy, but it appears he doesn't want to practice what he preaches.

Gore and his wife divide their time living in two homes: a 10,000 sq-ft, 20-room, eight-bathroom mansion in Nashville, and a 4,000 sq-ft home in Arlington, Virginia. He also has a farm near Carthage, Tennessee. Apparently, in Gore's estimation downsizing applies only to peons, not people of his stature.

According to the Department of Energy, the average American household consumes 10,656-kilowatt hours (kWh) per year, but in 2006 Gore used nearly 221,000 kWh, more than 20 times the national average.

To put it more succinctly, the Tennessee Center for Policy Research states, "Gore's mansion, located in the posh Belle Meade area of Nashville, consumes more electricity every month than the average American household used in an entire year, according to the Nashville Electric Service. In his documentary, the former vice President calls on Americans to conserve energy by reducing electricity consumption at home...Last August alone, Gore burned through 22,619 kWh – guzzling more than twice the electricity in one month than an average American family uses in an entire year."

In response to that "inconvenient truth" Gore claims he uses "green power", but records indicate this wasn't so as of Dec. '06. He also claims he's installed solar panels and compact fluorescent bulbs in his homes and buys "carbon offsets" to mitigate his family's "carbon footprint".

Where does he buy these "carbon offsets"? He buys them through Generation Investment Management LLP, a firm he helped found in 2004 along with five other men, including three with ties to the scan-

dal-ridden, wealth management firm, Goldman Sachs. Gore is chairman of Generation Investment Management LLP and is actually buying carbon offsets through his own investment company.

A "carbon offset" is an emission reduction credit from another organization's project that results in putting less carbon dioxide or other greenhouse gases in the atmosphere. For example, wind energy and solar power companies often sell these controversial offsets, which, in essence, presumably allow the buyer to be piggy about energy consumption provided he clears his conscience by tossing some money into the alternative energy racket.

As Kermit the Frog once sang so convincingly, "It's not easy being green". Perhaps it's even harder to pretend you are, particularly when you need to sweep your family's involvement with the likes of "influence peddler" Armand Hammer under the rug, as Gore seems to have conveniently done so peons don't hear about that inconvenient truth.

Armand Hammer, son of Julius Hammer who co-founded the Communist Party USA, was chairman of the Occidental Petroleum Corporation. He cultivated favorable relationships with politicians over several decades, but he was closest to Tennessean Al Gore, Sr., a U.S. senator from 1953 to 1971 who pleaded guilty in 1975 to providing hush money in the Watergate scandal.

After Gore, Sr. was defeated for reelection in 1970, Occidental Petroleum hired him at a salary of \$500,000 a year to head up its subsidiary, Island Creek Coal Company, and gave him a seat on Occidental's board of directors.

In 1972 Occidental bought a zinc-rich farm in Carthage, Tennessee for \$160,000 and a year later sold it to Gore Sr. for the same price, but the corporation also gave him an initial payment of \$20,000 for mineral rights on the land. On the same day that he bought the farm, Gore Senior sold it to Gore Junior for \$140,000 and from then until 1985 Occidental paid the former Vice President \$20,000 a year for mining rights on the farmland.

Occidental never did mine the zinc on the Gore farm, but in 1985 Gore Junior began leasing his mineral rich land to Union Zinc after Occidental sold its competitor the mining rights. Those rights changed hands a couple of times, but it appears that Pasminco, an Australian company, did mine the land until 2003. At his death, Al Gore, Sr. left Occidental stock in his estate valued at

hundreds of thousands of dollars, stock that was managed by his son.

Armand Hammer was as cozy with Gore Junior as he was with Gore Senior, and even after Hammer's death his corporation continued to funnel thousands upon thousands of dollars into Gore's campaigns and causes.

No doubt the influence peddling paid off for Occidental during the Clinton/Gore administration when, at a Dec. 19, 1994 "Reinventing Government" news conference with Pres. Clinton and V.P. Gore, Deputy Energy Secretary White announced the administration's intent to sell its 78% share of the Elk Hills Naval Petroleum Reserve; the other 22% was owned by Chevron.

The government had bought the reserve near Bakersfield, California in 1912 to ensure the Navy would have sufficient oil reserves, but it remained undeveloped until 1976 when Congress passed the Naval Petroleum Act to open Elk Hills and another reserve for production. From July 1976 until February 1998, Elk Hills alone generated a total of \$17.1 billion in revenue for the U.S. Treasury, against total expenses of \$3.3 billion.

Though it was a long, drawn out, three-year process between the announcement of intent to sell and the actual sale, on October 6, 1997 the Department of Energy announced that Occidental Petroleum Corporation was the high bidder for Elk Hills Reserve. Sale price: \$3.65 billion dollars, double what some government officials expected to get, but also 50% less than what many others believed it was worth at the time.

The administrative cost of the sale, which tripled Occidental's U.S. oil reserves overnight, was in excess of \$84 million, billed, of course, to the taxpayers, and although the Energy Dept. was required to determine likely environmental impacts of the sale, it hired a private company, ICF Kaiser International, to do the job instead. Gore's presidential campaign chairman, Tony Coelho, was a member of Kaiser's board of directors, but if the American people got screwed on this deal, we'll probably never know. The DOE refuses to disclose any information regarding the sale.
