### VOTERS POISED TO CROSS PARTY LINES TO VOTE IN PRIMARY

While the Republicans were unable to muster qualified individuals to run in a significant number of the local seats, they were also very weak at building credibility within the Party. With the exception of Wayne County there will be very few GOP candidates competing against each other for GOP nominations. However, in some of the districts located in Wayne County the Republicans don't have any candidates. Please visit the web site below; you will wonder what the Republicans have been doing for the last two years!

On the other side of the aisle the Democrats have more candidates than they can shake a stick at on their primary ticket. In the 108th State House District, there are four Democrats facing each other August 5th. Many of the local elections also see Democrats challenging each other.

In Marquette County, the 35-year incumbent Prosecuting Attorney retired less than two months after his reelection. His term ended in a retirement and his last term began as a combination retiree and tenured employee. The Marquette County Board of Commissioners did not reduce the Prosecutor's salary to what a beginning Prosecutor would earn; instead they kept his tenure salary intact. He will be challenged by the Steve Adamini "Justice We can Afford" Committee. Mr. Adamini is the former term-limited state representative. All are Democrats, with the exception of one Republican on the County Board of Commissioners.

In the Marquette County Sheriff's race, Democrat incumbent Mike Lovelace is being challenged by his former coworker and Under-sheriff Jim Bjorne.

While the time was ripe to replace all the incumbents holding State office, and most of those representing the State in DC, the Republicans seemed to recruit whomever they could just to fill-up the ballot. Only a hand-full of quality people are on the ballot for the GOP.

The Democrats have been loading up their primary ballots all across the State and it appears that even Republicans will have to participate in the Democrat elections. There will be several seats given to the highest vote-getter in the primary; the winning Democrat will be unopposed by any GOP or other party candidate in the General Election. Republicans do not belly-up to the polls and hold their nose to vote for the weakest candidate in a primary, but if they don't they will have to live with the one winning the primary.

### Students reprimanded for singing national anthem Jeff Johnson - One News Now - 7/22/2008

Officials at the California State Capitol are under fire for stopping a student tour group from singing the national anthem in the capitol rotunda.

Launch into an *a cappella* version of the Star Spangled Banner in the California State Capitol and a group could find themselves facing Capitol Security and officers of the California Highway Patrol. And that is what happened, says Brad Dacus, president of the Pacific Justice Institute, when a group of students touring the capitol, as part of the "City on a Hill" education program, spontaneously began to sing the national anthem.

"Upon hearing the students, a security guard there silenced them and said that they could not sing the national anthem unless they had a special permit to do so," explains Dacus. "This was an egregious abuse of discretion and a violation of the First Amendment rights of these students to be able to express patriotism and their love for their country."

Dacus adds the singing was not planned in advance and was not, in any sense of the word, a protest. "These students were not being disruptive in any way of anything that was taking place. There was no other event going on. There was no function of government that was being interrupted," he contends.

He argues that "[s]uch spontaneous expression of love for...country should never, ever be stifled by government when it's in no way creating a disturbance of any kind...."

Pacific Iustice Institute sent a letter to the Chief Sergeant at Arms for the Capitol informing him that citizens have a First Amendment right to express themselves in the capitol rotunda as long as they are not being disruptive, and that any future attempt to interfere with that right will result in appropriate legal action.

## Non-citizen voting -- election fraud in the making Jim Brown - OneNewsNow - 7/22/2008

A new study warns that fraudulent votes by non-citizens, including illegal aliens, could swing this year's local and national elections.

"When you learn that half of the 9/11 hijackers were registered to vote, that's when you realize that the honor system the country has for its voter registration system is broken," explains Hans von Spakovsky, a visiting scholar at the Heritage Foundation and author of a new report titled "The Threat of Non-Citizen Voting."


The study says tens if not hundreds of thousands of non-citizens, including illegal immigrants, are registered to vote nationwide. Former Federal Election Commission member von Spakovsky points out the U.S. expects individuals, when they register to vote, to comply with the law and not register if they are not American citizens -- but people are clearly breaking that law and there is no way for the government to detect it, he states.

"The state of Utah did a limited audit just of their DMV records," von Spakovsky contends. "That limited audit showed hundreds of aliens who were registered to vote, and one of the state senators said that if you extended that audit to the entire DMV records, he estimated that there were five [thousand] to 7,000 aliens registered to vote in that state."


Von Spakovsky says non-citizen voting is likely growing at the same rate as the alien population in the U.S.

Congresswoman Zoe Lofgren (D-California) believes the study is an effort by Republicans to disenfranchise minority voters. Von Spakovsky says Lofgren's claim is simply untrue. "The federal government requires all employers, before they can employ any American, to have that American present proof of citizenship. Now the states should be doing the same thing," von Spakovsky points out. "And I think it's pretty hard to claim that if the states were to ask for a proof of citizenship before you registered to vote in exactly the same way as the federal government requires you to provide proof of citizenship before you're able to get a job, that that somehow is discriminatory."

Von Spakovsky notes that one of the closest congressional races in recent vears - the Loretta Sanchez-Bob Dornan contest in 1996 - was "almost stolen" by non-citizen voting in California.

## August 5<sup>th</sup> Primary – Get Out and Vote By C. J. Williams

Americans for Constitutional Enforcement (ACE) of Iron Mountain recently sponsored a public forum for the three Republican candidates who want to replace Bart Stupak as 1st District Representative. Only one will survive the August 5th primary and it is now more critical than ever that voters make a wise choice, particularly with the looming transformation of Canada, Mexico, and the United States into a North American Union.

That letter set in motion the targeting of Tom Casperson for the 1st District seat through pleas for financial contributions and name recognition saturation in press releases regardless of the other contender's qualifications, regardless of whom the constituents might decide is the best candidate when they go to the polls on August 5, 2008.

So sure are they of his win that an invitation was issued on July 17th by the 1st Congressional GOP Party to attend an August 29th dinner hosted by the Houghton County Republican Party, where for \$50 a pop, guests can meet the invited postprimary election candidates. Casperson's name is among them and unless they're hosting a commiseration dinner, and not a celebratory one, the 1st District GOP and Houghton County Republican Party are quite obviously planning on him winning the primary since neither Goldthorpe nor Hooper has been invited.

Evidently, Casperson is willing to allow the MI-GOP leadership to treat 1st District voters like mindless sheeple, herded to the voting booth where they can dutifully put an "x" by his name. Those who attended the ACE public forum,

however, didn't appear to be mindless sheeple. Rather, they appeared to be very concerned about the direction in which our country is headed and very dissatisfied with the current Democrat and Republican leadership at all levels of government. ### EDITORIAL: Bailouts and Fannie, Freddie

Revelations that the Federal Deposit Insurance Corporation (FDIC) authored faulty and improper sub-prime loans to consumers after it took over operations of Hinsdale, Illinois-based Superior Bank FSB could not be more troubling and should signal Congress that rushing to pass reactionary bailout provisions and new regulatory legislation will likely be inadequate.

More than 6,700 mortgages worth in excess of \$550 million were doled out to consumers under FDIC authority, and hundreds of those borrowers who couldn't afford the loans have been foreclosed on, according to the Wall Street Journal. The FDIC is being sued by Texas-based Beal Bank that bought 5,315 of the loans from Superior alleging that half of them originated while the bank was under FDIC control. The FDIC, in an initial report, estimated it could be liable for about \$70 million. An agency official said the case could be settled for about \$23 mil-

IndyMac Bancorp Inc. was taken over by the insurance agency earlier this month, and there are several other banks on the FDIC's list of troubled institutions. That coupled with these new troubling revelations about the FDIC's handling of Superior raises some serious questions for the federal insurer. Taxpayers should pay close attention.

The current balance of the FDIC insurance fund stands at an estimated \$53 billion. If IndyMac folds, and it is highly likely that it will, the FDIC could be on the hook for about \$6 billion to \$7 billion - roughly 12 percent of the fund - to repay customers of one bank. At that funding level, the FDIC can currently insure about 10 bank failures. Then what?

What is the government going to do if the number of home foreclosures that have risen every month this year, 53 percent in June, continue to rise at a record pace launching even more banks toward the brink? The Bush administration opened the treasury coffers more than a week ago to allow Fannie Mae and Freddie Mac to borrow at reduced rates to save themselves from collapse, even as the two mortgage giants proclaim strength, as their liquid capital outpaces their obligations.

The Democrat-controlled Congress wants bailouts across the board and wants to hire more regulators to fix this mess. In this case, the 53 elected representatives and senators are going to have to sit down and think long and hard about reforming the entire structure and duties of the regulatory agencies.

Proclamations that everything will work out coming from Senate Banking Committee Chairman Chris Dodd, who wants bailouts and more regulation, won't cut it. Neither will Republican proclamations that the Democratic Congress is responsible, because Richard Shelby was the chairman of the committee for the majority of the time that these sub-prime lenders were doling out bad loans. Pennsylvania Avenue is flush with finger pointing. Taxpayers and conservatives want solutions, not buck passing.

Bam!!! Bret Clayton, the CEO of Rio Tinto Cooper Group, the parent company of Kennecott Minerals Corporation, spoke in Marquette on July 23, 2008. He spent time talking about the proposed mine on the Yellow Dog River Plains. Clayton said the mine is projected to go well beyond the previously estimated eight years and the mine may end up a lot bigger than the small snot-slot in the middle of forty acres.

Jerry Hume of WLUC TV-6 reported on the CEO visit (see link below). KMC and Rio Tinto flew over 150,000 acres to evaluate nickel, cooper and other natural ore deposits. There is an air of optimism in the north-central U. P.; our natural resources may actually once again become a major source of income for both the residents and businesses in the area rather than being merely an environmentalists' mission to keep the UP poor and eventually vacant — Bam!

KMC purchased the old CCI Headquarters building in Ishpeming and are in the process of major renovations. The historic building is adjacent to the CCI Mining Museum.

Finally, there are unconfirmed reports which suggest KMC may build a nickel ore processing plant in the Humboldt Township area. This will limit the ore that will be sent to Canada for processing. Once again-Bam! And thank you.

On the same topic, CCI is investing \$500 million to increase iron ore pellet production at the Empire Mine. Emily Pace of TV-6 News interviewed CCI President Donald Gallagher (see link below). Unfortunately the news story included interviews with the U. P.'s most famous environmentalists, Congressman Bart Stupak and State Senator Mike Prusi.

The iron ore production has went from the predicted 2011 closure date to 2018; a few more years to enable other mining interests to get established in the Upper Peninsula. The 550 employees with CCI on the Marquette Range will be retained and another 375 jobs will be added to the mix.
