Change. The concept suggests that business as usual will not be acceptable. Americans went to the polls and voted for change; they sent the same group that had a 9% approval rating back to their jobs. It may sound like some form of political insanity, but it's just simply a matter of impoverished intelligence.

Michigan liberals attack Lansing congregation in the middle of Sunday worship

This is what we're up against.

On Sunday morning, amidst worshiping congregants and following unifying prayers that our President-elect be granted wisdom as he prepares to lead our nation through difficult global, social and economic challenges, the Michigan left declared open war on peaceful church goers.

They did it with banners, chants, blasphemy, by storming the pulpit, by vandalizing the church facility, by potentially defiling the building with lewd, public, sex acts and by intentionally forcing physical confrontations with worshipers.

This didn't take place in some dystopian, post modern work of fiction and it didn't take place in San Francisco or Berkley. This was the scene at a Bible believing church in Lansing, Michigan.

I returned home myself yesterday, from church and an afternoon watching football with the family, to find an email in my inbox from a friend in the Capitol City. Isn't surprising to see her name in the inbox as she and I often compare notes on our Sunday services.

Truth be told, I've done my best over the last year to start a friendly little rivalry with her. My church is better than hers, I insist, and I have been known to tell her why. Hers is superior to mine, she reminds me, and lists the reasons. (I admit I'm maybe a tad hypercompetitive, but my church really is the best in the world.) Yesterday's email began with an understated proclamation; "So church today was exciting..."

On Sunday, November 9, 2008 Michigan liberals sat peacefully through announcements, worship and prayer for the sick, our nation and our President-elect before staging a coordinated, disgusting and repulsive attack on worshipers and the broader concept of the church itself at Lansing's Mount Hope Church.

The lefties were a part of a liberal organization known as Bash Back Lansing and their collection of radical blogs, including one of the state's most widely read "mainstream" progressive blogs (and none which will receive a link on this website) called on "queers and trannies" from across the state and the region to converge on Lansing for what they refer to as an "action." While many of the members claim to be anarchists (they drove on roads, ate non-garden grown foods, printed materials on products created by government protected free markets, wore clothing, talk incessantly

about "organization," etc etc etc) their broader goal is stated plainly on one of their lefty blogs.

"I can tell you that we are targeting a well-known anti-queer, anti-choice radical right wing establishment."

Mount Hope, for the record, is an evangelical, bible believing church whose members provide free 24 hour counseling, prayer lines, catastrophic care for families dealing with medical emergencies, support groups for men, women and children dealing with a wide variety of life's troubles, crisis intervention, marriage ministries, regular, organized volunteer work in and around the city, missions in dozens of countries across the globe, a construction ministry that has built over 100 churches, schools, orphanages and other projects all over the world and an in-depth prison ministry that reaches out, touches and helps the men and women the rest of society fears the most. They also teach respect for all human life and the Biblical sanctity of marriage as an institution between one man and one woman.

This is what Michigan liberals label a "radical right wing establishment," and over 30 of them showed up in force yesterday. Wearing secret-service style ear pieces and microphones they received the "go" from their ringleader and off they went.

Prayer had just finished when men and women stood up in pockets across the congregation, on the main floor and in the balcony. "Jesus was gay," they shouted among other profanities and blasphemies as they rushed the stage. Some forced their way through rows of women and kids to try to hang a profane banner from the balcony while others began tossing filiers into the air. Two women made their way to the pulpit and began to kiss.

Their other props? I'll let them tell you in their own words... from another of their liberal blogs:

"(A) video camera, a megaphone, noise makers, **condoms**, glitter by the bucket load, confetti, pink fabric...yeh." The video camera they put to good use as they attempted to provoke a violent reaction. The image of the pink-clad folks above is one of theirs, stating in a picture worth more than a thousand words the goals of the Michigan left.

The "open minded" and "tolerant" liberals ran down the aisles and across the pews, hoping against hope to catch a "right winger" on tape daring to push back (none did). And just in case their camera missed the target, they had a reporter in tow. According to a source inside the church yesterday there was a "journalist" from the Lansing City Pulse along for the ride, tipped off about the action and more interested in getting a story than in preventing the vandalism, the violence and anti-Christian hatred being spewed by the lefties. We'll see what he files and what his editors see fit to print.

Props were readily on display too, though some of the condoms may have been put to even more nefarious use.

An hour after police and security had collected and removed who they thought were the last of the liberals, a volunteer security person discovered two more, hiding, together, in a public restroom. While their compatriots engaged in openly violent protest in front of everyone these two snuck away to potentially stage their own protest of sorts, and only by the grace of God did one of the hundreds of kids at the church not happen upon that particular restroom in those moments. Precisely how long they'd been there and precisely what they'd been up to we don't know.

The church's response? After things settled down, the blasphemy ended, the lewd props removed and the families safe from fear of additional men and women running into and past them the pastor took the stage and led the congregation in one more prayer... not for retribution, or divine justice or a celestial comeuppance (that's what I'd have prayed for) but instead that the troubled individuals who'd just defiled the Lord's house, so full of anger and hate, would know Jesus' love in their lives and God's peace that exceeds human understanding.

Yesterday morning defined the difference between a church of believers and Michigan liberals. It also illustrated in shocking, painful detail precisely what we're up against.

Duties of Sworn Officers by J. C. Powers

"I, AB, do solemnly swear (or affirm) that I will office as the 44th President. While I am not sugsupport and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. Although law enforcement officers and military personnel occasionally stumble when it comes to their oath, especially when they're new comers to their awesome position of responsibility, most will always recover and assume their duties and responsibilities with honor and dedication.

Along with members of law enforcement and the military, all public servants, including those elected to office, are sworn-in. We may witness that ceremony on January 20th when Mr. Obama takes gesting that constitutional obligations will be dispensed with by the new President, it is a reality that many members of the United States Congress, the Supreme Court and too many legislative and judicial officials up and down the political ladder have been less than committed to upholding the strict guidelines provided by the Constitution.

Americans are hoping the new administration will solve the economic problems we face. That's not likely to happen, because the economic advisors to the new President have no more understanding of how to get us out of this mess than previous administrations and Congresses understood how the crisis was brought about in the first place.

Except for a rare few, Members of Congress are unaware of Austrian Free Market economics. For the last 80 years, the legislative, judiciary and executive branches of our government have been totally influenced by Keynesian economics. If they had had any understanding of the Austrian economic explanation of the business cycle, they would have never permitted the dangerous bubbles that always lead to painful corrections.

Today, a major economic crisis is unfolding. New government programs are started daily, and future plans are being made for even more. All are based on the belief that we're in this mess because free-market capitalism and sound money failed. The obsession is with more spending, bailouts of bad investments, more debt, and further dollar debasement. Many are saying we need an international answer to our problems with the establishment of a world central bank and a single fiat reserve currency. These suggestions are merely more of the same policies that created our mess and are doomed to fail.

At least 90% of the cause for the financial crisis can be laid at the doorstep of the Federal Reserve. It is the manipulation of credit, the money supply, and interest rates that caused the various bubbles to form. Congress added fuel to the fire by various programs and institutions like the Community Reinvestment Act, Fannie Mae and Freddie Mac, FDIC, and HUD mandates, which were all backed up by aggressive court rulings.

The Fed has now doled out close to \$2 trillion in subsidized loans to troubled banks and other financial institutions. The Federal Reserve and Treasury constantly brag about the need for "transparency" and "oversight," but it's all just talk – they want none of it. They want secrecy while the privileged are rescued at the expense of the middle class.

It is unimaginable that Congress could be so derelict in its duty. It does nothing but condone the arrogance of the Fed in its refusal to tell us where the \$2 trillion has gone. All Members of Congress and all Americans should be outraged that conditions could deteriorate to this degree. It's no wonder that a large and growing number of Americans are now demanding an end to the Fed.

The Federal Reserve created our problem, yet it manages to gain even more power in the socialization of the entire financial system. The whole bailout process this past year was characterized by no oversight, no limits, no concerns, no understanding, and no common sense.

Similar mistakes were made in the 1930s and ushered in the age of the New Deal, the Fair Deal, the Great Society and the supplysiders who convinced conservatives that deficits didn't really matter after all, since they were anxious to finance a very expensive deficit-financed American empire.

All the programs since the Depression were meant to prevent recessions and depressions. Yet all that was done was to plant the seeds of the greatest financial bubble in all history. Because of this lack of understanding, the stage is now set for massive nationalization of the financial system and quite likely the means of production.

Although it is obvious that the Keynesians were all wrong and interventionism and central economic planning don't work, whom are we listening to for advice on getting us out of this mess? Unfortunately, it's the Keynesians, the socialists, and big-government proponents.

Who's being ignored? The Austrian freemarket economists – the very ones who predicted not only the Great Depression, but the calamity we're dealing with today. If the crisis was predictable and is explainable, why did no one listen? It's because too many politicians believed that a free lunch was possible and a new economic paradigm had arrived. But we've heard that one before – like the philosopher's stone that could turn lead into gold. Prosperity without work is a dream of the ages.

Over and above this are those who understand that political power is controlled by

those who control the money supply. Liberals and conservatives, Republicans and Democrats came to believe, as they were taught in our universities, that deficits don't matter and that Federal Reserve accommodation by monetizing debt is legitimate and never harmful. The truth is otherwise. Central economic planning is always harmful. Inflating the money supply and purposely devaluing the dollar is always painful and dangerous.

The policies of big-government proponents are running out of steam. Their policies have failed and will continue to fail. Merely doing more of what caused the crisis can hardly provide a solution.

The good news is that Austrian economists are gaining more acceptance every day and have a greater chance of influencing our future than they've had for a long time.

The basic problem is that proponents of big government require a central bank in order to surreptitiously pay bills without direct taxation. Printing needed money delays the payment. Raising taxes would reveal the true cost of big government, and the people would revolt. But the piper will be paid, and that's what this crisis is all about.

There are limits. A country cannot forever depend on a central bank to keep the economy afloat and the currency functionable through constant acceleration of money supply growth. Eventually the laws of economics will overrule the politicians, the bureaucrats and the central bankers. The system will fail to respond unless the excess debt and mal-investment is liquidated. If it goes too far and the wild extravagance is not arrested, runaway inflation will result, and an entirely new currency will be required to restore growth and reasonable political stability.

The choice we face is ominous: We either accept world-wide authoritarian government holding together a flawed system, OR we restore the principles of the Constitution, limit government power, restore commodity money without a Federal Reserve system, reject world government, and promote the cause of peace by protecting liberty equally for all persons. Freedom is the answer.

On March 18, 2008, Congress met in secret ^{3"}Several congressmen were so insession. censed about what was discussed behind those doors that they were compelled to leak the contents of the meeting. Following is what is rumored to have been discussed: Imminent collapse of the U.S. economy by September 2008; imminent collapse of the U.S. Government finances by February 2009; possibility of civil war within the U.S. resulting from the collapse; detainment of "insurgent U.S. citizens" in anticipation of their moving against the government; the potential for violent action taken by citizens against members of Congress due to the collapses; the merger of the U.S. economy with those of Canada and Mexico as a solution to the collapse; the introduction of a new tri-national currency called the "AMERO" as another economic solution."

Nancy Pelosi, Chris Dodd, Chuck Schumer, Charles Rangel, and numerous other players from both sides of the aisle are key players in the economic collapse. To fulfill the conspiracy against the United States of America, politicians elicited support from their constituents; most were receptive to embracing and retaining their own political participants. Soup Lines for Michigan?

Campaign '08, the Bell Tolls for Thee By Bob Tyrrell

What a wonderful morn! Campaign '08 is a corpse. Step gently around it. Offer a gentle wave of the hand to those poor wretches over in the corner looking forlorn and lost. Those are the political junkies. They have awakened every day for almost two years eager for the electioneering fray. First, there were the primaries, where Hillary was "inevitable" and Rudy the likely Republican candidate. Then they heaved and sweated for Sen. Barack Obama or Sen. John McCain. Now the election is over, and they are in withdrawal.

Yet most of the rest of us have reason to be relieved and frankly a bit proud of our country. Yes, the campaign was a blare of competing rhetorical sophistications. It was rare for either candidate to utter an applause line that did not begin with a deceit or end with one. Sen. Obama's yawp about giving 95 percent of us a tax cut is a comely example; after all, some 40 percent of his targeted audience pays no income tax. And Sen. McCain's rant against Wall Street for the financial crisis is another. The crisis began with those subprime mortgages from Fannie and Freddie and was exacerbated by cheap money and recklessly low interest rates from the Department of the Treasury and from the Fed.

Most of the rest of us can be proud of how this election has concluded. The United States has elected an African-American to the presidency two generations after Jim Crow. There was no violence and very little playing of the race card. Sen. Obama ran a deft campaign, and his Chicago advisers created a formidable machine (pardon the term). He is from Chicago, and so am I. We know what a Chicago machine has been, and frankly I have not been reassured when I have heard him sing that he is running against "30 years of broken politics in Washington." Does he mean he is bringing in "fixed politics"? We from Chicago know what "fixed politics" has meant in Chicago, and there the fix has been in for more than 30 years.

Yet beyond my little play on words, I, a Reagan conservative through and through, join with so many of my fellow Americans in taking pride in this election. Old Europe has disdained this country for years as racially prejudiced, though for years some of our most beloved popular figures have been African-Americans. At this point, we have had black generals in our military, black members of our presidential cabinets, black Supreme Court justices, black political leaders throughout the states, and black CEOs all over the lot. No European nation has shown such tolerance of color, ethnic origins, or religious and political disagreement. Spare us your canards about racial prejudice in the Great Republic, and may I remind our European critics that 2009, the year in which Sen. Obama will be inaugurated to the presidency, is the 200th anniversary of the birth of Abraham Lincoln, the Great Emancipator.

Aside from the political junkies, there is another tiny coterie of gloomy souls this week: the Clintonistas. Doubtless the gloomiest among them is the downcast former Boy President. He is actually, according to my sources, quite angry. With the election of Sen. Obama, Bill Clinton's days of White House revelry are finito . He has wanted to get back in the White House for years. Relatively unreported, but nonetheless true, he wanted his wife to run in 2004. We saw how passionately he campaigned for her in 2008. Yet a return of the Clintons was never to be. As I said as early as the spring of 2007, in "The Clinton Crack-Up" (and in an interview with Brian Lamb on C-SPAN), the "inevitable" Hillary was "going to have real problems getting the nomination." She faced a serious challenge from a younger generation of Democrats, who found their candidate in the junior senator from Illinois.

As I also reported, her husband is a dreadful campaigner for anyone but himself. When she turned to him in the primaries, she apparently knew nothing of his limitations. In 2004, of the 14 candidates he campaigned for, 12 lost. In the closing days of this campaign, when the former president campaigned for Sen. Obama, we saw why he is so dreadful in campaigning for others. To Sen. Obama's visible chagrin, Bill talked about himself first and then his White House advisers. When he finally referred to the 2008 Democratic candidate sitting nearby, he only diminished him. Now Bill is a has-been, and the historians are going to note his failed presidency.

In the months ahead, we are going to be hearing that the Reagan conservatives are has-beens, too. Well, we shall see. Critics have been writing obituaries for the conservative movement since 1964. I recall their pessimistic reports in 1987 with great clarity. That was when the Reagan Revolution supposedly was finished off by Iran-Contra and a stock market decline. In the years ahead, the principles of Reagan conservatism came to be adopted even by Democrats. The reason is clear: Those principles protect personal liberty, encourage prosperity, and protect American national security.

In the months ahead, the conservative movement will regroup. It will refine its principles for the present needs of the nation: growth, personal liberty, and national security. It will find the next generation of conservative political leaders. If President Obama really makes good on his promise to return to the New Deal of the 1930s and the Great Society of the 1960s, a revitalized conservative movement will be back on top sooner than one might expect. Recall, if you will, that this happened two years after the Clintons brought "change" to Washington in 1992.

TARP's \$700 billion so far is being used to buy preferred shares in banks to shore up their capital. The program was originally intended to hold banks' troubled assets while markets were frozen.

AIG Lending

Ratings Cuts

Ultimately, the Fed will have to remove some securities held as collateral from some programs because the central bank's rules call for instruments rated below investment grade to be taken back by the borrower and marked down in value. Losses on those assets could then be written off, partly through the capital recently injected into those banks by the Treasury.

Moody's Investors Service alone has cut its ratings on 926 mortgage-backed securities worth \$42 billion to junk from investment grade since Sept. 14, making them ineligible for collateral on some Fed loans.

The Fed's collateral ``absolutely should be made public," said Mark Cuban, an activist investor, the owner of the Dallas Mayericks professional basketball team and the creator of the Web site Bailout-Sleuth.com, which focuses on the secrecy shrouding the Fed's moves.

Michigan's Future - Beyond Bleak By C. J. Williams

While Michigan citizens are still waiting for Gov. Granholm to make good on her promise to blow them away by pulling the state's economy out of the sewer, it appears that the only thing waving in the wind is her tongue.

Over the past eight years and as of Sept. 28, 2008, Michigan has lost 315,000 manufacturing jobs, a reduction of 35.5 percent since the year 2000. Since it seems that, daily, the state's newspapers carry more and more stories about failing businesses, job losses, or employee layoffs while at risk companies restructure, God only knows how many more nonmanufacturing jobs were lost during that time, as well as from both job sectors in October '08 and during the first two weeks of November.

Figures toted in a recent New York Times article, 'Economy Is Only Issue for Michigan Governor' written by Monica Davey and Susan Saulney, indicate that the net job loss since Granholm took office stands at 281,500, a figure that's likely escalated already. According to that article, however, and to her credit, a spokesperson from her office claims that since taking office, Granholm has brought 120,800 new jobs to Michigan.

However, let's consider a few things before an attagirl is extended to the current occupant of the governor's mansion. Granholm took office in 2003 when the state unemployment rate was 6.2% and the national average was 5.7%. By the end of 2003, Michigan's jobless rate had climbed to 7.2% while the national average remained steady. At the end of Granholm's first year in office, there had been a one-year job loss of 35,000, but the unemployment numbers only reflected an additional 4,000 people out of work because 31,000 folks left the state.

During 2004, 35,000 more people moved out and the state's jobless rate stood at 7.3% compared to the national average of 5.5%. Although people continued to flee the state, things improved a tad in 2005, as Michigan's jobless rate dipped to 6.1% and the national rate fell to 4.2 percent. However, by the end of 2006, Michigan had again lost over 150,000 people and was showing a jobless rate of 7.2% while the national average increased slightly to 5.0 percent. During 2007, Michigan lost another 120,000 jobs, and at the end of the year the state's jobless rate was 7.6% compared to a national average of 4.9%.

Things do not bode well for Michigan this year, either. Even though the state's jobless rate for September briefly fell to second place nationally with 8.7% behind Rhode Island's 8.8%, the glory was short lived. Headlines on Nov. 19th indicated that the state's jobless rate for Oct. '08 stood at 9.3% compared to the national rate of 6.5%, and some economists are projecting that the figure will climb into the double digits within months.

Today, as this column is being written and as Congress is debating the merits of bailing out the state's automakers, Ms. Granholm, accompanied by her Michigan Economic Development Corporation toadies, is on an 'investment mission' in the Middle East, purportedly romancing more foreign companies to set up shop in the Great Take State. Her seven-day jaunt, which began on Nov. 14th, was her seventh such overseas trip since 2004. Her SEVENTH trip in four years to bring industry to Michigan, and the state is still hemorrhaging jobs and people!

According to a recent press release from the Gov's office, little Miss Blow You Away planned to meet with alternative energy companies in Israel and Jordan to discuss such things as wireless energy and water reuse. She will also call on venture capital firms and business leaders in Dubai, as well as pharmaceutical companies that apparently already 'invest' in Michigan companies.

One such pharmaceutical company mentioned in one of her press releases was Perrigo, which is based in downstate Allegan. Perrigo bills itself as the nation's largest manufacturer of store brand over-the-counter pharmaceuticals, as well as nutritional products sold by supermarkets and drug and mass-merchandise chains such as WalMart, Walgreens and Target. In 2004, Perrigo acquired Agis Industries, the second largest pharmaceutical company in Israel. Why the Governor and her entourage called on Perrigo in Israel rather than Allegan. Michigan wasn't disclosed.

PowerMat is an Israeli wireless energy company that so interests the guv that she stopped by on her Middle East junket to promote Michigan. The company claims it can turn any surface into a power source, be it table, wall, floor, or even sheetrock. However, it seems that PowerMat, which was founded in 2007, has already entered into a deal with Michigan's Commerce Township-based HoMedics to form another entity, HoMedics PowerMat North America, to market and distribute products equipped with PowerMat's technology.

Regardless, it should be apparent that these overseas trips have done little to staunch job losses in Michigan or alleviate another financial problem the state has been facing, but only now is coming to light in big city newspapers.

Michigan workers who lose their jobs usually can count on 26 weeks of unemployment compensation, generally a paltry maximum of \$362 per week, providing they meet eligibility requirements. However, news making the headlines in some downstate papers last week is that Michigan's Unemployment Compensation Fund has been depleted for a couple of years and the state has already had to borrow from the federal government to pay unemployment benefits to an estimated 650,000 people this year.

As of Oct. 2nd, the outstanding balance on this year's loan was at least \$376 million, but more recent reports put that sum at around \$473 million, which will start accruing interest in January of 2009. Michigan, of course, has no way to repay that loan, though the powers that be have somehow managed to do so in the past. For instance, in 2007 Michigan borrowed \$637 million from the feds even though the state's budget was in total disarray and government lay-offs and complete shutdowns were threatened.

Perhaps this year, Peter's coffer is so thin that there's nothing left to rob in order to pay Paul, although some legislators are eyeballing treasure chests, such as the Natural Resource Trust Fund that could possibly be pilfered so as to meet the State's financial obligations, namely the outstanding federal loan needed for unemployed workers. Interestingly, as of 2001, the state's Unemployment Compensation Fund showed a positive balance of \$3 billion and a balance of a little over \$1.7 billion two years later. However, in 2003 and prior to her bid for reelection, Granholm signed legislation that temporarily extended unemployment benefits from 26 weeks to 39 weeks, further depleting the fund by an additional \$206 million. Perhaps that maneuver bought her enough votes for her to get reelected then, but certainly it must be a bitter pill to swallow now considering that Mother Hubbard's cupboard is filled with cobwebs rather than juicy bones for the unemployed.

Interestingly, there is a bill now pending in the Michigan Senate that would again extend unemployment bennies for 39 weeks, rather than the standard 26 weeks. It was introduced on Jan. 25, 2007 by Ray Basham (D-Taylor) and referred to the Committee on Commerce and Tourism on the same day. As the State already can't foot the bill for unemployment bennies without borrowing, how ever would the legislators rationalize passing a bill that would increase the onus?

Over the past week or so, approximately 40,000 Michigan employers have been given notice that they will be dunned an extra \$67.50 per employee as of Jan. 2009 to help repay the federal loan and interest it generates. As best as can be understood from the politically correct, fair and balanced reports written with a lot of flowery mumbojumbo words and published in the Lame Street Media press, this so called 'solvency tax' will affect businesses whose laid-off workers have collected more in unemployment benefits than their employers paid into the state's unemployment fund. What isn't being written, however, is that Michigan has managed to deplete the cushion provided by those many employers who pay into the fund, but whose workers draw nothing from it.

If the state has to borrow more money, the 'solvency tax' will be increased, and the more employees that are laid off, the worse the business owners' tax onus will be. This is definitely not one of Granholm's 'win-win' situations to be in, especially when the state's already tanked economy is tanking even more.

Additionally, in 2010 most Michigan employers will be forced to ante up a surcharge of \$21 per employee to pay off Michigan's debt to the federal unemployment system. This will be in addition to each business owner's unemployment taxes that are applied to the first \$9,000 of each of their employee's wages. The unemployment tax rate ranges between 0.06% and 10.3% per employee. Ironically, while long term Michigan businesses have been taxed to death for years, Ms. Blow You Away continues to romance foreigners and start-up companies in other states to invest in Michigan by promising those businessmen all sorts of tax breaks.

Care to venture a bet on how many more businesses will fail in the Great Take State during 2009 and how many more people will join the unemployment line, making the situation even bleaker?
