## Feeling under the weather? Nick Miller April 7, 2008

AUSTRALIANS are getting so anxious about climate change that they are seeing their doctors for help.

In a speech tonight to mark World Health Day, Dr Grant Blashki says climate change is already having direct and indirect effects on Australia's health, and the problems are set to get worse.

His call for the medical profession to treat climate change as a health issue and address it as such is being echoed today around the country and the world, as the World Health Organisation chose "protecting health from climate change" as its theme.

Dr Blashki, a senior research fellow in the University of Melbourne's Primary Care Research Unit, says general practitioners and other health care professionals will need to develop strategies to help patients deal with concerns.

He said patients who came to him with depression or anxiety were increasingly citing climate change news as something they were having trouble coping with. "These people tend to have a low threshold to taking on worries. When they pick up the paper and see a small part of Antarctica disintegrating, they take it on board," he said. "They pick up on the negative things going on in the world.

It comes down to maintaining hope, to get people motivated, not despairing. Action is a great stress reliever."

A report commissioned by the Climate Institute says that by 2020 Australians will be suffering increased rates of heat stress, allergic diseases and depression because of climate change. The report, endorsed by the Royal Australian College of General Practitioners, also predicts food poisoning, respiratory disorders and mosquito-transmitted diseases will be on the rise.

The WHO has estimated that 60,000 people die each year from climate change-related natural disasters.



# "A Flagrant and Continuing Injustice"

On April 3rd, we attended an evening meeting of over 30 rural landowners, in which a couple of auditors of a land use department in a Western State (King County, WA) were there to collect stories of government abuse, for the purposes of adding to their audit. They got an un-expected ear full. As the two auditors were leaving the meeting, one of them was overheard to say, **"I had no idea it was this bad."** One might ask how they could be so blind when the rural landowners of this county have been yelling from the roof tops for years, about the egregious injustices that are being foisted on them by an over-bloated, city-run, county council.

In the spirit of surprising civilized behavior, one by one, the landowner's stories came pouring out, sometimes punctuated with a few expletives that weren't deleted, sometimes with passion bordering on wanting to do physical harm to the perpetrators of their extended grief. Words like Gestapo, brown shirts, Nazism, communism and socialism were frequently on the lips of the landowners, as they related their individual experiences with land use code enforcement officers.

But what was entirely overlooked by those attending the meeting and by the auditors themselves, was that this was just a symptom of a much greater evil. An evil that is being perpetrated on America's minority, the private property owner, with little or no representation in the government process. An evil that is foisted on this minority by the tyranny of a majority (*city folk*) who have bought into the "green" lie that the environment must be protected, no matter how much it costs, or how many individual and property rights that the minority has to give up to implement what can be generously called, a draconian government policy. An evil that has all the characteristics associated with mass hysteria. An evil that totally ignores the rights protected by the 5th Amendment to our cherished Constitution, the absolute requirement by government to provide "due process" and "just compensation" when "TAKING" private property. This evil has clearly violated our constitution; the **"equal protection clause"**. The rural minority is being asked to bear almost the entire burden of environmental

protection, for the benefit of the constitutionally ignorant and naive urban dwellers, who have been duped into thinking they have the right to usurp the rights of their rural brethren.


# The Elites Plan For Internet Shutdown

As the Internet continues to give rise to the alternative media, the technocrats are getting ready to bring its replacement online. Internet2 also known as “the grid” will have speeds 10,000 times faster than a regular broadband connection. Researchers are set to activate this new network over the summer so they can use it to collect information from a supercollider that they hope will recreate the big bang and the conditions that lead to the creation of the universe. Some believe that this experiment might cause the inadvertent destruction of the planet, but that’s another story. Some researchers believe that the new Internet will be so fast that people will eventually trust all of their information to the network itself. The following is taken from a MemphisRap.Com article on Internet2.

*According to Ian Bird, project leader for CERN's high-speed computing project, grid technology could make the Internet so fast that people would stop using desktop computers to store information and entrust it all to the Internet. Users would use the new "Cloud computing" as a common way to organize personal and private information that would be stored on the Grid and accessible from any where.*

If the establishment is successful in convincing the people of the world to put all of their personal and private information on this network, this will be the equivalent of Big Brother on steroids. The establishment is not going to make the same mistake with Internet2 as they did with the original Internet. *Internet2 is a not-for-profit advanced networking consortium comprising of more than 200 U.S. universities in cooperation with 70 leading corporations, 45 government agencies, laboratories and other institutions of higher learning as well as over 50 international partner organizations. Our organization is governed by an executive Board of Trustees and strategic councils consisting of leaders who represent our broad membership.*

A new network infrastructure will be built for Internet2 and there are already stories propagandizing how the increase of video sharing on the Internet means that it will be overloaded in a few years. This is absolute bull, as all they'd have to do is upgrade the existing network infrastructure currently used on the Internet. Instead, they want to get everybody to move over to Internet2 that will have different rules set by the corporations, universities and government agencies behind the Internet2 project. Another words, it will be a faster Internet that is heavily policed and regulated by the establishment.

Overall, Internet2 or “the grid” is definitely something to watch out for. By moving to a new network the establishment can claim that they are not censoring the Internet by getting people to move to the Internet2 system voluntarily. # Stupak Co-sponsored 1993 Pro-Agenda 21 Legislation

*Supports: (1) pursuing the research and policy initiatives urged in Agenda 21; (2) the Congress adopting a system to reallocate an appropriate amount of savings from reduced defense spending to achieve its goals of global environmental protection and sustainable development over the next decade; (3) the United Nations Commission on Sustainable Development; and (4) rules of procedure for the Commission which ensure the participation of nongovernmental organizations*

*Calls on the President to: (1) actively participate in multilateral efforts aimed at creating a more favorable international economic climate for developing countries to practice sustainable development; (2) affirm strong U.S. commitment to the Commission by appointing a high-level representative to the Commission and by supporting the Under Secretary General for Policy Coordination and Sustainable Development in coordinating the implementation of Agenda 21 in the United Nations system and heading the secretariat support structure for the Commission; (3) submit a national report to the Commission on activities the United States has undertaken to implement Agenda 21 both domestically and internationally, on progress made toward fulfilling other commitments undertaken at UNCED, and on other environmental and developmental activities."*

At a recent downstate townhall meeting, Bart Stupak was asked by a constituent if he still supported HJ RES 166 and, if so, why; if he no longer supported it, what was he doing to stop the implementation of Agenda 21 in America? He is reported to have replied that the measure was just a House Resolution and therefore meaningless.

Over the years, Stupak, who represents citizens of 31 counties that comprise Michigan's 1<sup>st</sup> Congressional District, has proposed many House Resolutions. Do you suppose he considers his own legislation as being meaningless, too? The townhall meeting was taped and we at the Yooper Scoop are eagerly awaiting a copy.

On August 5, 1992, Rep. Nancy Pelosi introduced H.CON.RES.353 in the U. S. House of Representatives. Sixty-three of her peers co-sponsored it.

The introductory language of H.CON.RES.353 reads: "**Title:** Expressing the sense of the Congress that the United States should assume a strong leadership role in implementing the decisions made at the Earth Summit by developing a national strategy to implement Agenda 21 and other Earth summit agreements through domestic policy and foreign policy, by cooperating with all countries to identify and initiate further agreements to protect the global environment, and by supporting and participating in a high-level United Nations Sustainable Development Commission."

On the day Rep. Pelosi's bill was introduced, it was referred to the House Committee on Foreign Affairs and from there it moved to the Senate, which received it on 9-5-92 and three days later referred it to the Committee on Foreign Relations where it apparently languished.

Not to be denied her shining historical moment to be the one primarily responsible for making the UN Agenda 21 Programme for Sustainable Development legally binding on American citizens, Pelosi again introduced a copy-cat joint resolution, HJ RES 166, on March 29, 1993. It, too, made it as far as the Senate Committee on Foreign Relations on April 16, 1993.

Even though these two Bills never got out of that committee, the UN Agenda 21 - Sustainable Development Programme has been and continues to be implemented in America through treaties signed by President Clinton and through executive orders he issued.

Of the sixty-seven co-sponsors of HJ RES 166, the following twenty-nine are still in office and some are now seeking re-election: **Gary**

Owens** (D-NY), **Collin Peterson** (D-MN), **John Porter** (R-IL), **Lucille Roybal-Allard** (D-CA), **Bobby Rush** (D-IL), **Bernard Sanders** (I-VT, currently a senator), **Charles Schumer** (D-NY), **Bart Stupak** (D-MI), **Edolphus Towns** (D-NY), **Lynn Woolsey** (D-CA), and **Albert Wynn** (D-MD).

Additionally, former Democrat **Cynthia McKinney** (GA) is now seeking nomination for the Presidency on the Green Party ticket, and **Constance Morella**, a former Republican representative from Maryland, became Permanent Representative to the Organisation for Economic Co-operation & Development (OECD).

The OECD was formed in France in 1961. On its Website, it describes itself as an "organisation" that "provides a setting where governments compare policy experiences, seek answers to common problems, identify good practice and coordinate domestic and international policies.

The OECD's Washington Center Website "About" link at the bottom of the Home Page will take inquisitive minds to another page where manipulative OECD "Decisions, Recommendations and Other Instruments of Force" can be viewed.

The summary of Pelosi's HJ RES 166 legislation reads as follows:

*"Declares that effective follow-up to achieve the goals of the agreements reached at the United Nations Conference on Environment and Development (UNCED) will depend on the following actions by the President and Congress: (1) adoption of a national strategy for environmentally sustainable development; (2) facilitation of a means for adopting individual Agenda 21 plans of action; (3) the establishment of an effective mechanism to plan, initiate, and coordinate U.S. policy for implementing Agenda 21; and (4) the formulation of policies to help developing countries implement Agenda 21.*



## LOCAL PATRIOTS TO SOUND ALARM ON “TAX DAY”

A dedicated group of freedom movement patriots from the Dickinson County area are planning on staging what they have named “Operation Stop Thief!” sponsored by <http://truthattack.org/>, a nation-wide coalition of tax honesty and freedom movement organizations and supporters. Participants plan to spend the entire day of April 15th in front of the Iron Mountain Post Office. They will be distributing flyers and urging people to read the law, which they claim differs significantly from what the Internal Revenue Service claims.

For over two decades the tax honesty movement has demanded that the IRS “show them the law” that makes working Americans liable for the income tax. Thus far, the IRS has never been able to cite any statute that does so, although all tax laws must contain specific provisions identifying exactly who must pay the tax. Now the movement, under the guidance of Truth Attack, has stopped asking and started telling. They claim the IRS can cite no law because there is no such law, something they have known all along.

The members of the group plan to assemble on the sidewalk in front of the Iron Mountain Post Office. They promise an upbeat, friendly assembly where they will offer tax return filers information directing them to websites that have details, research tools and material people can read to determine the issue for themselves.

# "Martin Luther King, Jr. Was A Republican!"

Don't you find it just a little disingenuous for Democrats to pick Martin Luther King, JR. (MLK) as their hero and roll model, when MLK was a Republican? *"During the civil rights era of the 1960's, Dr. King was fighting the Democrats who stood in the school house doors, turned skin-burning fire hoses on blacks and let loose vicious dogs. It was Republican President Dwight Eisenhower who pushed to pass the Civil Rights Act of 1957 and sent troops to Arkansas to desegregate schools. President Eisenhower also appointed Chief Justice Earl Warren to the U.S. Supreme Court which resulted in the 1954 Brown vs. Board of Education decision ending school*

*segregation. Much is made of Democrat President Harry Truman's issuing an Executive Order in 1948 to desegregate the military. Not mentioned is the fact that it was President Eisenhower who actually took action to effectively end segregation in the military."*

*"Democrat President John F. Kennedy is lauded as a proponent of civil rights. However, Kennedy voted against the 1957 Civil rights Act while he was a senator, as did Democrat Senator Al Gore, Sr. And after he became president, John F. Kennedy was opposed to the 1963 March on Washington by Dr. King that was organized by A. Phillip Randolph who was a black Republican. President Kennedy, through his brother Attorney General Robert Kennedy, had Dr. King wiretapped and investigated by the FBI on suspicion of being a Communist in order to undermine Dr. King."*

*"In March of 1968, while referring to Dr. King's leaving Memphis, Tennessee after riots broke out where a teenager was killed, Democrat Senator Robert Byrd, a former member of the Ku Klux Klan, called Dr. King a 'trouble-maker' who starts trouble, but runs like a coward after trouble is ignited. A few weeks later, Dr. King returned to Memphis and was assassinated on April 4, 1968."*

*"Given the circumstances of that era, it is understandable why Dr. King was a Republican. It was the Republicans who fought to free blacks from slavery and amended the Constitution to grant blacks freedom (13th Amendment), citizenship (14th Amendment) and the right to vote (15th Amendment). Republicans passed the civil rights laws of the 1860's, including the Civil Rights Act of 1866 and the Reconstruction Act of 1867 that was designed to establish a new government system in the Democrat-controlled South, one that was fair to blacks. Republicans also started the NAACP and affirmative action with Republican President Richard Nixon's 1969 Philadelphia Plan (crafted by black Republican Art Fletcher) that set the nation's first goals and timetables. Although affirmative action now has been turned by the Democrats into an unfair quota system, affirmative action was begun by Nixon to counter the harm caused to blacks when Democrat President Woodrow Wilson in 1912 kicked all of the blacks out of federal government jobs."*

Colonel Rice closes her article with this admission:

*"In order to break the Democrats' stranglehold on the black vote and free black Americans from the Democrat Party's economic plantation, we must shed the light of truth on the Democrats. We must demonstrate that the Democrat Party policies of socialism and dependency on government handouts offer the pathway to poverty, while Republican Party principles of hard work, personal responsibility, getting a good education and ownership of homes and small businesses offer the pathway to prosperity."*

History is a fragile thing. It seems to ebb and flow, depending on the bias of the writer, or the reader. The true facts of history are indeed a precious commodity. 



“Federal Income Tax is about 50% for Exxon-Mobil. Exxon-Mobil cleared about \$8 billion after paying \$6.8 billion to the federal government. A person with a simple calculator can figure out the particulars of how many gallons had to be sold, but don't forget the profit includes oil, jet fuel, diesel and other by-products.

The government makes \$00.56.274 per gallon; Exxon-Mobil remains at \$00.09. The estimate is that for every ten cents the gas price increases, the State of Michigan gets \$30 million more through the sales tax. The State makes approximately \$900 million in sales tax alone when the gas hits \$3.00.

As investors drive up the cost of a barrel of oil to \$109.90 (at the time of this writing), the consumers stand awe-struck at the pump as they fill their tanks. Some of us are old enough to remember gasoline costing 18 cents per gallon during the gas-wars in Wisconsin; circa 1970. Once gasoline became a buyable commodity, the prices became more fickle. The 1985 deregulation was disastrous; one of the Reagan-era mistakes. The first was the bail out from Lebanon.

The answer is not to have Congress hold more hearings; the answer is to replace every one of those Daffy Ducks.
