Liberty

Liberty, in modern time, is generally considered a concept of political philosophy and identifies the condition in which an individual has the ability to act according to his or her own will.

Individualist and liberal conceptions of liberty relate to the freedom of the individual from outside compulsion or coercion; a socialist perspective, on the other hand, associates liberty with equality in wealth. As such, a socialist redefines liberty as being entitlements and connects liberty (i.e. freedom) to the equal distribution of wealth, arguing that liberty without equal ownership amounts to the domination by the wealthy. Thus, freedom and material equality are seen as intrinsically connected. On the other hand, the individualist argues that wealth cannot be evenly distributed without force being used against individuals which reduces individual liberty.

John Stuart Mill, in his work, On Liberty, was the first to recognize the difference between liberty as the freedom to act and liberty as the absence of coercion. In his book, *Two Concepts of Liberty*, Isaiah Berlin formally framed the differences between these two perspectives as the distinction between two opposite concepts of liberty: positive liberty and negative liberty. The latter designates a negative condition in which an individual is protected from tyranny and the arbitrary exercise of authority, while the former refers to having the means or opportunity, rather than the lack of restraint, to do things.

Mill offered insight into the notions of *soft tyranny* and *mutual liberty* with his *harm principle*. Uverall, it is important to understand these concepts when discussing liberty since they all represent little pieces of the greater puzzle known as freedom. In a philosophical sense, morality must supersede tyranny in any legitimate form of government. Otherwise, people are left with a societal system rooted in backwardness, disorder, and regression.

The first known use of the word freedom in a political context dates back to the 24th century BC, in a text describing the restoration of social and economic liberty in Lagash, a Sumerian city-state. Urukagina, the king of Lagash, established the first known legal code to protect citizens from the rich and powerful. Known as a great reformer, Urukagina established laws that forbade compelling the sale of property and required the charges against the accused to be stated before any man accused of a crime could be punished. This is the first known example of any form of due process in the history of humanity.

Like Urukagina, most ancient freedoms focused on *negative liberty*, protecting the less fortunate from harassment or imposition. Other ancient legal codes, such as the Code of Hammurabi, similarly forbade compulsion in economic matters, like the sale of land, and made it clear that when a rich man murders a poor one, it is still murder. Still, these codes relied on a certain virtuousness of kings and ministers, which was far from reliable.

Chrysler sales are down 25%, Ford is down 16%, GM is closing four truck and SUV plants in the U. S. and may drop the Hummer from its lineup. Semi truck sales are down and many independent truckers are

selling their rigs to go to work for the larger trucking companies because the independent truckers can't afford an \$1,200 pit stop.

The automakers can't blame anyone but themselves for their lack of preparation and vision. Freedom is never free! - 4th of July Tribute—What Happened to Them?

Have you ever wondered what happened to the 56 men who signed the Declaration of Independence?

Five signers were captured by the British as traitors and tortured before they died.

Twelve had their homes ransacked and burned.

Two lost their sons serving in the Revolutionary Army, another had two sons captured.

Nine of the 56 fought and died from wounds or hardships of the Revolutionary War.

They signed and they pledged their lives, their fortunes, and their sacred honor.

What kind of men were they?

Twenty-four were lawyers and jurists. Eleven were merchants, nine were farmers and large plantation owners; men of means, well educated. But they signed the Declaration of Independence knowing full well that the penalty would be death if they were captured.

Carter Braxton of Virginia, a wealthy planter and trader, saw his ships swept from the seas by the British Navy. He sold his home and properties to pay his debts, and died in rags.

Thomas McKeam was so hounded by the

British that he was forced to move his family almost constantly. He served in the Congress without pay, and his family was kept in hiding. His possessions were taken from him, and poverty was his reward.

Vandals or soldiers looted the properties of Dillery, Hall, Clymer, Walton, Gwinnett, Heyward, Ruttledge, and Middleton.

At the battle of Yorktown, Thomas Nelson, Jr., noted that the British General Cornwallis had taken over the Nelson home for his head-quarters. He quietly urged General George Washington to open fire. The home was destroyed, and Nelson died bankrupt.

Francis Lewis had his home and properties destroyed. The enemy jailed his wife, and she died within a few months.

John Hart was driven from his wife's bedside as she was dying. Their 13 children fled for their lives. His fields and his gristmill were laid to waste. For more than a year, he lived in forests and caves, returning home to find his wife dead and his children vanished. A few weeks later, he died from exhaustion and a broken heart.

Norris and Livingston suffered similar fates.

Such were the stories and sacrifices of the American Revolution. These were not wildeyed, rabble-rousing ruffians. They were softspoken men of means and education. They had security, but they valued liberty more.

Standing talk straight, and unwavering, they pledged: "For the support of this declaration, with firm reliance on the protection of the divine providence, we mutually pledge to each other, our lives, our fortunes, and our sacred honor."

They gave you and me a free and independent America. The history books never told you a lot about what happened in the Revolutionary War. We didn't fight just the British. We were British subjects at that time and we fought our own government!

Some of us take these liberties so much for granted, but we shouldn't.

So, take a few minutes while enjoying your 4th of July Holiday and silently thank these patriots. It's not much to ask for the price they paid. Remember: Freedom is never free!

The Scott Loper Story http://www.scottloperstory.com/

Scott Loper, a U.S. citizen living in Canada, was a good cop, highly trained in surveillance and criminal investigation.

On the verge of exposing a police-run narcotics ring in Durham, Ontario, Loper was discovered by the ring and imprisoned for four years on extorted charges. There, he was tortured to the point where he often questioned his ability to make it out alive.

Those he had been about to expose were after the evidence - audio and video recordings Loper had made of their illegal operations. They also wanted him to keep quiet.

The Canadian government originally said the whole thing, including Loper's arrest, never happened, denying that Loper had ever lived in Canada, let alone been incarcerated there.

Had Loper been unable to produce evidence of his imprisonment, the denial would have succeeded. Loper had that evidence, which he had stuffed into his jeans as he was being released. Caught in their lie, the Canadians want the whole ordeal swept under the rug. The U.S. government, rather than protecting its citizen, is complying with the cover-up.

Now free, and living in the United States, Scott Loper's main goals are involved with putting his life back in order and more importantly, to find his son Eddy, now 11 years old. Scott has not seen or heard from his wife and son since his arrest.

Article 36 of the Vienna Convention, signed by 164 nations in 1967, states that those nations are bound to notify foreign nationals, when arrested, of their right to contact their embassy or consulate, allowing that embassy or consulate to assure that citizen is treated properly.

The Canadian government says Scott Loper waived those rights. However, they could produce no document as proof of this statement. The reason, says Loper, is that no such signed document ever existed.

In an attempt to prove their lie, the Canadians finally came up with an unsigned document that holds absolutely no credibility. To add to the absurdity, the document is dated three years after Loper was arrested. Hardly the requirement of notice "without delay" as described by Article 36.

The ongoing series of articles on the right are

written by World Net Daily staff writer Bob Unruh. They contain an amazing story of U.S. officials and Congressional representatives going to bat for Scott Loper, only to turn tail when the going got rough.

The Canadian government does not want this story to be told. The U.S. government seems happy to oblige.

There is a larger issue here that affects the safety and well-being of every U.S. citizen who ventures into another country. If the U.S. Government is unwilling to expect its neighbor to the north to comply with the Vienna Convention, what protection can we expect from our government when our rights are violated by other, less friendly countries.

Treasury Secretary, Henry Paulson said Thursday that the government must move quickly to give the Federal Reserve more power to regulate the financial system, contending that this years financial market turmoil had highlighted the need for action

Paulson said that the central bank's powers should be expanded in the wake of the near collapse earlier this year of "Bear-Sterns," the giant Wall Street investment firm.

He said there was a need to consider quickly on how to give the fed the power it needs to obtain information from investment banks and the responsibility to intervene to protect the overall financial system. (End Quote)

The above statement leaves me almost speechless. The Federal Reserve is a privately owned world wide banking system that is accountable to no one. The President and the Congress has to brush their teeth, comb their hair and put on their best image to even ask " The Reserve" to give the order to start the money printing presses to print worthless currency not backed by anything but "confidence" in America's ability to pay it back. (Which they will never pay back)

Of course The Reserve will never refuse the request of the U.S. Government because as soon as the new currency is distributed to the reserve banks across the country, the government is subject to paying interest on the requested amount to the Reserve, whom the government gave the authority to regulate the nation's money supply in the first place. (Back in 1913)

It does not cost the Reserve anything to print the money except about one cent per bill, whether it is a hundred dollar bill, or a twenty, or a ten or a single dollar bill. That is the printing cost for the order, not the ink and the paper and the labor. That is paid for by the government which owns the mint, which is you and I, (I think.) Now if that confuses you, don't feel bad because you are not alone.

Let me try to simplify this: -- You are giving me the authority to regulate your money. If you want more liquidity, you ask, or order me (depends on who thinks they are in charge) to provide the cash for your needs. Then I will dig into your source to give you your money and charge you interest on that amount for doing so. It does not matter if you do not have enough money in your reserve for your needs, because if you don't, I will manufacture more for you with your printing press. (Sounds like a Doritos commercial.) This is what happened when we removed our currency from "The gold standard". All our money used to be backed up by the gold in Fort Knox, Kentucky and would never diminish in value caused by inflation.

The Federal Reserve wants more power, not because they don't know how much money we have, (After all they printed it) but because they want to know how you are going to spend it. If they don't like your investments, they will choke you off via higher interest rates. It makes me wonder what happens to all that interest money we pay to the Fed's for the use of our own money. Can you imagine how much is paid to them from the trillions (Yes trillions) that are printed against our gold reserves??? No one knows because they are accountable to no one. We have approximately a thirteen trillion dollar annual economy.

Also, I would like to know if foreign countries have committed their gold reserves to the world's money supply.

I think not.

My friends, this is only a scratch on the subject of the American dollar. But it is a huge gash on the future of American security. The answer is that we must return to the gold standard and eliminate the Federal Reserve if we are to control our own future.

During the week after Father's Day, I received a number of interesting emails from readers asking me to write about the dearth of looting after the recent floods in Iowa. Specifically, they wanted me to write about the reason there was so much more looting in New Orleans after Katrina hit the "Chocolate City" in 2005. Of course, the problem involves so much more than race – a factor most people are thinking about, even if they won't admit it.

Some of the looters who would participate in the destruction of their own neighborhoods would later suggest that they were entitled to loot because of years and years of "oppression."

Of course, talk of historical oppression goes a long way towards explaining why blacks would be more inclined to loot than whites. But it doesn't go far towards explaining the fact that looters are predominantly male rather than female. At some point, variables other than race have to be written into the equation.

There is another observation that is just as obvious as the fact that black males are more likely than black females to take advantage of the opportunity to loot as a means of eradicating historical oppression. I am referring, of course, to the fact that black females are more likely than black males to take advantage of affirmative action as a means of eradi-

cating historical oppression. In fact, overall differences between blacks and whites in important areas including income and education – are largely due to the failures of black males relative to everyone else in society, including black females.

Sociologists have, at least to date, failed to grasp what lies behind this problem. This is largely because of their foolish contention that there are no inherent differences between men and women. They continue to believe, or pretend to believe, that gender differences are merely "socially constructed." I believe otherwise

A man has as an inherent component of his being a need to be useful in some form of occupation. He also needs to provide for his children if he has anv. The man who is able-bodied and does not work does not need to be taught to feel worthless. He feels that way without instruction. That is why a man is less likely to be driven to unemployment by drink than to drink by unemployment. That feeling of worthlessness similarly accompanies the man who does not care for his children. And it need not be taught to him by others. He imagines what people should be saying to him long before the first aspersions are cast.

For some forty years now the government has been providing incentives for (predominantly minority) men not to work and for women not to keep them around to care for their children. This idea that they are not needed as workers or as fathers cuts against their nature as men. It is a very dangerous pair of ideas with a very dangerous pair of consequences – only one of which has been addressed in this short essay.

The violence that is committed in an act of looting is not born of some idea that a man is entitled to the things kept from him by historical oppression. The violence against another man's place of work is born of his own sense of worthlessness for having not fulfilled his responsibilities as an able-bodied man. This non-sense about oppression is merely an after-thought – a form of rationalization in the Freudian sense. If used often enough it becomes more than an individual malady.

It becomes a cultural malady as well.

But the personal violence exhibited by minority men against other minority men is not so easily explained by economic oppression. Enlightened minds can easily grasp the effect of illegitimacy - and I speak here of illegitimate fathers because there are no illegitimate children - on minorities raised in single parent homes. But I believe the separation of fathers from their children explains, not just the transmission, but the genesis of violence in minority commui t i e \mathbf{n} S

Sociologists write volumes on the scores of black men executed annually in the criminal justice system. But they are silent regarding the thousands of minorities killed at the hands of other minorities annually. Such a thing would not be possible unless black males had come to hold other black males in such low regard. And that is something that, in turn, would not be possible unless they also held themselves in very low regard.

So I am not at all impressed that, on Father's Day, Barack Obama chose to chastise black men for failing to take care of their children. It takes little courage to state the obvious fact that their absence will make things tougher on the current generation of children raised in single parent homes.

I would be far more impressed were there any indication that Barack Obama understood the impact the War on Poverty has had on the current generation of fathers who have been displaced by government programs. Of course, if he did understand that he might be tempted to admit that he, too, is contributing to a very complex problem. And there is every indication that, if elected president, he will continue to contribute to the problem and force the rest of us to contribute our "fair share" too.

Jeremiah Wright recently found himself embroiled in controversy for suggesting that the government invented the AIDS virus to kill black people. It would have been closer to the truth to say that was the reason they have injected the virus of government aid into minority communities.

THE ECHO CHAMBER

The Michigan State House and the Senate are looking at approving a state-wide smoking ban. It is strongly and urgently suggested that those in Lansing get their own collective Houses and the Governor's office in order before dictating to business, industry and private citizens on how to run their own affairs.

When I ran for the State House in 2002 the anticipated deficit was \$400,000; that was eight years after the voters in Michigan approved a 50% increase in the sales tax to help fund schools. Today the General Fund and School Aid Fund deficit is \$920,000,000; this despite the cutting of \$1 billion in spending, the largest income tax increase in generations, issuing \$490,500,589 in bonds against the annual tobacco suit settlement money in May of 2006, and the Governor's hiring of a Chief Operating Officer. The Michigan Treasury also reports tobacco revenue in 2006 at \$1,169.0

million; that would be accurately depicted as \$1,169,000,000.00.

The Republicans in Lansing eliminated the Single Business Tax, but by compromising with the money-starved Democrats, legislators found a way to replace the lost revenue. The SBT was replaced by the Michigan Business Tax, which in some cases escalated business taxes by 424%. The huge increase in tax liabilities may account for some of the 28% earning losses among Michigan's small businesses and the residual unemployment rates.

Michigan has lost 300,000 jobs since 2000; including 170,000 manufacturing jobs. The benefit of losing both jobs and employees is that the unemployed had to leave the State to look for work. That has helped reduce the 7.6% unemployment rate to only 6.9% in April 2008. The annual unemployment average in 2007 for the 15 counties in the UP is a mini-

mum of 7.6%, ranging from 5% in Dickinson and Menominee counties to over 10% in Baraga, Keweenaw and Schoolcraft counties – http://www.milmi.org/

Michigan currently assesses a 19 cent tax on each gallon of gas. This is after the State collected the 6% sales tax from the distributorship. The legislators in Lansing are contemplating a 10.8 cent increase in gasoline and upping the current 15 cent diesel tax by 4 cents; each penny increase on diesel generates \$10,000,000 in revenue for the State. With the current burden on goods and services because of the outrageous transportation costs, Lansing has once again displayed their overpowering brilliance to identify a problem and tax it.
