I had the pleasure of attending the Michigan American Legion's Winter Conference in Lansing in mid-February. I took the opportunity to share my observations regarding American Flag lapel pins and received an affirmation regarding the proper display of the pin. The US Flag pins should be worn on the right lapel or collar, not on the left side like we've seen on politicians.



Military, veterans, law enforcement officers, fire fighters and others who wear or have worn the uniform may find the following protocol of value. When speaking, such as reciting the Pledge of Allegiance, you should rise, remove your cover, and hold it over your heart with your right hand.

While The Star Spangled Banner, our National Anthem, is played or being sung, military veterans may rise and render a salute, even if not wearing a cover of colors, such as a Legion or VFW cover.

During the National Anthem all other citizens should stand and first face the Flag of the United States or if not seen face in the direction of the music. The right hand should be put over the heart to show a sincere respect for the nation, citizens, and all those who served us with honor. Can you identify two discrepancies in the photo to the right? Aside from the wannabe President giving his usual crotch-salute, if there was no Color Guard entering the field, the participants on the stage should have turned around and faced the American Flag.



Next, there is the disrespect and outright blatant disregard of the American Flag by the politicians. The overt display of the Flag is pretty obvious to veterans and other Americans; politicians are trying to provide a public imagery that somehow they are more patriotic when they decorate their backdrop with American Flags. The most appropriate understanding on displaying the Flag of the United States of America is simple: "one flag; one nation".

With the upcoming Memorial Day, 4th of July, and other honorary events, it may be good to review the protocols regarding the Color Guard teams. Although we are compelled to recognize the Color Guard, an applause is not the most appropriate demonstration of the due respect.

A solemn silence should be observed.



The Color Guard is the main focus when they carry the flag into a ceremony or at the start of a parade. All persons should rise, face the center where the flag will pass. When the Color Guard is seen in the peripherals of your vision, eligible persons should render a hand salute and others should cover their heart with the right hand. 



Major Foreign Holders of U.S. Treasury Securities (Sep 2009)





Arrogance of Government Boycott in Michigan Looming

Upper Peninsula, Michigan: Both the U.P. Patriots and the NationalDefender.us are calling upon smokers, supportive business owners and all freedom-loving citizens in the State to take-on the Michigan legislature and commie Governor Granholm in defying their quest to dictate social policies.

Effective May 1, 2010, the State of Michigan will prohibit smoking in all public places, except of course the casinos in downtown Detroit.

The obvious political sabotage of the rights of private businesses and citizens has reached its crescendo. We are now going to ask all those concerned to join us in a unified demonstration of our outrage and discontentment with Michigan's continuous poor policies of disrespect.

Through a prolonged and possible permanent boycott of government revenue-raising schemes, we are now asking all supporters to boycott the Michigan Lotto and Lottery, Detroit area casinos, and all the unnecessary subsidization of Michigan's spending and dictator inclinations.

Aside from replacing most persons holding state and national offices in 2010, the UP Patriots and ND have joined forces to publically combat what can only be considered as an overbearing dictatorial government which utilize laws, regulations, rules, and visceral voodoo science to stomp on the rights of citizens and impose unnecessary restriction on our already struggling businesses and industries.

The December 2009 signature by Governor Granholm to implement a law to ban smoking in all public places with the exception of the Detroit casinos on May 1, 2010 is the final brick in the wall.

Michigan imposes a \$2.00 state tax and the federal government has a \$1.006 tax on a pack of cigarettes – Michigan totals the cost of the pack of cigarettes, adds the sin taxes and then assesses a 6% sales tax. Michigan Attorney General Mike Cox is aware of the tax on a tax yet has done nothing on behalf of citizens of the State.

Mr. Cox would not make a suitable Governor based on his lack of concern for the smoking citizens who mostly live below the poverty level.

In addition to attacking low-income citizens, the synopsis of the State of Michigan's cut of the national Tobacco Settlement from Michiganinbrief.org exposed:

Michigan's initial payment from the tobacco industry was \$104.5 million, to be followed by \$279–365 million annually for 24 years. Michigan, however, allocates none of its settlement money directly to tobacco-use prevention and cessation; it is one of only three states to take this approach.

Most disturbing is the fact that:

The Michigan Tobacco Settlement Finance Authority ("Authority") was created by Act 226 of 2005 and amended by Act 18 of 2007 to issue bonds secured by a pledge of a percentage of tobacco settlement proceeds which will be used to finance projects under the 21st Century Jobs Fund and make deposits to the state school aid fund and the general fund.

With the unemployment rate at 14.6%, which does not include those citizens no longer eligible to receive unemployment funds or who have had to escape the State because of the lack of work, the citizens need to ask just how well those 21st Century Jobs Funds are working out?

But, what is fundamentally the most disturbing feature of the State's political atmosphere is the insane laws, rules, and regulations which affect the business climate.

The State still punishes success, has incentive programs for green businesses and industries, gives tax breaks to the movie industry, all while they continue to crap on those who had built and supported the State for generations. There are no retention incentives.

It's pretty tough to tout the new slogan, "Pure Michigan" when there's an enormous turd floating in the middle of the political gene pool. Until the State respects its citizens there should be no reason for the citizens to reciprocate.

Debt versus Deficit

Government debt (also known as **public debt** or **national debt**) is money (or credit) owed by any level of government; either central government, federal government, municipal government or local government. The annual government **deficit**, however, refers to the difference between government receipts and spending in any given year.

As the government draws its income from much of the population, government debt is an indirect debt of the taxpayers. Government debt can be categorized as internal debt, owed to lenders within the country, and external debt, owed to foreign lenders. Governments usually borrow by issuing securities, government bonds and bills. Less creditworthy countries sometimes borrow directly from supranational institutions. Some consider all government liabilities, including future pension payments and payments for goods and services the government has contracted but not yet paid, as government debt.

Another common division of government debt is by duration until repayment is due. Short term debt is generally considered to be one year or less, long term is more than ten years. Medium term debt falls between these two boundaries.

A government bond is a bond issued by a national government, and often denominated in the country's domestic currency. Bonds issued by national governments in foreign currencies are normally referred to as sovereign bonds. Government bonds are theoretically risk-free bonds, because governments can, up to a point, raise taxes, reduce spending, or simply print more money to redeem the bond at maturity. Investors in sovereign bonds denominated in foreign currency have the additional risk that the issuer may be unable to obtain foreign currency to redeem the bonds.

A **budget deficit** occurs when an entity spends more money than it takes in. The opposite of a budget deficit is a **budget surplus**.

An accumulated governmental deficit over several years (or decades) is referred to as the government debt. Government debt is usually financed by borrowing, although if a government's debt is denominated in its own currency it can print new currency to pay debts. Monetizing debts, however, can cause rapid inflation (but does not necessarily do so) if done on a large scale. Governments can also sell assets to pay off debt. Most governments finance their debts by issuing long-term government bonds or shorter term notes and bills. Many governments use auctions to sell government bonds.

Governments usually must pay interest on what they have borrowed. Governments reduce debt when their revenues exceed their current expenditures and interest costs. Otherwise, government debt increases, requiring the issue of new government bonds or other means of financing debt, such as asset sales.

According to Keynesian economic theories, running a fiscal deficit and increasing government debt can stimulate economic activity when a country's output (GDP) is below its potential output. When an economy is running near or at its potential level of output, fiscal deficits can cause inflation.

The Ricardian equivalence hypothesis, named after the English political economist and Member of Parliament David Ricardo, states that because households anticipate that current public deficit will be paid through future taxes, those households will accumulate savings now to offset those future taxes. If households acted in this way, a government would not be able to use fiscal policy to stimulate the economy. The Ricardian equivalence result requires assumptions. These include households acting as if they were infinite-lived dynasties as well as assumptions of no uncertainty and no liquidity constraints.



The government's deficit can be measured with or without including the interest it pays on its debt. The **primary deficit** is defined as the difference between current government spending and total current revenue from all types of taxes. The **total deficit** (which is often just called the 'deficit') is spending, plus interest payments on the debt, minus tax revenues.

Therefore, if t is a timeframe, G_t is government spending and T_t is tax revenue for the respective timeframe, then

$$\text{Primary deficit} = G_t - T_t$$

If D_{t-1} is last year's debt, and r is the interest rate, then

$$\text{Total deficit} = G_t + rD_{t-1} - T_t$$

Finally, this year's debt can be calculated from last year's debt and this year's total deficit:

$$D_t = (1 + r)D_{t-1} + G_t - T_t$$

Economic trends can influence the growth or shrinkage of fiscal deficits in several ways. Increased levels of economic activity generally lead to higher tax revenues, while government expenditures often increase during economic downturns because of higher outlays for social insurance programs such as unemployment benefits. Changes in tax rates, tax enforcement policies, levels of social benefits, and other government policy decisions can also have major effects on public debt. For some countries, such as Norway, Russia, and members of the Organization of Petroleum Exporting Countries (OPEC), oil and gas receipts play a major role in public finances.

Inflation reduces the real value of accumulated debt. If investors anticipate future inflation, however, they will demand higher interest rates on government debt, making public borrowing more expensive.




Anti-religious zealots in DC care more about China.



What I am about to tell you is something you've probably never heard or will ever read in history books.

I believe that I am an eyewitness to history. I cannot tell you that Hitler took Austria by tanks and guns; it would distort history. We elected him by a landslide – 98% of the vote. I've never read that in any American publications. Everyone thinks that Hitler just rolled in with his tanks and took Austria by force. In 1938, Austria was in deep Depression. Nearly one-third of our workforce was unemployed. We had 25% inflation and 25% bank loan interest rates.

Farmers and business people were declaring bankruptcy daily. Young people were going from house to house begging for food. Not that they didn't want to work; there simply weren't any jobs. My mother was a Christian woman and believed in helping people in need. Every day we cooked a big kettle of soup and baked bread to feed those poor, hungry people – about 30 daily.

The Communist Party and the National Socialist Party were fighting each other. Blocks and blocks of cities like Vienna, Linz, and Graz were destroyed. The people became desperate and petitioned the government to let them decide what kind of government they wanted.

We looked to our neighbor on the north, Germany, where Hitler had been in power since 1933. We had been told that they didn't have unemployment or crime, and they had a high standard of living. Nothing was ever said about persecution of any group -- Jewish or otherwise. We were led to believe that everyone was happy. We wanted the same way of life in Austria. We were promised that a vote for Hitler would mean the end of unemployment and help for the family. Hitler also said that businesses would be assisted, and farmers would get their farms back. Ninety-eight percent of the population voted to annex Austria to Germany and have Hitler for our ruler.

We were overjoyed, and for three days we danced in the streets and had candlelight parades. The new government opened up big field kitchens and everyone was fed.

After the election, German officials were appointed, and like a miracle, we suddenly had law and order. Three or four weeks later, everyone was employed. The government made sure that a lot of work was created through the Public Work Service.

Hitler decided we should have equal rights for women. Before this, it was a custom that married Austrian women did not work outside the home. An able-bodied husband would be looked down on if he couldn't support his family. Many women in the teaching profession were elated that they could retain the jobs they previously had been required to give up for marriage.

Hitler Targets Education – Eliminates Religious Instruction for Children:

Our education was nationalized. I attended a very good public school. The population was predominantly Catholic, so we had religion in our schools. The day we elected Hitler (March 13, 1938), I walked into my schoolroom to find the crucifix replaced by Hitler's picture hanging next to a Nazi flag. Our teacher, a very devout woman, stood up and told the class we wouldn't pray or have religion anymore. Instead, we sang "Deutschland, Deutschland, Uber Alles," and had physical education.

Sunday became National Youth Day with compulsory attendance. Parents were not pleased about the sudden change in curriculum. They were told that if they did not send us, they would receive a stiff letter of warning the first time. The second time they would be fined the equivalent of \$300, and the third time they would be subject to jail. The first two hours consisted of political indoctrination. The rest of the day we had sports. As time went along, we loved it. Oh, we had so much fun and got our sports equipment free. We would go home and gleefully tell our parents about the wonderful time we had.

My mother was very unhappy. When the next term started, she took me out of public school and put me in a convent. I told her she couldn't do that and she told me that someday when I grew up, I would be grateful. There was a very good curriculum, but hardly any fun – no sports, and no political indoctrination. I hated it at first but felt I could tolerate it. Every once in a while, on holidays, I went home. I would go back to my old friends and ask what was going on and what they were doing. Their loose lifestyle was very alarming to me. They lived without religion. By that time unwed mothers were glorified for having a baby for Hitler. It seemed strange to me that our society changed so suddenly. As time went along, I realized what a great deed my mother did so that I wasn't exposed to that kind of humanistic philosophy.

Equal Rights Hits Home:

In 1939, the war started and a food bank was established. All food was rationed and could only be purchased using food stamps. At the same time, a full-employment law was passed which meant if you didn't work, you didn't get a ration card, and if you didn't have a card, you starved to death. Women who stayed home to raise their families didn't have any marketable skills and often had to take jobs more suited for men.

Soon after this, the draft was implemented. It was compulsory for young people, male and female, to give one year to the labor corps. During the day, the girls worked on the farms, and at night they returned to their barracks for military training just like the boys. They were trained to be anti-aircraft gunners and participated in the signal corps. After the labor corps, they were not discharged but were used in the front lines. When I go back to Austria to visit my family and friends, most of these women are emotional cripples because they just were not equipped to handle the horrors of combat. Three months before I turned 18, I was severely injured in an air raid attack. I nearly had a leg amputated, so I was spared having to go into the labor corps and into military service.

Hitler Restructured the Family Through Daycare:

When the mothers had to go out into the work force, the government immediately established child care centers. You could take your children ages 4 weeks to school age and leave them there around-the-clock, 7 days a week, under the total care of the government. The state raised a whole generation of children. There were no motherly women to take care of the children, just people highly trained in child psychology. By this time, no one talked about equal rights. We knew we had been had.

Health Care and Small Business Suffer Under Government Controls:

Before Hitler, we had very good medical care. Many American doctors trained at the University of Vienna. After Hitler, health care was socialized, free for everyone. Doctors were salaried by the government. The problem was, since it was free, the people were going to the doctors for everything. When the good doctor arrived at his office at 8 a.m., 40 people were already waiting and, at the same time, the hospitals were full. If you needed elective surgery, you had to wait a year or two for your turn. There was no money for research as it was poured into socialized medicine. Research at the medical schools literally stopped, so the best doctors left Austria and emigrated to other countries.

As for healthcare, our tax rates went up to 80% of our income. Newlyweds immediately received a \$1,000 loan from the government to establish a household. We had big programs for families. All day care and education were free. High schools were taken over by the government and college tuition was subsidized. Everyone was entitled to free handouts, such as food stamps, clothing, and housing.

We had another agency designed to monitor business. My brother-in-law owned a restaurant that had square tables. Government officials told him he had to replace them with round tables because people might bump themselves on the corners. Then they said he had to have additional bathroom facilities. It was just a small dairy business with a snack bar. He couldn't meet all the demands. Soon, he went out of business. If the government owned the large businesses and not many small ones existed, it could be in control.

We had consumer protection. We were told how to shop and what to buy. Free enterprise was essentially abolished. We had a planning agency specially designed for farmers. The agents would go to the farms, count the live-stock, then tell the farmers what to produce, and how to produce it.

"Mercy Killing" Redefined:

In 1944, I was a student teacher in a small village in the Alps. The villagers were surrounded by mountain passes which, in the winter, were closed off with snow, causing people to be isolated. So people intermarried and offspring were sometimes retarded. When I arrived, I was told there were 15 mentally retarded adults, but they were all useful and did good manual work. I knew one, named

Vincent, very well. He was a janitor of the school. One day I looked out the window and saw Vincent and others getting into a van. I asked my superior where they were going. She said to an institution where the State Health Department would teach them a trade, and to read and write. The families were required to sign papers with a little clause that they could not visit for 6 months. They were told visits would interfere with the program and might cause homesickness.

As time passed, letters started to dribble back saying these people died a natural, merciful death. The villagers were not fooled. We suspected what was happening. Those people left in excellent physical health and all died within 6 months. We called this euthanasia.

The Final Steps - Gun Laws:

Next came gun registration. People were getting injured by guns. Hitler said that the real way to catch criminals (we still had a few) was by matching serial numbers on guns. Most citizens were law abiding and dutifully marched to the police station to register their firearms. Not long afterwards, the police said that it was best for everyone to turn in their guns. The authorities already knew who had them, so it was futile not to comply voluntarily.

No more freedom of speech. Anyone who said something against the government was taken away. We knew many people who were arrested, not only Jews, but also priests and ministers who spoke up.

Totalitarianism didn't come quickly, it took 5 years from 1938 until 1943, to realize full dictatorship in Austria. Had it happened overnight, my countrymen would have fought to the last breath. Instead, we had creeping gradualism. Now, our only weapons were broom handles. The whole idea sounds almost unbelievable that the state, little by little eroded our freedom.

After World War II, Russian troops occupied Austria. Women were raped, preteen to elderly. The press never wrote about this either. When the Soviets left in 1955, they took everything that they could, dismantling whole factories in the process. They sawed down whole orchards of fruit, and what they couldn't destroy, they burned. We called it The Burned Earth. Most of the population barricaded themselves in their houses. Women hid in their cellars for 6 weeks as the troops mobilized. Those who couldn't, paid the price. There is a monument in Vienna today, dedicated to those women who were massacred by the Russians. This is an eye witness account.

It's true....those of us who sailed past the Statue of Liberty came to a country of unbelievable freedom and opportunity. America Truly is the Greatest Country in the World. Don't Let Freedom Slip Away.

Clinton vetoed the budget, shut down the government, and blamed the Republican's insistency on "cutting Medicare." Polls showed the nation backing Clinton and backing away from Congress. Gingrich and the GOP capitulated and did as Clinton demanded, restored the Medicare funds. Even at his weakest, Clinton had read the country right and bested the GOP when it thought the country was behind it.

Like Lee at Gettysburg, the party had chosen to fight on the wrong battlefield. At that

point the Republican morale was broken, wrote Buchanan. And no one until now has had the guts to take on the task. Now, today, Barack and friends want an unelected, unaccountable "death panel" to approve or reject treatments using a formula that divides the cost of the treatment by the number of years the patient is likely to benefit and guess who is targeted? With Americans living longer and health-care costs rising, Medicare and its sister Medicaid program for the poor are the fastest growing part of the federal budget. Trustees were projecting that Medicare's hospital fund would go broke in 2002 without corrective action. To use the word "trustee" suggests something is in trust; however, the bureaucrats found the social security deposits to be just another slush fund. Today there is no trust fund and baby boomers are now retiring and looking for their share only to find it broke. In addition to presidents appointing naifs to head these unconstitutional agencies that always end up mismanaged and because there is no accountability or punishment like there is in the private sector, one of the most profitable crimes in America is the fraud industry.

Well, perhaps no single act in the entire administration of the beloved Franklin D. Roosevelt really did more to win him the illustrious place in history he has as did the laying of that cornerstone...And those who share this day will also be remembered for making the most important addition to that structure, and you are making it in this bill, but most important addition that has been made in three decades." Johnson explained, "Through this new law...every citizen will be able, in his productive years when he is earning, to insure himself against the ravages of illness in his old age. This insurance will help pay for care in hospitals, in skilled nursing homes, or in the home. And under a separate plan, it will help meet the fees of doctors." So Johnson, like Roosevelt, understood the importance of deceiving the American people by packaging Medicare's potential costs in the lie of insurance. A November 27, 2009 article

said Medicare makes an expected announcement that Physicians' pay will be cut 21% in 2010. The Medicare Fee Schedule sets payment rates for more than 7,000 types of services in physicians' offices, hospitals and other settings. Recently, a number of letters to the editor in my local paper tell about how doctors are no longer taking Medicare patients.

The private sector could never get away with such lies. When we sign up for insurance through the private sector, we have a legal and binding contract and they are required by law to have substantial reserves or its CEOs go to jail if the government doesn't unconstitutionally decide to bail them out. Yes, some people with pre-existing conditions may be rated or put into risk categories and others such as smokers, mountain climbers, skydivers and others in risky categories may have a higher premium, which is understandable. But with the government in charge, anyone is eligible and the responsible ones pay for the risky behaviors and let's be honest. Many who don't have insurance would sooner spend their money on frivolous items instead.




Payroll tax

generally refers to two different kinds of similar taxes. The second kind is a tax that is paid from the employer's own funds and that is directly related to employing a worker, which can consist of a fixed charge or be proportionally linked to an employee's pay.

"A recent study in Georgia found more than 15,000 dead people on active voting rolls statewide. Alaska, according to Federal Election Commission, had 502,968 names on its voter rolls in 1998. The census estimates only 437,000 people of voting age were living in the state that year...

"A cursory check of the registration cards turned up questionable names. Shortly thereafter, election board workers spent an entire day calling the names listed on the cards and found that nearly all of them were fraudulent. Many of them sought to register prominent people, dead or alive - as well as at least three deceased aldermen and a dog. The media have reported that close examinations have turned up cards that attempted to register prominent businessmen using their childhood addresses, a former deputy mayor using an old address for an alderman, and a former alderman who has been dead for years.

"They also found cards for convicted felons and for residents who did not seek to register themselves in the primary. The woman at the center of this vote fraud investigation "doesn't deny" that some of her canvassers may have turned in bogus voter registration cards. A grand jury convened by St. Louis Circuit Attorney Jennifer Joyce has begun interviewing witnesses regarding the 3,800 bogus registration cards. St. Louis police have obtained a warrant and searched the house of the Operation Big Vote director for evidence.

"Not surprisingly, many St. Louis residents are angry that someone had registered them and knew information such as their Social Security numbers. Some of the people registered by the bogus cards told Election Board workers that someone calling himself "Big Mike" came to their homes and said he was with the Election Board and wanted to register them.....

"The clogged rolls have cost taxpayers thousands of dollars in cleanup costs and additional election expenses. For example, the Indiana Election Division has conducted its statewide duplicate program four times at a total cost of about \$900,000. Moreover, several county officials in Indiana have increased the number of voting sites unnecessarily because the lists are so inaccurate.

"The county that includes the transient student population of Indiana University at Bloomington has added about a half dozen precincts since "Motor Voter" became law. Each new precinct costs county taxpayers \$10,000 for two voting machines and about \$500 per election for additional poll workers and supplies. Statewide in Indiana, more than 200 precincts have been added since the law went into effect, according to state election officials. Such costs are not trivial, especially since the state gets nothing in return for such spending. Such costs for the nation as a whole must be large.

"We have also learned about the threat of vote fraud posed by such wildly inaccurate voting rolls. Susan Morandi, Nevada's deputy secretary of state for elections, noted that the Motor Voter Act made registration easier but also made the process "much more open to voter fraud." Experts like Deborah Phillips of the Voter Integrity Project add that the trend toward mail-in and absentee voting exacerbates this problem, since those seeking to manipulate the system can pretend to be a dead person or someone who has moved, and then cast a ballot.....

"Mr. Chairman, judged by its purposes, the National Voter Registration Act should be judged a failure. The Act has brought about a substantial increase in the number of registered voters. However, that increase has been bought at a high price. Specifically, the Act has made it difficult if not impossible to maintain clean registration rolls, a major purpose of the law. Moreover, the inaccuracy in the rolls caused by the Act has thrown into doubt the integrity of our electoral system."

Our elections have been stolen from us for decades. I know because I ran for Congress. I know what it's like to be cheated. Thousands were screaming about it election after election, but it wasn't until the 2000 pretend presidential election that the Democrats catapulted the issue into America's living rooms. Apparently it was faster to hand count 8,497 ballots, as they did promptly in Newburyport, or 7,339 ballots, as they hand counted in public for all to see in Milton, than to push a button and wait five minutes for the machine to spit out a Diebold results report in Pelham where they had 725 votes. East Brookfield's 899 Diebold votes must have run out of gas somewhere; they weren't reported for hours.

"All in all, a total of 170,594 Diebold votes took a long time to stumble in the door. These votes -- surprise! -- favored Coakley. She got 86,214 of them, for 50.54%, and Brown got 82,911 tardy Diebold votes, for 48.60%, putting Coakley on the plus side of the late arrivers by a 1.94% margin, for a net gain of 3,303 slow-moving votes.

"They'd called the election by the time the 170,594 tardy Diebold votes showed up. Coakley had conceded."


