# The 2010 Spending Record

Perhaps you missed it, but then so did the Washington press corps. Late last week the Congressional Budget Office released its preliminary budget tallies for fiscal year 2010, and the news is that the U.S. government had another fabulous year—in spending your money. We didn't expect President Obama to hold a press conference, but why are Republicans so quiet?

Spending rolled in for the year that ended September 30 at \$3.45 trillion, second only to 2009's \$3.52 \$262 billion from 2009 as banks trillion in the record books. As for the deficits, the 2010 total was \$1.29 trillion, down slightly from \$1.42 trillion. That's a two-year

total of \$2.7 trillion, or more than the entire amount during the Reagan Administration, when deficits were supposed to be ruinous. Now liberal economists tell us that deficits are the key to restoring prosperity. But all we have to show for spending nearly 25% of GDP for two years running is a growth rate of 1.7% and 9.6% unemployment. have contributed to the deficits by yielding paltry tax revenues. Individual income tax receipts fell again in 2010, by 1.6% to \$901 billion. As recently as 2008, individual income tax revenues were \$1.15 trillion. Corporate tax revenue climbed a healthy 38.6% to \$192 billion, but that's still well below the \$304 billion of 2008. This only underscores how much deficit reduction depends on a growth revival. Here's the kicker: By far the biggest percentage-gain revenue winner for the taxpayer in 2010 was... the Federal Reserve. Thanks to the expansion of its balance sheet

The Fed's windfall is a perfect symbol of education, transporta- our current economic policy. The government is making money because it now controls so much capital, but it is robbing that money from the private economy in the process. It is never a good sign when your central bank is a national profit center.

You might call it the fiscal scorecard for the 111th Congress, and that's before the ObamaCare subsidies begin in earnest. (We've excluded TARP and deposit insurance to better capture the underlying spending trend.)

The 21.4% federal spending in-Those slow growth numbers crease in two years ought to put to rest any debate about the nature of America's fiscal problem. The Pelosi Congress has used the recession as an excuse to send spending to record heights, and its economic policies have contributed to a lousy recovery. The solution is to stop the spending and change the policies. Polls open on November 2.

## **Constitutional Bereavement**

It actually begins on January 4, 2005 when senator-elect Barack H. Obama took his oath of office as a U.S. Senator. The Senate is constitutionally required to vet all members' eligibilities before they can take their oath of office.

The extended duration that an ineligible person holds a position reserved to only a natural-born citizen complicates the recall and rescinding of all actions taken by the ineligible individual.

Where the problems start to evolve is primarily connected to appropriated funds. Since it was first the requirement of the Democratic National Committee to vet Obama, followed by the Democratic Party members holding senate seats, any money appropriated in which Obama cast a vote would have to be immediately repaid by those responsible for the vetting process.

While back-tracking is easy enough regarding an ineligible person's vote on any legislative action; it's those small details like expending public moneys to travel, entertain, vacation and even eat that will have to calculated in order to reimburse the taxpayers.

#### Understanding the Nature Conservancy's Conservation Plan for the Upper Peninsula of Michigan



What follows is a short synopsis of what appears to be happening to the Upper Peninsula land and waters at the hands of the Nature Conservancy (TNC). There is much to digest, but there is much more that could have been included. ~C. J. Williams

TNC does a marvelous job of baiting the hook and pulling suckers in. The "stake holder's" (us) go to a negotiation table to beg for the right of traditional land use, which generally means the right to enter public lands by motorized access. There are trained TNC facilitators at these meetings, as well as numerous representatives from agencies that have partnered with TNC. The scale is tipped, and when enough of us don't show up to help those begging, miniscule concessions may be made for the short term, but, as citizens, we will all have lost the right to access or easily access our own public lands.

Noisy, polluting, sportsmen are targeted at first, but we have now learned that cross-country skiers actually also disturb wildlife, which is claimed to need rest to retain strength during the winter months. Eventually...all humans will be kept out of a great deal of the land purportedly "protected" for public use.

Over the years TNC has spawned many companies who are then contracted by state governments to also facilitate TNC's plan to re-wild America, as much as possible, to the condition they believe it was prior to Columbus' discovery. As best as can be determined, TNC is immune from prosecution and appears to have pretty free reign over whatever they decide to do in the name of eco-systems, people be damned. Paper is to be made from straw and the fluffy stuffing in your comfy pillows are to be replaced with downy seeds of the milkweed plant. One industry mentioned to replace logging is the harvesting of mushrooms and people will pay to pick. Most often, the transaction will include a conservation easement in perpetuity, which restricts how that land can be used, even if later transferred to another party. Engler wanted 390,000 acres Forestland now owns, and by already having investigated the original sale a couple of years ago, it appears history is repeating itself, perhaps at a greater profit, with Granholm, the DNR, and its TNC partner.

The DNR gets money to purchase land or easements through the Natural Resources Commission Trust Fund Board. Steven Hamp, who sits on that board, is also a board member of the MI branch of TNC. Another, Sam Washington, is the CEO of the Michigan United Conservation Clubs, which appears to be facilitating Agenda 21 in MI. MUCC is an affiliate of the National Wildlife Federation (only one conservation group allowed per state,) and the NWF and TNC are both partners of the UN's International Union for the Conservation of Nature. The IUCN is implementing the Biodiversity Treaty, the Wildlands Project, Sustainable Development, and Agenda 21 all over America. In the U.P. TNC Conservation Plan report they list only 4 targets. However, these 4 targets provide what they refer to as "nesting areas". While we might think of "nesting" as relating to birds, this is not the case here. Each target is selected to blanket other species' habitats also, and that is what is meant by "nested".

As far as Red Crossbills, it appears they prefer "old forest" habitat and soTNC is attempting to regenerate old forest growth. I'm not a logger, but my understanding is that a great deal that should be logged isn't. The forest understory, if allowed to return to a natural state, is an extreme fire threat... but then, managing ecosystems by fire is part of TNC's plan. They want no human interference with wildfires and no human interference with flooding. They are also at work all over the nation, partnering with the Army Corps of Engineers; removing dams or doing whatever they feel is necessary to put things back as "nature" intended. The Neo-tropical migratory birds would be the nesting targets for any matter of things in wetlands and semi-wet (mesic) areas. These birds include geese and other migratory species. TNC and it's partners are working to control the Great Lakes Basin fresh water resources and whatever land type surrounds it, including the forest and agriculture land in the U.P.

developed Bio-reserves are around the core Biosphere. There is a Biosphere at Isle Royale and also one near the tip of the Lower Peninsula. Humans pose the greatest threat to Bio-Reserves. We destroy the habitat of all other things by our actions...mining, logging, building homes, putting in a culvert, septic systems, and even going into the woods to hunt or pick berries, and also to and on the lakes and streams to fish. TNC may want you to believe you will always and forever be able to access our public lands by traditional means, but then along will come their cohorts with stricter and stricter environmental laws until your access is relegated to "view sheds" and stay on the path signs during escorted sight-seeing strolls to enjoy your "protected for the public" land. There is so much more, but a great deal of it points back to the UN's Biodiversity Treaty, which Clinton signed, but Congress never ratified. There are many such treaties and UN Programs/Projects. In fact, I've just come across the UN's Dams & Development Program, which deals with watersheds.

TNC will "partner" with any local government agency looking for a grant to buy land... then they move in and offer to "protect" it. As I understand it, they do not have to pay property taxes on what they own, but may offer to pay them to hide their vulture mentality. Later, they can renege on the offer and local governments have no recourse. In any of their literature that they put out, just substitute the word "control" for protect...

"Working forest backdrop" is really the entire U.P. Working forest doesn't mean there will be normal logging procedures. It means there will be very selective cutting to "control", not protect, the UP for all nested "targets". Efroymson is deceased, but his legacy lives on through workshops. I firmly believe that the DNR has purposely been reporting deer population numbers far above what really is there, purposely issuing far too many doe permits, and intentionally causing us to help eradicate our whitetail deer herd.

TNC is not truly interested in all the little wood rats and lady bugs in the world's ecosystem. They're interested in destroying our property rights and constitutional rights so that our land can be turned over to the UN and our resource wealth can be controlled.



When people think of the Secretary of State, they most often think of driver licenses and plates for their vehicle. Seldom do they think of election laws and the enforcement thereof.

When people think of avowed Marxist and billionaire George Soros, they most often think of the stock market and the hefty campaign contributions he gives to his favored Democrat presidential puppets, i.e. liberal progressives Bill Clinton, Al Gore and Barack Hussein Obama.

The Secretary of State Project group chose Michigan as one of its

targets for this year's mid-term election and is throwing all it financially can behind Democrat contender Jocelyn Benson, who intends to replace termlimited Republican Terri Lynn Land as the state's next Secretary.

Benson, a soon to be 33-year old McMurray, PA native, became interested in social activism and community organizing early on; interests that could explain why Obama Administration officials and other left-wing, progressive "political insiders" were so generous at a July 2009 fund raiser hosted on her behalf in Washington D.C. Benedict Arnold Stupak also contributed, as did Michigan's John Conyers and Carolyn Cheeks Kilpatrick, among many others.

Before earning her law degree, Benson began her working career by tracking and reporting on the activities of "hate groups" for the Southern Poverty Law Center (SPLC), which champions civil rights, specializes in teaching tolerance, and advocates for the acceptance of diversity through 'innovative" litigation.

More than a few Michigan patriotic Tea Party organizations have made the Law Center's hate group watch list, as has an anti-illegal immigration activist group headquartered in Petoskey. Rep. Ron Paul, Judge Anthony Napolitano. Glenn Beck, and Ron Ewert and his National Association of Rural Landowners are listed among many others on the SPLC hit list.

Benson, who received a Bachelor's degree at Wellesley College in 1999 and a law degree from Harvard in

Michigan's Wayne State University. She launched her campaign for the MI-

SoS seat in March 2009 after receiving support for her "early voting" and "noreason absentee voting" proposals at a state Democratic Party convention a month earlier.

Among Benson's supporters, other than the Soros-backed SoS Project, is the Oakland County Democratic Party, of which some members had a hand in forming the bogus political "Tea Party" Party so as to hoodwink politically illinformed conservatives and draw votes away from Republican candidates on Election Day.

Ms. Benson is the relatively new wife of Michigan native and community activist and organizer Ryan Friedrichs, whose thesis at Harvard was a study for the Michigan Democratic Party regarding the cost effectiveness of mobilizing young voters for the 2002 election.

As a liberal progressive, Friedrichs worked for Hillary Clinton's political teams at HillPac and Friends of Hillary. He was also employed as a research assistant for former Saturday Night Live jokester Al Franken, who fought a hotly contested and expensive vote recount battle against Norm Coleman before being sworn in as a U.S. Senator from Minnesota in 2009.

The young man's work in Michigan centers on building coalitions to empower communities of color, impressionable young voters, new citizens and down on their luck low-income voters. He's the coordinator for Michigan Voice, a coalition of 48 groups that work for social justice.

Among Michigan Voice's partners are ACORN, the SEIU Michigan State Council, the Michigan Unitarian Universalist Social Justice network, the Sierra Club, TransGender Michigan, Planned Parenthood Affiliates of Michigan and the Center for Progressive Leadership, for which Gov. Granholm and Friedrich, among others, act as "trainers". It should be noted that ACORN hasn't disbanded, but instead is still operating under different names, i.e. Community Organizations through the bogus and now defunct International and Affordable Housing

Centers of America (formerly ACORN Housing).

Early voting and no-excuse absentee voting, which Jocelyn Benson champions, may provide some conveniences, but both proposals could open the door to more voter fraud. To her credit, current SoS Terri Lynn Land, much to the chagrin of the "Michigan Election Reform Alliance", began a 3-year purge of the state's voter database in 2006.

"It's not the votes that count, it's who counts the votes" is a quote attributed to Soviet dictator Josef Stalin. With the Secretary of State Project, ACORN, MoveOn.org, and the SEIU becoming more and more involved with the electoral process, there could well be more of those who vote from the grave, or from disputable addresses, or at multiple precincts on Election Day depending on who allows which votes to be counted. Conservative voters need to be aware of this and vote accordingly for a candidate whom they believe will best preserve the integrity of the ballot box and election laws.

Benson's Republican opponent is Ruth Johnson, the current Oakland County Clerk who defeated Michigan ACORN coordinator and Democrat Sheila Smith for that position in 2008. During this year's State Republican Convention the former state representative, public school teacher, and small business owner was overwhelmingly selected from a slate of five excellent candidates as the best person to face-off against Jocelyn Benson.

Over the years, Johnson has earned a reputation for her tenacity in uncovering fraud, particularly within the Oakland County Intermediate School District. Most recently, she has been credited with investigating and putting an end to the scandalous behavior of some prominent Oakland County Democrats who were attempting to rig the mid-term election political "Tea Party" Party.

# GARY MCDOWELL NO FRIEND OF TAXPAYERS

Gary McDowell, a 58-year old career politician from the rural Eastern Upper Peninsula Rudyard area, has been involved in politics at the county and state level for almost thirty years.

While the Democrat would have Michigan's 1st District voters believe he's a farmer at heart, truth is he spent 33 years working for the United Parcel Service – a job he apparently landed after graduating from high school in 1970. His claim to farming fame comes through a twenty-year stint as treasurer for McDowell Hay, Inc., a 1,000-acre hay farming and distribution business owned by himself and his two brothers. Some of their compressed hay is exported to Haiti, the West Indies and other countries.

Before being elected as a state representative in 2004, McDowell served on the Chippewa County Board of Commissioners (1981-2002). He was also a Board member of his county's Economic Development Corporation for seventeen years (1987-2004).

As a Democrat in Lansing he aligned himself well with the job-killing Granholm administration and has done little to nothing to bring prosperity to Michigan, let alone the U.P. Even with that baggage. McDowell has set his sights on taking over for U.S. Congressman Benedict Arnold Stupak who, after much strutting and preening in the public eye last spring, sold out to the Pelosi Machine on the abominable Healthcare issue.

McDowell, whose district covers Chippewa and Mackinac County in the Eastern U.P., as well as downstate Emmet County and two Cheboygan County townships, is like most Democrats in that he shuns free enterprise and appears to prefer cherry picking which businesses to welcome the state.

As McDowell has been involved with Economic Development Corporations at the local and state level since 1987, one would think he'd have a better track record in playing the "pin the tail on the donkey" jobs game by now, but unfortunately that's not the case.

One donkey pinned by McDowell is an

entrepreneurial "green energy" company known as Mascoma, which purportedly will eventually get around to setting up shop in Chippewa County. While he and other state legislators, along with Granholm and the Michigan Economic Development Corporation, contrived to shower Mascoma with special tax breaks and over \$23 million in state grants, and lauded its job creating potential, the cellulosic fuel producer just can't seem to get it off the pad in the U.P., even with multi-millions of more dollars from 'investors'.

Interestingly, the now Lebanon, N.H.based Mascoma bio-fuel maker wannabe, which began in 2005 as a Dartmouth College innovative enterprise, recently bought and merged its company with SunOpta BioProcess Inc., a division of SunOpta Inc of Canada. Due to the merger, the newly blended company collectively has development partners in China, Brazil and South Africa, as well as in the U.S. and Canada, and also became a strategic joint venture partner with Xylitol Canada, maker of an all-natural sweetener.

Should Mascoma ever quit wheeling and dealing with international conglomerates and get around to building its Chippewa County plant, it hopes to produce bio-fuel not only from wood chips, but also from switchgrass. Just think how beneficial that could be for U.P. farmers, including the McDowell brothers who could stop making hay on their 1,000-acre farm and grow switchgrass instead.

Another less than stellar choice for preferential tax treatment by Gary McDowell and his legislative cohorts was a personal security service company, Sovereign Deed, which wanted to set up shop at the tiny Pellston Airport in Emmet County. McDowell rushed his special tax break legislation through the state House and Senate (with help from his hands-across-the-aisle buddy, Sen. Jason Allen), and had it on Granholm's desk ready for her to sign within 24 days time on May 18, 2007, which she gleefully did seven days later.

In his special tax abatement legisla-

a particular firm that wanted to set up a strategic response center that would administer catastrophic needs to private corporations and government entities. Later, after investigation by a Michigan Messenger reporter, the men operating Sovereign Deed were exposed as snake oil salesmen looking for a leg up in their scheme to sell national catastrophe security to the wealthy. For a mere \$50,000 initial membership fee and another annual fee of \$15,000, Sovereign Deed would guarantee its clients an edge if and when all hell broke loose.

The base package offered would have included one-on-one training; early notice of a catastrophe to allow the wealthy to escape before roads were clogged; emergency updates; food supplies; a survival kit; and a satellite phone if necessary. At the highest level of service, a member would have been personally rescued and evacuated. So much for the Democrat's image of being on the side of poor working stiff, eh?

Folks, Michigan has lost an estimated 800,000 working stiff jobs in the past ten years, 204,000 of them in 2009 alone. In 2007 it was estimated that Michigan's local governments were giving up at least \$1 billion worth of tax revenue annually in a futile effort to retain or create jobs through preferential tax abatements to certain businesses. Yet, Gary McDowell still wants to be selective about who does business in Michigan and offer special tax treatment and taxpayer money to those that catch his eye for any variety of reasons.

However, Rep. McDowell hasn't been as magnanimous with Michigan citizens during his tenure in office. Although it was later repealed and replaced with a job-killing business tax surcharge in Nov. 2007, McDowell voted for Granholm's massive \$1.35 billion tax hike package on Sept. 30 of that year. That package, the largest in the state's history, raised the state income tax onus to 11.5 percent and expanded the 6 percent state sales tax to 23 new services, including haircuts and ski tickets.

According to a Detroit Free Press article at the time, McDowell was quoted as tion McDowell billed Sovereign Deed as saying, "I'm ready to do whatever it takes to keep the state moving forward. I anguished over it. Nobody wants to raise taxes, especially me. But I know it's the right thing to do."

It's been claimed that McDowell has never met a tax he didn't like. Considering that on Sept. 22, 2009 he was all for imposing a 3 percent 'provider tax' on at least 15.000 Michigan physicians to help plug a \$2.8 billion dollar hole in the 2010 state budget, there must be some truth to the claim.

Instead of cutting millions of dollars in handouts to outfits like Mascoma and Sovereign Deed and defunding failing enterprises like the Michigan Film Studio and it's 42 percent tax break for film makers, McDowell would rather tax the bejudus out of Michigan's working poor and force them to pay more for services, including doctor appointments.

Information at Project Vote Smart indicates McDowell supported the interests of the Michigan Chamber of Commerce by a mere 29 percent in 2007-08. Additionally, based on a point system, with points assigned for action in support of or in opposition to the Michigan National Federation of Independent Business's position, he was awarded a pathetic rating of 9 out of 100. McDowell's abysmal pro-business track record is such that this year the Michigan Farm Bureau Agri-Pac Committee has endorsed the hay farmer's Republican opponent Dr. Dan Benishek.

Yours truly can understand why Michigan's 1st District liberal progressives would support a tax, spend and "grow government" candidate like McDowell for the U.S. House. However, it's hard to comprehend how independent voters and the more conservative

Democrats could do so, that is unless they're rolling in dough and prepared to redistribute their wealth to further the Washington, D. C. socialists' agenda.
