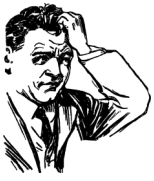

# The Preponderance—An Amazing Head-scratcher

[Former U.S. President Donald Trump faces 37 felony charges](#), which are based on the search warrant findings executed on his private residence. Search Warrant?

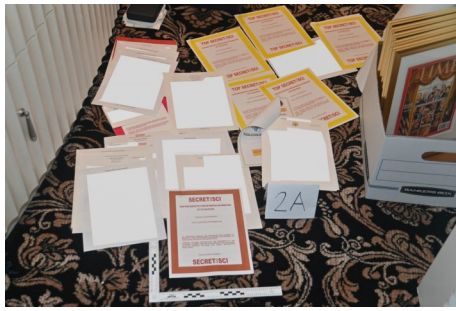

[dence](#) that was illegally obtained. As the metaphor suggests, if the evidential "tree" is tainted, so is its "fruit."

With these treasonous acts that go well beyond the flip-pant disregard of afforded protections under the Constitution, various conspirators have honed-in individuals

that can do the most harm to America's neo-fascists. It began early with the knowingly falsified "Russia Collusion" campaign and cojoined with the General Michael Flynn firing under the direction of the incoming

Vice-President Mike Pence, who would later claim he was asked to overturn the election by President Trump rather than invoking his authority of sending the well-known and verified election disparities back to the states.

A few more items of concern have developed as a result of the use of corrupt government employees and highly

ignorant grand jury members to attack persons on the right while protecting persons on the left. It appears that the "[Grand Jury](#)" clause in the Constitution needs to be reevaluated and redefined by SCOTUS; the definition of a [Grand Jury](#) as a *group of people selected to sit on a jury that decide whether the prosecutor's evidence provides probable cause to issue an indictment* . . . *The grand jury acts as an investigative body, acting independently of either prosecuting attorney or judge.*

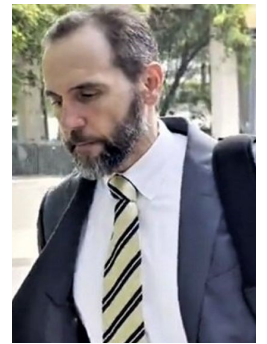
The last sentence defines the problem with a citizen-oriented grand jury. Most citizens will sit there listening to the prosecutor bullsh\*t his/her way through presentation of what they consider evidence with no



presentation of exculpatory evidence, as we seen with the January 6 Committee and the detention of January 6 participants by the neo-fascists.

What we have learned through recent events is that the intent of the Grand Jury to [act as a buffer](#) between the Government and the people, providing a check on governmental power, has failed miserably. The problem isn't the entrusted citizens compelled to sit on a Grand Jury, it's the manipulative prosecutors and their government allies acting on behalf of their vindictive agendas that are the problem.

Perhaps there should be two considerations to readjust the propensities of dishonest persons. First is to have clear, unnegotiable penalties for anyone, including prosecutors, that knowingly misrepresent the facts, which should consist of reimbursing all costs associated with the convening and a criminal penalty.



Second, if grand juries permanently consisted of retired law enforcement officers and other investigative professionals that would be quite willing to openly challenge the investigative process and the prosecutor's evidence, we may have an empaneled constitutionally-competent group of citizens capable of critical thinking that would be issuing Grand Jury indictments.

At this point in the formation of the seditious and treasonous conspiracy, Congress needs to compel the U. S. Marshal Service to seek search warrants for all federal facilities housing the Biden documents collected by the DoJ and FBI in order to established the validity of their seizure.

## Trump Could Face 400 Years in Prison if Convicted on All Federal Charges

Former President Donald Trump could be sentenced to 400 years in prison if he is convicted on all charges and the maximum sentences are imposed consecutively, though a likelier penalty would be for five to twenty years.

Trump was charged with 37 counts, and co-defendant Waltine Nauta was sentenced to six counts. They are:

Counts 1-31, for "Willful Retention of National Defense Information" under [18 U.S.C. § 793\(e\)](#), carry a maximum sentence of ten years for each charge.

Count 32, for "Conspiracy to Obstruct Justice" under [18 U.S.C. § 1512 \(k\)](#), makes Trump and Nauta liable for the same penalties that each would receive for their alleged crimes as part of the alleged conspiracy, in this case up to 20 years.

- Count 33, for "Withholding a Document or Record" under [18 U.S.C § 1512 \(b\) \(2\) \(A\)](#) (and also § 2, making Trump a "principal" for allegedly causing the act alleged to have been committed by Waltine Nauta), carries a sentence of up to 20 years.

Count 34, for "Corruptly Concealing a Document or Record" under [18 U.S.C. § 1512 \(c\) \(1\)](#) (and also § 2), carries a sentence of up to 20 years.

Count 35, for "Concealing a Document in a Federal Investigation" under [18 U.S.C § 1519](#) (and also § 2), carries a sentence of up to 20 years.

Count 36, for "Conspiracy to Conceal" under [18 U.S.C. § 1001 \(a\) \(2\)](#) (and also § 2), carries a sentence of up to five years.

Count 37, for "False Statements and Representations" under [18 U.S.C. § 1001 \(a\) \(2\)](#) (and also § 2), carries a sentence of up to five years.

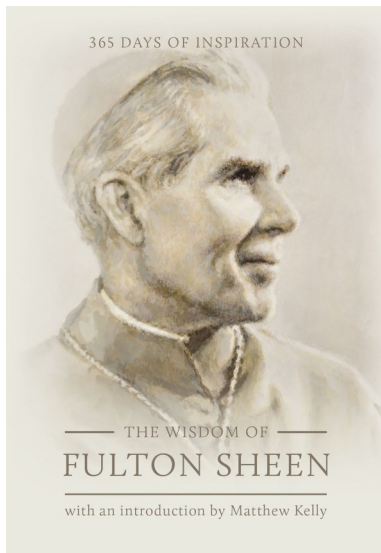
Count 38, for "False Statements and Representations" under [18 U.S.C. § 1001 \(a\) \(2\)](#), carries a sentence of up to five years.

Trump faces counts 1 through 37; Nauta faces counts 32, 33, 34, 35, 36, and 38. That means Trump faces a potential sentence of 400 years, while Nauta faces a potential sentence of 90 years, though it is unlikely that a judge would impose these sentences to run consecutively.

It is more likely that each would face a sentence of up to five years on the lesser charges, or up to 20 years on the greater charges, with other sentences concurrent.

## California Bill Would Allow Killing Babies in Infanticide Up to 28 Days After Birth *Greg Burt* | Mar 24, 2022

California policymakers who make up the [“Future of Abortion Council”](#) just dropped a bombshell. They intend to not only codify the killing of unborn children throughout all nine months of pregnancy but to decriminalize killing newborns days or even weeks after birth.

New language added to [AB 2223](#) last week revealed the disturbing intent. The proposed legislation would shield a mother from civil and criminal charges for any “actions or omissions” related to her pregnancy, “including miscarriage, stillbirth, or abortion, or perinatal death.” Although definitions of “perinatal death” vary, all of them include the demise of newborns seven days or more after birth.

The bill from [Assemblywoman Buffy Wicks](#) additionally protects anyone who “aids or assists a pregnant person in exercising” these rights. It also allows a woman to sue any police department or legal authority which arrests or charges her for hurting or killing her child under provisions of the bill.

“For years, pro-life advocates have argued there is no moral difference between ending a child’s life days before birth or days after birth. California’s pro-abortion legislators now seemingly agree,” said Jonathan Keller, President of California Family Council. “A political culture that justifies killing millions of children in the womb is now declaring open season on unwanted newborns. Every Californian must oppose this heinous bill.”

Governor Newsom formed the “Future of Abortion Council” last year in an effort to



turn California into a “sanctuary state” for the procedure. Organizers listed AB 2223 as part of their [legislation package](#) implementing a 45-point plan to “expand and protect access” to abortion in California.

A few weeks ago, Maryland introduced a bill that [“decriminalizes neglecting newborns to death”](#) using the same “perinatal death” language, though the bill hearing was canceled. In 2019, Virginia Governor Ralph Northam was widely condemned for a [radio](#)

[interview](#) asserting doctors could decide to allow children to die after birth “if that’s what the mother and the family desired.”

The first stop for AB 2223 is the Assembly Judiciary Committee, though legislators have yet to announce a hearing date.

**The following legal experts, all based in California, asserted that AB 2223 would essentially legalize infanticide:**

AB 2223 is not only a pro-abortion bill – it removes all civil and criminal penalties for killing babies born alive under any circumstances. The bill expressly authorizes any person to facilitate late-term abortions and infanticide without legal repercussions. Life Legal condemns the use of euphemisms like “personal reproductive decisions” and ‘reproductive justice’ to justify and encourage the killing of babies in and outside the womb. – Attorney and Chief Executive Officer Alexandra Snyder of the Life Legal Defense Foundation

California lawmakers have crossed a red line by seeking to legitimize the killing of hours-old and even week-old infants. This is

not about expanding abortion rights; this is a degree of evil that the overwhelming majority of Americans, regardless of how they identify politically, cannot stomach. We will be working to defeat this insane and diabolical bill. – Attorney Matthew McReynolds with the Pacific Justice Institute

AB 2223 seeks to legalize the killing of babies in California after birth. Depending on how the term “perinatal” is interpreted by the courts, this bill legalizes the infanticide of children several weeks after their birth and possibly as late as their first birthday. If this barbaric bill is enacted, there will be no criminal or civil liability for the mother or those who assist her with killing her baby post-birth. – Attorney and President of the National Center for Law and Policy Dean Broyles

Under the guise of “reproductive health,” this bill seeks to decriminalize killing babies not only in the womb, but also even after the baby is born. This is the most extreme, anti-life bill in California’s history. It legalizes infanticide, plain and simple. – Attorney Nada Higuera with Tyler & Bursch, LLP

In California under AB 2223, former Philadelphia abortionist Kermit Gosnell, who murdered three infants born alive after botched abortions, could not be prosecuted. And incredibly, someone like Gosnell who helped a California mother kill her newborn after birth will actually have a cause of action to sue police for investigating the matter if AB 2223 becomes law. – Attorney Susan Arnall, Esq., Director of Outreach, Right to Life League.

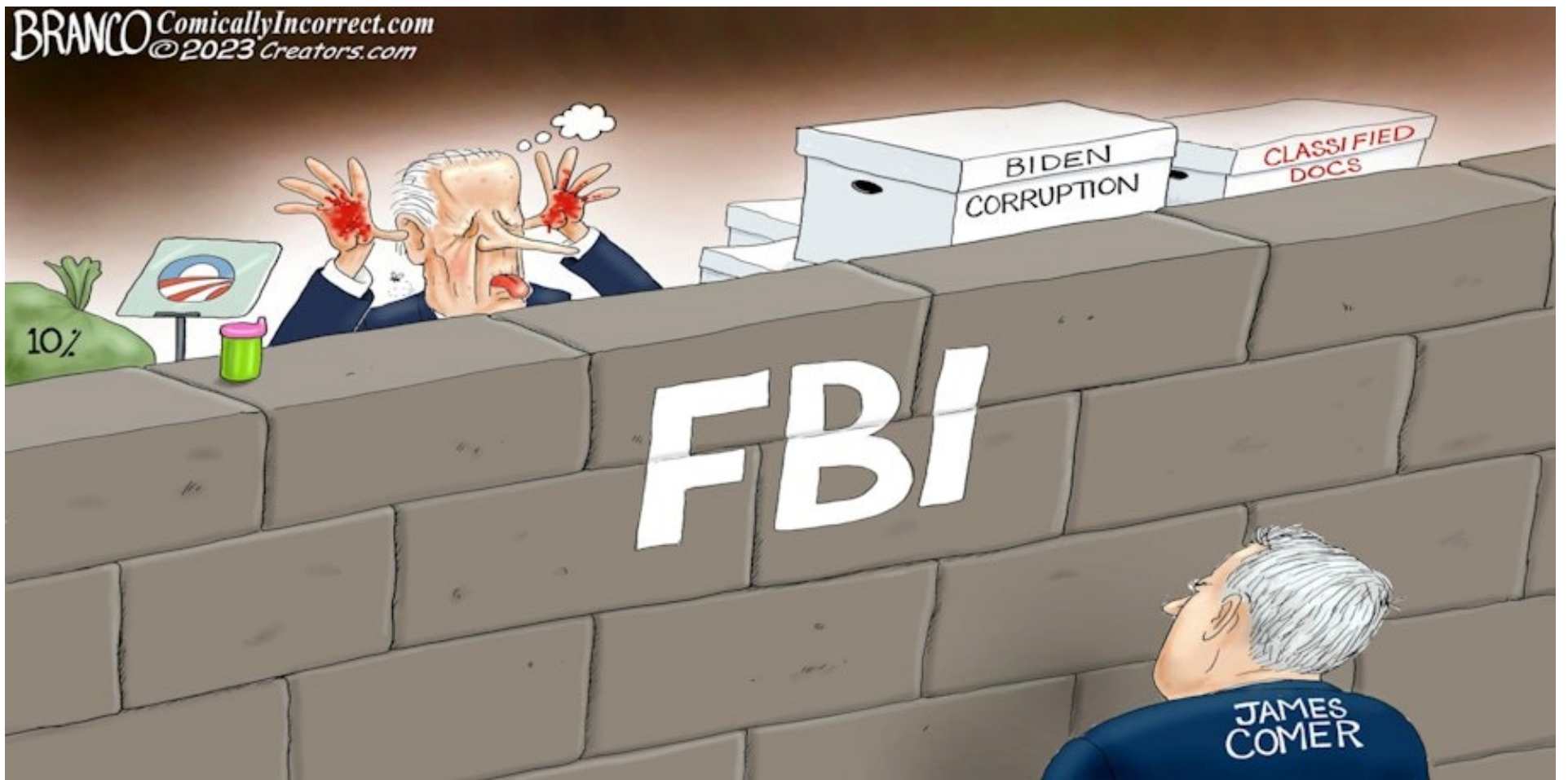

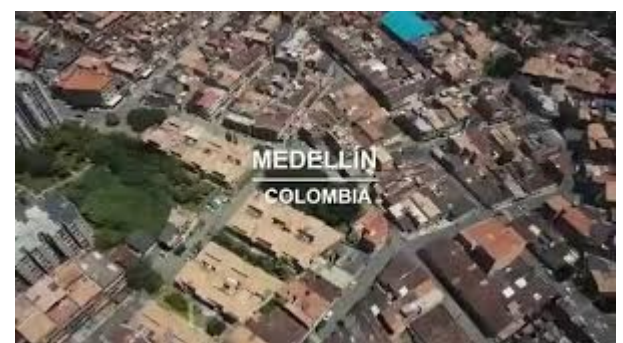

# TOUGH CULLING DECISIONS COME WITH DROUGHT, FORAGE SHORTAGES

COLUMBIA, Mo. – As dry weather and short pastures abound, Missouri cattle farmers face tough decisions — one way to match cows’ needs to available grass is to sell cows. First, give careful thought to which grass eaters go first, says Eric Bailey, University of Missouri Extension beef nutritionist. Under drought stress, identifying those cows becomes urgent.

The first cut is simple, Bailey says. Even the best herds have poor performers that need to be culled. Sell cows that are not pregnant or nursing. There is no feed for freeloaders when forage is short.

“Next, cull lactating cows with bad disposition, bad eyes, bad feet, or bad udders,” Bailey says. “Now’s time to remove cows with blemishes or poor-doing calves.”

Everyone has a cull list, he adds. “But they hesitate to act if a cow has a calf.”

Culling helps even in good years because culling poor cows improves overall herd averages.

The goal is to keep best genetics in the herd as long as feasible. Finally, lack of feed or water forces a move.

Downsizing goes beyond simply getting rid of bad cows, Bailey says.

Early weaning and selling calves can cut feed demand. That provides needed cash but can hurt annual income. Another strategy calls for splitting a herd into young and old females.

Sell one of the groups. Two- to 4-year-olds may have superior genetics, but older cows show success in the farm’s management.

Overall, culling depends on forage outlook for summer, fall, and winter feeding. Level of de-stocking can differ from farm to farm in the same neighborhood.

Rainfall patterns vary greatly. Bailey points out that in typical years, two-thirds of forage yield comes in spring growth. One-third comes in fall growth. That’s when winter stockpiling should happen. Missouri producers with cool-season grass always deal with summer slumps. Even if rains return, Bailey cautions, expect below-average fall forage yields. A big long-term problem will be winter feed, Bailey says.

Many farms could be facing severe de-stocking.

“Initially, consider a 25% cut,” he says. “If normal rains don’t return, consider another 25% later.”

Selling calves early in spite of revenue loss may take care of downsizing needs. A 50% cut ahead of fall forage growth may allow stockpiling pastures for winter grazing. That cuts feed buying but that depends on a return of rainfall.

The main advice is to plan downsizing, Bailey says. Management improvements, such as shorter breeding seasons, not year-round calving, can benefit.

For optimists, drought-induced culls can be beneficial as it forces some producers to tough management decisions.

“Producers who last longest in cow-calf businesses are not those who make the most money in good years. They are those who lose the least in bad years,” he says.

**The House Criminal Justice Committee is conducting a second hearing on HB 4474 and 4475, proposed Hate Crimes legislation with chilling consequences on First Amendment liberties.**

**The Senate Housing and Human Services Committee is taking up SB 348 and 349, "Conversion Therapy Laws" which ban therapists from helping someone return to the gender identity they were born with or embrace a Biblical view of themselves or their relationships. Again, the First Amendment and ethical consequences are staggering.**

**UPDATE: Hate Crimes Legislation in Michigan Legislature Week Targets 1st Amendment**



**House Bill No. 4474**, is a piece of proposed legislation that amends Michigan's Ethnic Intimidation law, MCL 750.147b, to expand its reach to criminalize hate speech. A companion proposal, **House Bill No. 4475** adds the behavior defined in HB 4474 to a list of felony crimes. Because the language of this legislation poses serious violation of the First Amendment's Free Speech and Free Exercise of Religion clauses and is clearly unconstitutional, the entire SLG team has been working hard to educate lawmakers on this important issue.

Last week, we presented written testimony, but we were not permitted to speak or given oral testimony. In fact, no member of the public was allowed to speak during public comment. Instead, three elected officials (A.G. Nessel, Rep. Arbit, and Prosecutor Worthy) filled the 35 minutes allowed for "discussion". It would seem that the committee chair was conducting a trial run of censoring speech and shutting down the voice of the people.

Because this legislation, as it is written, could impact nearly every liberty protected under the First Amendment, including freedom of religion, freedom of speech, and freedom of the press, this is arguably one of the most significant legislative hearings of our time. Instead of a slow, careful, thoughtful deliberative process that welcomes public participation and critical discussion to ensure that the very best policy is adopted, a one-sided discussion befitting dictatorial oligarchs ensued. Not a single legislator from either side even asked or considered whether or not the Constitution limited their power to set such policy.

However, Today at 9 AM, both bills are currently slated to be taken up a second time by the House Criminal Justice Committee. We are again seeking to testify, to defend against this insidious attack on Constitutional liberty and the First Amendment.

The Legislature could conduct a floor vote on this legislation as early as this week.

**Senate Bill 348** & **Senate Bill 349** comprise a set of bills proposing to **ban** "conversion therapy" that would help someone experiencing same-sex attraction or help someone "de-transition" and rediscover who God created them to be, and would **punish** any therapist or mental health professional who engages in such activity, including loss of their license. In other words, Christian therapists could be forced to choose between their faith and their career. Also, patients truly in need of help and seeking such counseling could be denied the care they so desperately need.

The House of Representatives took up similar legislation last week, and the Michigan Senate is holding its first hearing on these bills this morning at 9:30 a.m. Professor Wagner's testimony is being shared this morning.

## Michigan Supreme Court Hearing on Compelled Speech, Pronouns, & Religious Conscience

In March, The Michigan Supreme Court announced a new proposed policy which, authorizes parties and attorneys to provide “personal pronouns” to a court. It further requires judges, with no attention to the factual circumstance of the case before the court, “to use those personal pronouns when referring to or identifying the party or attorney.”

This rule poses numerous problems. First, there is the Religious Liberty and Free Speech concern; Christian judges would be forced to choose between upholding the teachings of their faith or keeping their career. Second, the policy violates other legal ethics standards that require judges and attorneys not to lie and make false statements. To force someone to refer to a person as something that they are not is simply wrong and constitutes unconstitutional compelled speech.

In April, Professor Wagner drafted a formal comment on behalf of the Great Lakes Justice Center and the Wagner Faith and Freedom Center, which was adopted as the official comment of the Religious Liberty Law Section of the State Bar of Michigan. Last week, Professor Wagner was able to participate in the hearing of the Court and offered oral testimony on the subject. You can read the complete testimony below:

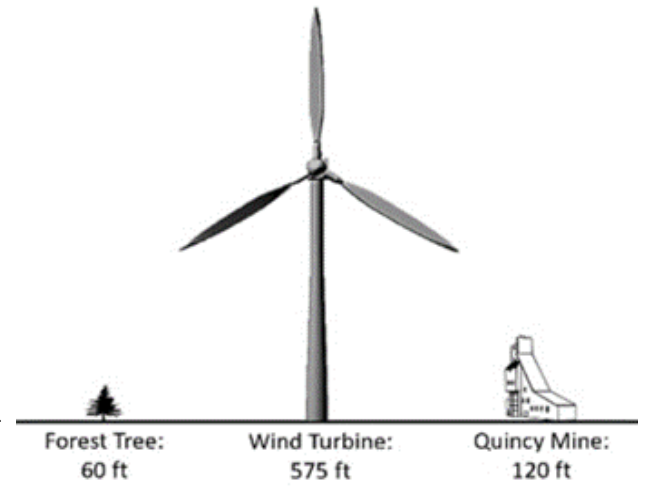

## Stone Fruit and Berry Galette

### INGREDIENTS

#### For dough

- 1 3/4 c. all-purpose flour, plus more for dusting
- 1/4 c. fine yellow stone-ground cornmeal
- 1/4 c. sugar
- 1 tsp. kosher salt
- 13 tbsp. cold unsalted butter, cubed
- 1/3 c. ice water

#### For filling and topping

- 1/2 c. sugar, plus more for sprinkling
- 1/4 c. apricot jam
- 2 tbsp. cornstarch
- 1 tbsp. fresh lemon juice
- 1 lb. peaches or nectarines, cut into thin wedges
- 1 c. mixed berries (blueberries, blackberries, raspberries, and small strawberries, halved)
- 1 tbsp. unsalted butter, cut into pieces
- 1 large egg, at room temperature



### DIRECTIONS

- Step 1 Make dough: In food processor, pulse flour, cornmeal, sugar, and salt to combine. Add butter and pulse until mixture resembles coarse crumbs with a few pea-size pieces remaining. Add ice water and pulse until large clumps form.
- Step 2 Transfer dough to sheet of plastic wrap and shape into large mound. Remove one-eighth of dough and shape into 1/2 -inch-thick disk. Shape remaining mound into 1-inch-thick disk. Wrap each disk tightly in plastic wrap and refrigerate until firm, at least 1 hour and up to 2 days.
- Step 3 Heat oven to 350°F with rack in lowest position. Unwrap large disk of dough and place on floured parchment paper. Using floured rolling pin, roll dough into 14-inch round. Slide dough with parchment onto rimless baking sheet and refrigerate.
- Step 4 Meanwhile, make filling: In large bowl, whisk together sugar, jam, cornstarch, and lemon juice until smooth. Add fruit and toss to coat completely.
- Step 5 Spoon fruit mixture evenly over dough round, leaving 1 1/2 -inch border. Fold up dough rim, pleating to enclose filling. Dot top with butter pieces.
- Step 6 In small bowl, whisk egg with 1 tablespoon water and brush over dough rim, reserving some egg wash for stars. Sprinkle rim evenly with sugar.
- Step 7 Bake galette on lowest oven rack and place rimmed baking sheet on oven floor to catch any drips. Bake until fruit mixture is bubbling and crust is golden brown, 50 to 55 minutes.

Step 8 Meanwhile, on floured surface using floured rolling pin, roll remaining disk of dough to 1/4 inch thick. Using floured star cookie cutters, cut out stars and transfer to parchment-lined baking sheet. Gather scraps, reroll, and cut. Freeze stars until firm, then brush with egg wash and sprinkle with sugar.

Step 9 Let galette cool on pan on wire rack. Meanwhile, bake stars until golden brown, 10 to 12 minutes.

Step 10 Carefully slide galette off parchment onto flat serving platter. Arrange stars on top. Serve warm or at room temp, with ice cream if desired.

## Absentee Ballots Discovered in Genesee County Storage Unit

**FLINT, Mich. (Michigan News Source)** – Nearly three hundred absentee ballots from the 2020 election were discovered in a Genesee County storage unit.

Rachel Stanke, the Thetford Township Supervisor, filed a Freedom of Information Act (FOIA) request and presented her discovery to the township board and residents.

Stanke first became aware that the missing ballots might exist in 2021. Initially, she alerted the Michigan Attorney General and the Secretary of State. She later contacted Michigan State Police (MSP) after receiving tips about missing ballots and the discovery of supposed “old township documents.”

A former township employee, whose name was redacted from the FOIA paperwork, had rented the storage unit and stowed the box of ballots there. According to Stanke, the employee did not realize what the box contained.

MSP recovered the ballots in August 2022. Their investigation is ongoing.

Stanke says the township hopes people will be able to trust that elections are run fairly and accurately. “That’s why I want to bring this to their attention,” she said. “And I want them to be able to make sure that their elections are run fairly and smoothly.”

Katie Hicks, who ran for Thetford Township Clerk in 2020 and lost by 19 votes, says she can’t trust future elections. “Now this is all coming out and ... I’m kind of happy that it’s coming out because the election is right around the corner again,” Hicks said. “And it concerns me that this will take place again for 2024.”

The *International Health Regulations (IHR) 2005*, which finds its roots in the International Sanitary Conference 1851, is a legal instrument ratified by 196 member countries of the World Health Organisation (WHO), endeavours to: 'Prevent, protect against, control, and provide a public health response to the international spread of disease.' While its main objective is laudable – concerns arise about the potential erosion of human rights, dignity, and freedoms in its execution – this article provides a critique of these concerns, focusing on its ability to potentially censor information, which can negatively impact the fundamental principles of transparency, accountability, and inclusivity. By no means does this critique purport to be a conclusive and/or exhaustive discourse on the ideological underpinning socially constructing a perpetual state of global emergency, but it does represent the threat to human rights, dignity, and access to timely healthcare without the intervention of non-elected international bureaucrats with little to no accountability of the host nations.

IHR 2005 proposes to grant significant powers to WHO, that could, depending on which version is implemented, allow the institution to take drastic measures to control public health emergencies of international concern (PHEIC). It would have to be ratified by government. If it proceeds, these measures may include restrictions on travel and trade, monitoring individuals, or enforcing quarantines. Such actions, though intended for public health protection, may inadvertently impinge on the human rights of individuals and communities. At first blush, one may indeed be captivated by the emotional spell of idealistic government/state-controlled healthcare, as we had seen during Covid. But more striking was the lack of protections afforded to citizens by those institutions such as the human/civil rights lobbies, selecting instead to follow the Government line. It is not our intention here to reflect on anything more than the failure of institutions to protect the fundamental rights of citizens all over the world.

Mistakes that permitted unelected health bureaucrats to wave their emergency powers infringing fundamental human rights such as:

freedom to earn a living;  
freedom of movement;  
freedom of association;  
freedom to participate in society;  
freedom to get married;  
freedom of religion;

freedom of education, and so on. These 'mistakes' went on for a considerable length of time – three years, in fact. Although the draconian measures are being slammed by some courageous lawyers, the medical fraternity, some media personalities, members of the community, emergency service workers, and former political leaders, the key institutions, and non-elected bureaucrats appear to be pursuing a monomaniacal extension of what we know is a controversial poli-

cy far exceeding policies experienced during the second world war in Australia.

Although some commentators suggest Covid is largely over, this cannot be further from the truth as many emergency service workers, airline employees, local council employees, and healthcare workers still face draconian occupational health and safety policies if they do not 'choose' to get a vaccine that has demonstrably failed to meet the highly publicised endpoints. Yes it's time they admit failure. But now we face an even greater danger than the pandemic itself – a global threat under the guise of international collaboration and efficient sharing in future crises.

The proposed amendments to the IHR raise serious questions with regards to state sovereignty and the future of governance. They also encourage the stifling of dissent from the official line and wider panopticon-styled surveillance via a range of (digital) certificates, CCTV, facial recognition, digital currency, online monitoring, and censorship, controversies that were all accepted by, civil liberties and human rights organisations, traditionally the gatekeepers and protectors of human and civil rights.

Thousands of legal challenges all over the world, have been unsuccessful, but the lockstep approach appears to dovetail into the very concerns we are raising in this article, that is, no accountability at any level.

Further, the IHR must be viewed in conjunction with the WHO pandemic treaty. The *WHO Pandemic Treaty/ Accord Zero Draft* is a separate and complementary legally binding treaty which, if adopted, would:

- Cede undue authority over global public health to the WHO;
- Create a new cost-intensive, undemocratic supra-national bureaucracy;
- Impose an ideological framework called 'One Health' for matters of global health, including support for gain-of-function research with pandemic potential pathogens (Article 9.8) and also encouraging a globally coordinated effort to counter public dissent (Article 17);
- Create 'platforms that promote findable, accessible, inter-operable and reusable data [on hazardous pathogens] available to all Parties' – which would include dictatorships and state sponsors of terrorism, raising security concerns.

The IHR in effect overrides a country's domestic law (after being ratified), and whilst

those pushing for the amendments may attempt to persuade otherwise, it is unlikely to be a point of discussion if passed (ergo Covid era 2.0) ignorance and control will permeate without equitable or objective recourse. This means that if the Australian government agrees to the amendments being put forward by the WHO, Australians, and other nations could be under the control of the WHO director-general during health emergencies. Thus, any legal challenges run the risk of acceding authority to international entities prompting further consideration of Australia's obligation to its own Constitutional protections.

As many may recall, NSW, Australia was never under a State of emergency, but yet locked down, introduced harsh measures, prevented citizens accessing timely healthcare, women denied access to mammograms, children denied access to education, small and medium business were devastated, and people unable to see doctors in person if they were not vaccinated.

The resulting juxtaposition means that if the WHO Director-General under global emergency powers orders vaccine mandates, shut-downs, digital passports etc., the Australian government would be compelled to comply, as we seen with former Prime Minister Scott Morrison closing down borders and issuing quasi-mandates for all federal workers.

But as we know, a choice involves a person choosing whether they want to eat a hamburger or salad, not 'you will become a participant in a global clinical trial and if you do not agree, you will lose your job, cannot leave your home, travel internationally, you will be stigmatised, discriminated against and ridiculed publicly for making that choice'. Let's face it, this was not a choice, this was straight out of the playbook of oppressive dictatorships where those who did not agree were purged from institutions such as state and federal police, paramedics, nurses, firefighters, and others. For example, the police were fired for misconduct, usually a charge reserved for corruption and serious wrongdoing, not because a person 'chose' to exercise their right to bodily autonomy. [We knew then](#), as we know now, the Covid virus was never as deadly as claimed and whilst people did sadly succumb to this variation of the flu, people died with, not died because of Covid.

Firstly, let us examine the language of the IHR 2005 as it seems to unduly emphasise state security over human security. While Article 3 explicitly requires respect for 'dignity, human rights, and fundamental freedoms of persons', the state-centred approach often creates a problematic trade-off between health security and individual rights. Imposing quarantines or travel restrictions, as we've seen during the Covid pandemic, can lead to social isolation, stigma, and violation of freedom of movement, thereby undermining human dignity and the right to access timely healthcare.

Secondly, the IHR 2005 overlooks the need for individual consent in many cases, a cornerstone of medical ethics, overlooked and ignored by medical associations, doctors and bureaucrats all purportedly acting in 'lock-step'. Under emergency circumstances, there's a risk that people may be subjected to medical examination, vaccination, or treatment without their informed consent, raising serious human rights and ethical concerns, again matters that were ignored during the Covid era.

Moreover, the regulations do not provide sufficient safeguards to ensure the right to privacy and protection of personal data, another critical human rights concern. Disease surveillance data collection, while essential in tackling disease spread, often entails processing sensitive personal data, potentially leading to privacy violations. The rules surrounding data collection, processing, and sharing under the IHR 2005 are not explicit enough to prevent possible misuse. All of these concerns were neglected by the human rights lobby and institutions traditionally duty bound to protect.

Concerning the potential to censor information, Article 11 of the IHR 2005 allows WHO to consider unofficial reports of public health risks. While this mechanism can facilitate early warning and rapid response, it raises concerns over the credibility and confidentiality of information. WHO's dis-

cretion to manage and disclose information might inadvertently lead to the suppression or alteration of information.

Although widely touted by the pseudo pharmaceutical salespeople such as government ministers, media, sports stars, bureaucrats, institutions, and employers as meeting these endpoints and failing, the switch in narrative orchestrated by the former government has moved towards preventing 'serious disease'.

Thus Article 11 may be an enabler of further self-aggrandising conduct where unofficial reports become the backbone of institutionalised science used to lockdown citizens. One may be forgiven to think this was a fable, but it is written in black and white, and everyone has lived this over the past three years. Whether you believe this or not is your decision.

The IHR 2005 lacks explicit provisions that protect whistle-blowers and health professionals who might provide the source of this unofficial information, particularly if the information is misleading or deceptive. This shortcoming undermines the principle of transparency and could create a chilling effect on free speech, restricting open discussions about public health emergencies and place governments and international bureaucracies as the dominant treatment provider of individual health.

In addition, the IHR 2005 does not adequately address the issue of equity. It underestimates the socio-economic impacts of health measures, which often disproportionately affect vulnerable populations, again, the same people who were ignored are now being asked to trust in a system that coerced their compliance under the semblance of a marketing campaign suggesting they had a 'choice'. Policies should not further exacerbate existing inequalities, and emergency health measures should take into account the socio-economic context and ensure that the rights and needs of

marginalised and vulnerable groups are met. It is important to note, that the wording, harks back language commonly found in writings relating Marxism, communism, and socialism. 'You will own nothing and be happy.'

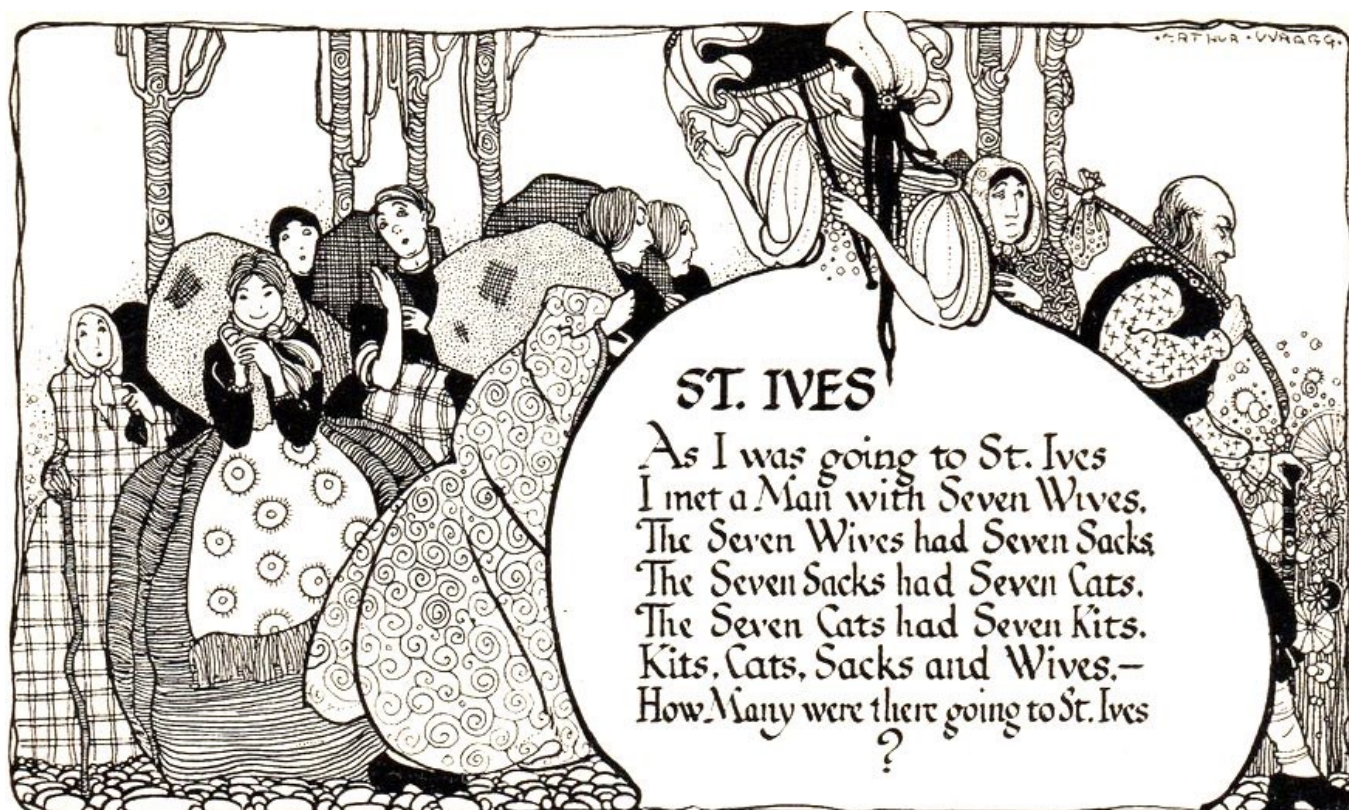
The authority of WHO in declaring PHEIC, as stipulated in the IHR 2005, creates a centralised decision-making process, which could undermine the democratic principles of inclusivity and participation. It is essential to involve the affected communities and consider their perspectives in decision-making processes regarding public health emergencies.

In conclusion, while the IHR 2005 plays a crucial role in managing global health security, it raises serious concerns about the potential erosion of human rights, dignity, and freedoms. The authority to censor information could undermine transparency and free speech, while the regulations' state-centred approach and lack of emphasis and direction points towards a totalitarian centralised control that can only be compared to a panopticon-styled state of perpetual surveillance and social control. Where the traditional institutions of power have otherwise abandoned the citizens and their rights, we must ask ourselves, when something goes wrong, you will need to complain to Caesar, about Caesar and hope that Caesar will take your side. I cannot answer this, but if the past three years can point towards an answer, we can only assume this endpoint will not be met.

## The Real State of Emergency

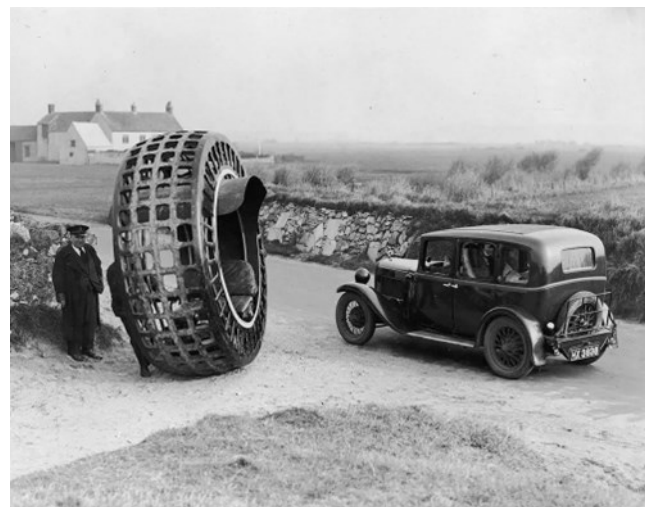

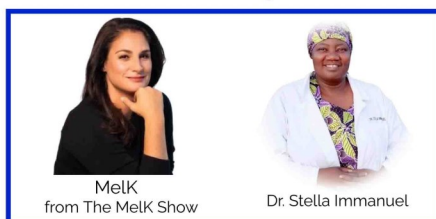

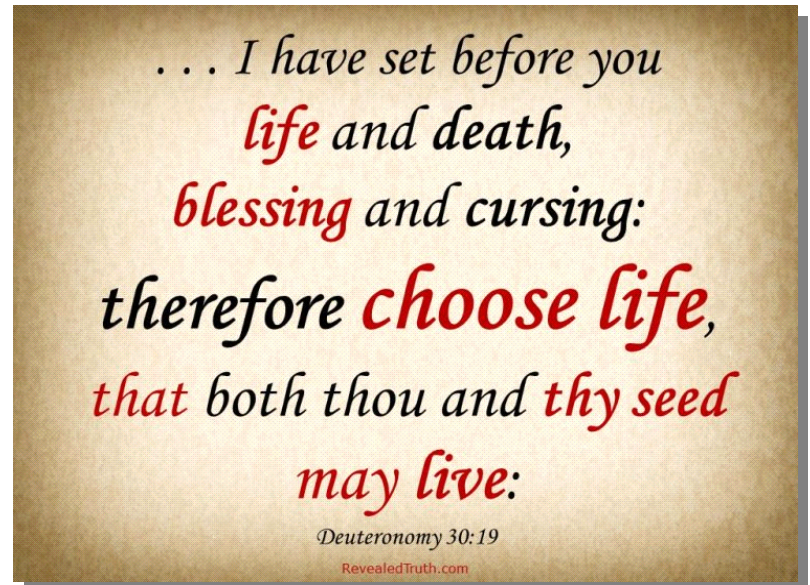

**National Popular Vote bill advances to Michigan House – Michigan Capitol Confidential**

IF MICHIGAN THREW IN ITS 15 ELECTORAL VOTES, INTER-STATE SCHEME WOULD HAVE 220 OF 270 VOTES NEEDED TO TAKE EFFECT

A committee of Michigan lawmakers voted Tuesday to enroll the state in the National Popular Vote Interstate Compact. By a vote of 6-2, the House Elections Committee approved House Bill 4156. The compact will take effect when signed on by states with a combined 270 or more electoral votes, enough to elect the president. When [Minnesota](#) joined the compact last month, it reached 205 electoral votes. With Michigan’s 15, it would reach 220. Currently, the winner of the Michigan vote tally gets Michigan’s 15 electoral votes. That would change under the National Popular Vote plan, as a candidate could lose Michigan but still be awarded its votes — all based on a noncertified result.

**Read it for yourself: House Bill 4156 of 2023: The National Popular Vote bill**

There is no official count of a national popular vote, nor is there any federal agency authorized to produce one. This bill empowers secretaries of state in National Popular Vote states not only to read their own election results but to determine the “popular vote” winner among 50 states.

The relevant portion of the bill reads:

Prior to the time set by law for the meeting and voting by the presidential electors, the chief election official of each member state shall determine the number of votes for each presidential slate in each State of the United States and in the District of Columbia in which votes have been cast in a statewide popular election and shall add such votes together to produce a "national popular vote total" for each presidential slate.

The words “shall determine,” and the lack of a certified result, mean the judgments of secretaries of state would be subjective. Secretaries of state would choose the president.

The candidate they deem the winner would get all 270-plus electoral votes from compact states. A plan that presents itself as an alternative to the winner-takes-all system would only accelerate it. With a victory margin of one vote, a candidate would be awarded a bloc of 270 votes, regardless of the vote tallies in each state.

As the House Fiscal Agency analysis notes, only in the event of a tie — a nationwide tie — would the Michigan vote tally be the deciding factor.

The analysis reads:

In the case of a tie for the national popular vote winner, each member state would appoint electors pledged to the candidate that won the popular vote in that state. (This is the “winner takes all” system currently used by most states).

Even the National Popular Vote initiative affirms the value of a winner-take-all system by reverting to it in the event of a tie.

The Mackinac Center has [testified](#) against House Bill 4156.

**Michigan GOP chair, others fined \$58K for ‘frivolous’ election fraud suit**

Michigan Republican Party chair Kristina Karamo and eight others have been sanctioned by a Wayne County judge, ordered to pay more than \$58,000 over their lawsuit that alleged, without evidence, there was widespread voter fraud in Detroit days before the November 2022 election. “Plaintiffs’ complaint was rife with speculation, an absence of facts and a lack of understanding of Michigan election statutes and Detroit absentee ballot procedures,” Third Circuit Court Judge Timothy Kenny wrote in the Monday order. He ruled their lawsuit had been “devoid of legal merit” and “frivolous,” ordering the plaintiffs in the suit and their attorneys to together pay \$58,459 in attorney fees and costs to the office of Detroit City Clerk Janice Winfrey, who was named as the defendant in the lawsuit. Attorney David Fink, who represented the city of Detroit in the suit, said in a statement, “we appreciate Judge Kenny’s hard work addressing this frivolous lawsuit, and we are grateful that he returned from retirement to consider our motion for sanctions. When a baseless lawsuit is filed to interfere with the good work done by Detroit’s city clerk, there should be consequences.” The case was first heard just eight days before Election Day and asked the court to discard all the absentee ballots cast in Detroit up until that point, and to require all voters in that city to either vote in person or get ballots from the clerk’s office themselves — dramatically chang-

ing the availability of absentee ballots in the city. Kenny reiterated Monday the suit contradicted the absentee voting protections included in Michigan’s Constitution. “Plaintiffs merely threw out the allegation of ‘corruption in Detroit’ as the reason for disregarding the Michigan Constitution in this state’s largest city,” he wrote. At a press conference with reporters after the first hearing, Karamo and her attorneys **refused to say whether they had any evidence** ballots were being cast illegally despite overtly claiming it had been happening in the lawsuit. By the day before Election Day, Kenny had thrown out the suit, ruling the plaintiffs failed to produce “any shred of evidence” and what they were asking would “egregiously harm” eligible voters. **Read more: Judge ends Karamo’s ‘intolerable’ lawsuit to stop Detroit absentee ballots** At the time Karamo had been the Republican nominee vying to oversee Michigan’s elections as secretary of state, but later lost to incumbent Democrat Jocelyn Benson by more than 14 percentage points. Karamo never conceded her defeat, claiming to have no faith in the veracity of the result. Three months later, Karamo was elected to lead the Michigan Republican Party by 58% of its delegates with a pledge to reshape the party from ground up. **Related: Conspiracies and a Holocaust meme mark the dawn of Karamo’s Michigan Republican Party**

That includes attorneys Daniel Hartman, who has since been referred to as the party’s in-house lawyer, and Alexandria Taylor, who recently launched a campaign for U.S. Senate. Hartman has frequently represented election conspiracy theorists in Michigan, but none of the numerous suits he’s filed have succeeded. In a filing trying to prevent sanctions, the attorneys said their lawsuit had been “seeking truth” and attempted to rehash their arguments, arguing procedural restrictions had prevented them from fully making their case. Kenny had particular derision for their motion to disqualify every judge in the third circuit in one fell swoop, which he also ruled was frivolous Monday. A spokesperson for the Michigan Republican Party contacted Tuesday was unaware of the sanctions and did not return a request for comment. The party, which had different leadership last year, had distanced itself from the lawsuit at the time.

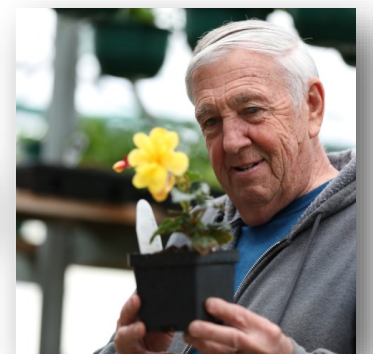

# Instagram Connects Vast Pedophile Network **WSJ**

The Meta unit's systems for fostering communities have guided users to child-sex content; company says it is improving internal controls

Instagram, the popular social-media site owned by Meta Platforms, helps connect and promote a vast network of accounts openly devoted to the commission and purchase of underage-sex content, according to investigations by The Wall Street Journal and researchers at Stanford University and the University of Massachusetts Amherst. Pedophiles have long used the internet, but unlike the forums and file-transfer services that cater to people who have interest in illicit content, Instagram doesn't merely host these activities. Its algorithms promote them. Instagram connects pedophiles and guides them to content sellers via recommendation systems that excel at linking those who share niche interests, the Journal and the academic researchers found.

Though out of sight for most on the platform, the sexualized accounts on Instagram are brazen about their interest. The researchers found that Instagram enabled people to search explicit hashtags such as #pedowhore and #preteensex and connected them to accounts that used the terms to advertise child-sex material for sale. Such accounts often claim to be run by the children themselves and use overtly sexual handles incorporating words such as "little slut for you." Instagram accounts offering to sell illicit sex material generally don't publish it openly, instead posting "menus" of content. Certain accounts invite buyers to commission specific acts. Some menus include prices for videos of children harming themselves and "imagery of the minor performing sexual acts with animals," researchers at the Stanford Internet Observatory found. At the right price, children are available for in-person "meet ups."

The promotion of underage-sex content violates rules established by Meta as well as federal law. In response to questions from the Journal, Meta acknowledged problems within its enforcement operations and said it has set up an internal task force to address the issues raised. "Child exploitation is a horrific crime," the company said, adding, "We're continuously investigating ways to actively defend against this behavior."

Meta said it has in the past two years taken down 27 pedophile networks and is planning more removals. Since receiving the Journal queries, the platform said it has blocked thousands of hashtags that sexualize children, some with millions of posts, and restricted its systems from recommending users search for terms known to be associated with sex abuse. It said it is also working on preventing its systems from recommending that potentially pedophilic adults connect with one another or interact with one another's content. Alex Stamos, the head of the Stanford Internet Observatory and Meta's chief security officer until 2018, said that getting even obvious abuse under control would likely take a sustained effort.

"That a team of three academics with limited access could find such a huge network should set off alarms at Meta," he said, noting that the company has far more effective tools to map its pedophile network than outsiders do. "I hope the company reinvests in human investigators," he added. Technical and legal hurdles make determining the full scale of the network hard for anyone outside Meta to measure precisely.

Because the laws around child-sex content are extremely broad, investigating even the open promotion of it on a public platform is legally sensitive.

In its reporting, the Journal consulted with academic experts on online child safety. Stanford's Internet Observatory, a division of the universi-

ty's Cyber Policy Center focused on social-media abuse, produced an independent quantitative analysis of the Instagram features that help users connect and find content.

The Journal also approached UMass's Rescue Lab, which evaluated how pedophiles on Instagram fit into the larger ecosystem of online child exploitation. Using different methods, both entities were able to quickly identify large-scale communities promoting criminal sex abuse.

Test accounts set up by researchers that viewed a single account in the network were immediately hit with "suggested for you" recommendations of purported child-sex-content sellers and buyers, as well as accounts linking to off-platform content trading sites. Following just a handful of these recommendations was enough to flood a test account with content that sexualizes children.

The Stanford Internet Observatory used hashtags associated with underage sex to find 405 sellers of what researchers labeled "self-generated" child-sex material—or accounts purportedly run by children themselves, some saying they were as young as 12. According to data gathered via Maltego, a network mapping software, 112 of those seller accounts collectively had 22,000 unique followers.

Underage-sex-content creators and buyers are just a corner of a larger ecosystem devoted to sexualized child content. Other accounts in the pedophile community on Instagram aggregate pro-pedophilia memes, or discuss their access to children. Current and former Meta employees who have worked on Instagram child-safety initiatives estimate the number of accounts that exist primarily to follow such content is in the high hundreds of thousands, if not millions.

A Meta spokesman said the company actively seeks to remove such users, taking down 490,000 accounts for violating its child safety policies in January alone.

"Instagram is an on ramp to places on the internet where there's more explicit child sexual abuse," said Brian Levine, director of the UMass Rescue Lab, which researches online child victimization and builds forensic tools to combat it. Levine is an author of a 2022 report for the National Institute of Justice, the Justice Department's research arm, on internet child exploitation.

Instagram, estimated to have more than 1.3 billion users, is especially popular with teens. The Stanford researchers found some similar sexually exploitative activity on other, smaller social platforms, but said they found that the problem on Instagram is particularly severe. "The most important platform for these networks of buyers and sellers seems to be Instagram," they wrote in a report slated for release on June 7. Instagram said that its internal statistics show that users see child exploitation in less than one in 10 thousand posts viewed.

The effort by social-media platforms and law enforcement to fight the spread of child pornography online centers largely on hunting for confirmed images and videos, known as child sexual abuse material, or CSAM, which already are known to be in circulation. The National Center for Missing & Exploited Children, a U.S. nonprofit organization that works with law enforcement, maintains a database of digital fingerprints for such images and videos and a platform for sharing such data among internet companies.

Internet company algorithms check the digital fingerprints of images posted on their platforms against that list, and report back to the center when they detect them, as U.S. federal law requires. In 2022, the center received 31.9 million

reports of child pornography, mostly from internet companies—up 47% from two years earlier.

Meta, with more than 3 billion users across its apps, which include Instagram, Facebook and WhatsApp, is able to detect these types of known images if they aren't encrypted. Meta accounted for 85% of the child pornography reports filed to the center, including some 5 million from Instagram. Meta's automated screening for existing child exploitation content can't detect new images or efforts to advertise their sale. Preventing and detecting such activity requires not just reviewing user reports but tracking and disrupting pedophile networks, say current and former staffers as well as the Stanford researchers. The goal is to make it difficult for such users to connect with each other, find content and recruit victims.

Such work is vital because law-enforcement agencies lack the resources to investigate more than a tiny fraction of the tips NCMEC receives, said Levine of UMass. That means the platforms have primary responsibility to prevent a community from forming and normalizing child sexual abuse.

Meta has struggled with these efforts more than other platforms both because of weak enforcement and design features that promote content discovery of legal as well as illicit material, Stanford found.

The Stanford team found 128 accounts offering to sell child-sex-abuse material on Twitter, less than a third the number they found on Instagram, which has a far larger overall user base than Twitter. Twitter didn't recommend such accounts to the same degree as Instagram, and it took them down far more quickly, the team found.

Among other platforms popular with young people, Snapchat is used mainly for its direct messaging, so it doesn't help create networks. And TikTok's platform is one where "this type of content does not appear to proliferate," the Stanford report said.

Twitter didn't respond to requests for comment. TikTok and Snapchat declined to comment.

David Thiel, chief technologist at the Stanford Internet Observatory, said, "Instagram's problem comes down to content-discovery features, the ways topics are recommended and how much the platform relies on search and links between accounts." Thiel, who previously worked at Meta on security and safety issues, added, "You have to put guardrails in place for something that growth-intensive to still be nominally safe, and Instagram hasn't."

The platform has struggled to oversee a basic technology: keywords. Hashtags are a central part of content discovery on Instagram, allowing users to tag and find posts of interest to a particular community—from broad topics such as #fashion or #nba to narrower ones such as #embroidery or #spelunking.
