Even before the colonies were America, there had been land taxes. Post war the federal government levied a national tax on land in 1798, 1814, 1815, 1816, and 1861.

The difference is today, we are bombarded with a tax at every turn. Everything is taxed and most, multiple times. We need to break this cycle of robbing the American people of wealth and transferring it to a corrupt political elite who pockets most, launder to their friends and prop up their pet projects while throwing tidbits to their voting base.

Presently, everyone is allowed to vote on tax issues whether they own

Jim is also the editor of the Patriot Press. He is a great writer, educator, trainer, and conservative activist. I'm very proud to call him my friend.

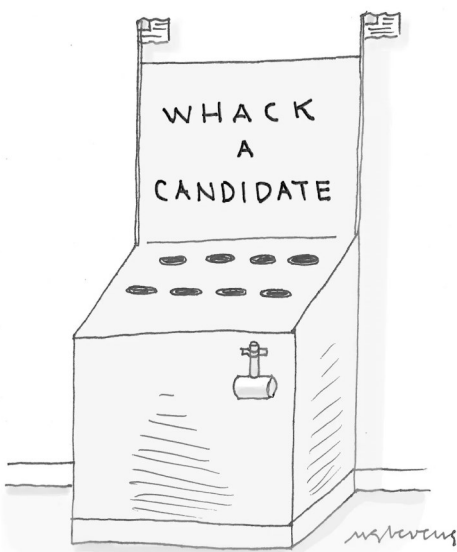

Next month we will have Joanna Martin, a retired constitutional educator and attorney as our speaker. She will be speaking about the dangers of a Constitutional Convention.

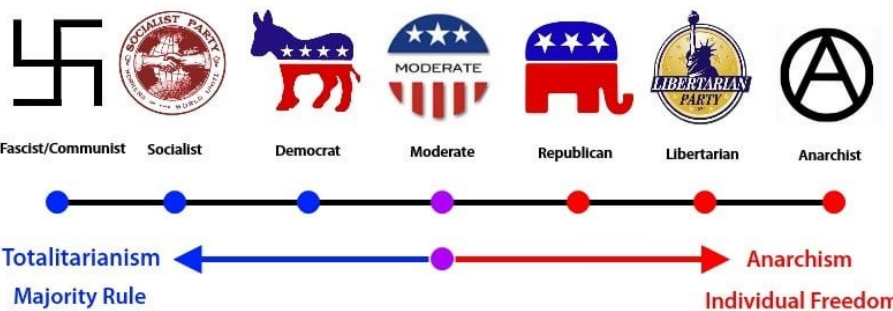

Biden demands media buddies fight his impeachment probe **Says Republican 'lies' should 'set off alarm bells for news organizations'**

No sooner had House Speaker Kevin McCarthy announced an inquiry into whether Joe Biden should be impeached, based on evidence Congress already has obtained about alleged corruption, than the White House announced it wanted legacy media corporations to fight back against the review of the evidence.

A report from the Daily Mail revealed Biden's White House plans to send letters to major news organizations including CNN and the Associated Press "demanding they probe the 'lies' of the House GOP's impeachment inquiry."

The AP, even before the letter officially was dispatched, seemed on board, with its claims that the Republicans have been "aggressively" investigating Biden and have been making claims "without evidence."

In fact, McCarthy in a letter to House members outlined extensive evidence that already is in hand.

That includes that "President Biden lied to the American people about knowledge of his family's foreign business dealings," the \$20 million in payments "directed to Biden family members," that the family has generated more than 150 "suspicious activity" reports from banks, the FBI document alleg-

ing a \$10 million bribe to the Bidens, and the entire Burisma scandal, where Joe Biden, as vice president, ordered the Ukrainian government to fire a prosecutor looking into corruption at a company that was paying Hunter Biden millions of dollars.

The Daily Mail report said Ian Sams, a special assistant to the president, "penned a letter to both conservative and liberal-leaning outlets, slated to be distributed Wednesday in an apparent attempt to influence their coverage."

Targeted are CNN, New York Times, AP, and Fox News.

The report explained Sams wrote, "It's time for the media to ramp up its scrutiny of House Republicans for opening an impeachment inquiry based on lies."

He continued that the inquiry should "set off alarm bells for news organizations."

Democrats, when Nancy Pelosi was House speaker, in fact launched two impeach-and-remove campaigns against President Trump, both unsuccessful. One was based on a phone call he had raising questions about Biden family corruption in Ukraine, and the other about his comments regarding the 2020 election faults.

The second was based on no evidence submitted to Congress at all, no witnesses, and no testimony.

In response, the Daily Mail reported, journalist Matthew Keys tweeted: "This is not okay. The White House should not be encouraging, influencing or interfering in the editorial strategies of America's newsrooms, including CNN and the New York Times."

He continued, "The media is the problem. The bigger problem, at the moment, is what the White House is apparently planning to do, if Oliver Darcy's reporting is correct (I have no doubt it is). And that is the kind of short-sighted move that gets Donald Trump re-elected next year."

He was referring to CNN's Oliver Darcy, who first broke news of the letter.

The report explained Sams described the Republican Party as including "every day liars and hucksters" who "peddle disinformation and lies everywhere from Facebook to Fox."

Sams just hours earlier had claimed on social media there's "no evidence" of wrongdoing by Biden.

McCarthy announced the inquiry, confirming, "House Republicans have uncovered serious and credible allegations into President Biden's conduct. Taken together these allegations paint a picture of a culture of corruption."

Summoning violence: Why using the 14th Amendment against Trump is a really bad idea

Of all of the legal challenges former President Donald Trump faces, perhaps the most formidable is the risk of being struck from the ballot in a number of states because his presence would, in the opinion of a handful of unwise and dangerous officials, contravene Section 3 of the 14th Amendment.

That section states in the relevant part: "No person shall ... hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States ... to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability."

There are those — including some Republicans — who argue that the provisions of Section 3 disqualify Mr. Trump from being on the ballot in 2024.

Indeed, William Baude, a professor at the University of Chicago and a former clerk for U.S. Chief Justice John Roberts, and Michael Stokes Paulsen, a contributor of the Federalist Society, made just such an argument in the *Pennsylvania Law Review*. Retired federal Judge J. Michael Luttig — a lifelong conservative — and liberal Harvard professor Laurence Tribe echoed the argument in a recent article in *The Atlantic*.

Leaving aside practical considerations for a moment, neither Mr. Trump nor his numerous supporters have even been charged with insurrection, let alone found guilty of it. This is even though the Justice Department and various prosecutors across the nation have had ample opportunity to bring such charges.

So, legally, it seems unclear how anyone can credibly claim that Mr. Trump is guilty of insurrection or of giving aid or comfort to the enemies of the United States, which would be treason. Even at this late date in the republic, one is presumed innocent until proven guilty in a court of law.

Let's consider the practical considerations of disallowing Mr. Trump's presence on state ballots for reasons unrelated to petitions or other metrics for getting on a ballot.

Ballot disqualifications would be the ultimate attack on democracy. The decisions to include or disqualify Mr. Trump would be made not by a jury after a trial but rather by secretaries of state in the various states, most of whom are partisan elected officials.

It is entirely possible that the Democratic secretaries of state in Arizona, Nevada or North Carolina could simply remove Mr. Trump from the ballot without a hearing or any finding — other than their own belief — that the former president was in violation of Section 3. The courts could possibly undo such a decision, but only after extensive and time-consuming legal processes that may not be resolved until after the election.

Consider that possibility for a moment. A candidate who had not been found guilty of anything in court could be disqualified from the ballot not because of any defect in petitions or other requirements associated with getting on the ballot but merely because state officers disapproved of his candidacy.

With that as precedent, the notion that the United States is a republic characterized by popular sovereignty and reliant on the will of the people for its legitimacy would be finished.

Of more immediate import, such an election would be illegitimate and, quite probably, lead to mass civil disobedience and perhaps widespread violence. You can't disenfranchise 80 million people — many of whom are armed and already convinced that the legal and economic systems are working energetically against them — and expect them not to resist.

Those who are advocating this Section 3 disqualification strategy need to think carefully about where their preferred course of action would take us. Apart from its lack of grounding in anything resembling American law, it would make the United States ungovernable for years.

10. Free education for all children in public schools. Abolition of children's factory labor in its present form. Combination of education with industrial production, etc

Butternut Squash and Turmeric Soup

Ingredients

- 2 **tbsp.** plus 1 **tsp.** extra virgin olive oil
- 1 large onion, roughly chopped
- 1 **tbsp.** vegetable bouillon base (we used Better Than Bouillon)

- 1 medium butternut squash (about 2 1/2 lbs.), peeled (seeds reserved), cut into 1" pieces
- 2 medium carrots, cut into 1" pieces
- 2 1/4 **tsp.** turmeric
- 2 1/4 **tsp.** black pepper
- 2 **tbsp.** light coconut milk

DIRECTIONS

- Step 1 Heat 2 tablespoons oil in a large Dutch oven over medium heat. Add the onion and cook, covered, stirring occasionally, until tender, 6 to 8 minutes.
- Step 2 Meanwhile, combine the bouillon base with 6 cups boiling water, stirring to dissolve.
- Step 3 Add the squash, carrots, 2 teaspoon turmeric and 1/2 teaspoon pepper to the Dutch oven and cook, stirring, 1 minute. Add the broth, bring to a boil, then reduce heat and simmer until the vegetables are very tender, 18 to 22 minutes.
- Step 4 Meanwhile, heat oven to 375°F. Toss the reserved seeds (about 1/4 cup with the remaining teaspoon of oil, 1/4 teaspoon turmeric and 1/4 teaspoon pepper and roast until golden brown and crispy, 9 to 11 minutes.
- Step 5 Using an immersion blender (or standard blender, working in batches) purée the soup. Sprinkle with the toasted seeds and swirl in the coconut milk.

52 U.S. Code § 20511 - Criminal penalties

A person, including an election official, who in any election for Federal office—

(1) knowingly and willfully intimidates, threatens, or coerces, or attempts to intimidate, threaten, or coerce, any person for—

- (A) registering to vote, or voting, or attempting to register or vote;
- (B) urging or aiding any person to register to vote, to vote, or to attempt to register or vote; or
- (C) exercising any right under this chapter; or

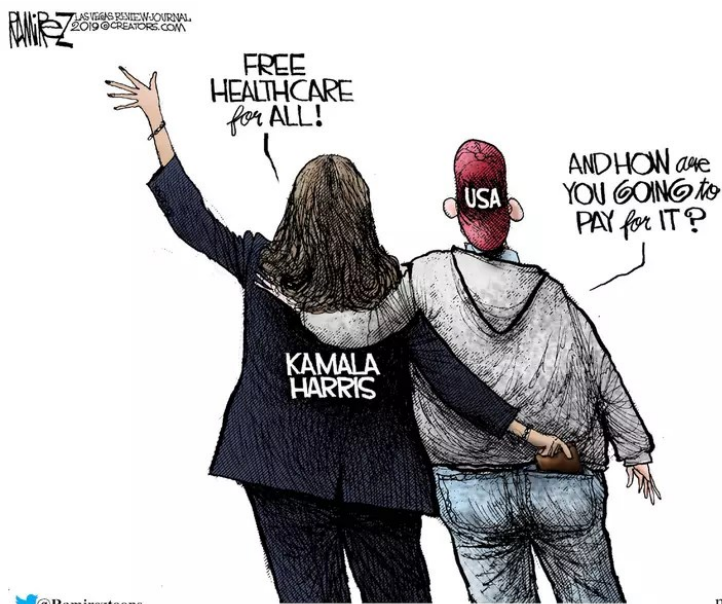
(2) knowingly and willfully deprives, defrauds, or attempts to deprive or defraud the residents of a State of a fair and impartially conducted election process, by—

- (A) the procurement or submission of voter registration applications that are known by the person to be materially false, fictitious, or fraudulent under the laws of the State in which the election is held; or
- (B) the procurement, casting, or tabulation of ballots that are known by the person to be materially false, fictitious, or fraudulent under the laws of the State in which the election is held, shall be fined in accordance with title 18 (which fines shall be paid into the general fund of the Treasury, miscellaneous receipts (pursuant to section 3302 of title 31), notwithstanding any other law), or imprisoned not more than 5 years, or both.
