'Jesus Revolution' Director on Movie's Release Coinciding with Asbury Revival: 'There's a Divine Hand on the Timing'

One of the directors of the new movie *Jesus Revolution* hasn't missed the fact that the title is opening on the heels of one of the largest Christian revivals in recent years — the Asbury Revival, which saw an estimated 50,000 Gen Z'ers participate in song and prayer over a multi-week period at Asbury University in Kentucky.

Speaking to *The Christian Post*, filmmaker Jon Erwin, who co-directed the movie with Brent McCorkle, spoke about the serendipity of the release.

"For years, we've been working on this story. We almost got it made, and then COVID got it shut down," he said. "I just think there's a divine hand on the timing of the film. And the reason we made it was ... the thing that we've said for years is, if it happened then, it can happen now. If it happened once, it can happen again."



Starring Kelsey Grammer, *Jesus Revolution* tells the true story of pastor Chuck Smith (Grammer) who welcomed hippies into his traditional congregation at the height of the Jesus movement in California during the 70s. Lionsgate is opening the movie nationwide Friday after holding special screenings on Ash Wednesday.

Erwin told *The Christian Post* that he traveled to Asbury University to witness the new revival firsthand.

"It felt just like the scenes of the movie, like it felt identical, just the emotion of it, which was why we made the movie," he said. "I just want it to feel awakening, a little bit; renewal, a little bit. And you felt it in that room."

As Breitbart News reported, the Asbury Revival developed into a viral phenomenon on social media, spurring young Christians from around the country, as well as from other countries, to travel to Kentucky to join the movement.

What's Really Going On with These Food-Facility Fires? By [Jim Geraghty](#) May 6, 2022

We made it to Friday! First, with two small planes crashing into or near food-processing plants, and reports of fires at various food-processing plants and facilities, it's fair to wonder if something sinister is going on, but the evidence is pointing in one clear direction; I would sincerely love it if unnamed "senior U.S. officials" would just shut up about how we're helping the Ukrainians kill lots of Russian soldiers; and if you think filling up your tank with regular gasoline is painful these days, don't look at the price of diesel — and I don't mean Vin.

What's Really Going on With Food-Processing-Plant Fires

In a typical year, how many planes crash into food-processing plants?

You'd figure the answer would be "zero," and in a bad year, maybe get all the way up to "one." This year, we're up to two so far — or more specifically, one crash into a plant, one crash about 300 yards from one.

So, what's going on? Is this a nefarious conspiracy of arsonists, terrorists, or foreign agents? At this point, there's no evidence of that and no reason to think it is the case.

For starters, not all the fires or crashes did significant damage. In the Chesapeake soybean-facility fire, a plant manager said that the fire will have little to no impact on their operations. In the Georgia crash, the plane didn't hit the building, no employees were harmed, and General Mills spokesperson Mollie Wulff said, "The plant did not experience any disruptions and it remains fully operational." [The pilot in that crash was identified as a student pilot, and the other person was a flight instructor](#) — with no signs of terrorism and no signs of ties to a hostile foreign government.

Second, none of the fires so far have been declared cases of arson. If we had confirmed or likely cases of arson at food-processing facilities from coast to coast, then yes, this would indeed be suspicious. (I know, I know, the [Cigarette-Smoking Man](#) showed up and covered it up.) But in any given year, there are a half-million fires reported to local fire departments, and about 5,300 of them are in "[manufacturing or processing](#)" facilities. That comes out to about 440 per month, and if there are fires in 440 manufacturing or processing facilities a month from coast to coast, we would expect at least a handful each month to be at food-processing facilities. In fact, the list above stretches the definition of food-processing facilities, because the Walmart Distribution Center also stored

clothes and cardboard, and the New Hampshire fire happened at a butcher shop.

Third, if you were a terrorist or foreign agent attempting to choke off the American food-distribution network . . . [would you start with an obscure potato-chip maker in Oregon? Then move on to the source of Hot Pockets in Arkansas?](#) Then move on to a soybean-processing tank in Virginia? Are these the right targets if you're trying to cripple America?

If you were a nefarious terrorist group or hostile foreign power and you had not merely one suicide pilot, but two of them — and in the case of the Georgia crash, someone willing to ride along as a passenger — would you really aim for a potato-processing plant in southern Idaho and then [the Georgia plant where they make Cinnamon Toast Crunch?](#) Does this terrorist group just hate carbohydrates or something? Does Dr. Atkins have an alibi?

If you hated America and had the ability to crash two planes into separate targets . . . wouldn't you pick something a little more high-profile? The last guys did!

How is this plan to attack and disrupt the U.S. food-supply chain going to work, anyway? As of 2017, [the U.S. had 36,486 food- and beverage-processing establishments](#). Is the plan to pick them off, one by one, every two weeks or so?

What we're likely experiencing is the "[Baader-Meinhof Phenomenon](#)," a.k.a. "frequency illusion" — when you hear a term and then feel like you're suddenly seeing it everywhere. In reality, whatever you're observing is occurring at the same frequency, it's just that you didn't notice it or ignored it before.

Because of the empty shelves earlier this year, people are paying much closer attention to supply chains these days. During the pandemic, many of us experienced sudden disruptions to our usually steady supplies of many varieties of food, [as some meatpacking plants briefly shut down because of Covid outbreaks, and potato growers found it harder to get their spuds to consumers](#). (There was also that [hacker attack on a major beef supplier in early 2021](#).) Then in January, [tens of millions of Americans caught the Omicron variant at the same time](#), leading to disrupt-



tions to shipments of all kinds of products, and thus empty shelves and product shortages across the country. [And those supply-chain problems still haven't been worked out](#).

Lots of Americans have become much more aware of all the steps between the creation of a particular good and when they purchase it, and just how many things can go wrong in between. (And just about everything can go wrong: The *Felicity Ace*, a cargo ship full of Porsches, Bentleys, and Lamborghinis, [caught fire and sank to the bottom of the ocean in early March](#).) It is not surprising that something genuinely unusual — like two small planes crashing in or near two food-processing facilities in a short span of time — would catch people's eyes and get them to start looking for a pattern.

But so far, with no evidence of foul play, this appears to be just another random set of fires in a country that has a lot more fires at industrial sites than we previously thought. The world has a genuine food-supply crisis, [as discussed yesterday](#), and that is likely going to increase prices on certain foods here in America. But the higher food prices we are seeing are thankfully not occurring because of small plane crashes or fires across the country.

ADDENDUM: One point I should have added to yesterday's Jolt about the global food crisis is that the rising cost of fuel is making moving food from one place to another more expensive. Cargo ships and most freight trucks run on diesel fuel, and diesel keeps hitting record-high prices — [\\$5.50 per gallon nationally this week, according to the Energy Information Administration](#). (In Massachusetts, [diesel fuel is now averaging \\$6.10 per gallon!](#) In California, [it's up to \\$6.40 per gallon!](#))

When Biden was inaugurated, a gallon of diesel fuel was \$2.71.

On Twitter, I keep seeing people — presumably liberal or progressive — who say, "I don't worry about high oil and gas prices, because I drive a Tesla!" (These are often the same people who said they will sell their Tesla if Elon Musk bought Twitter.)

I ask these MENSA candidates, who are so convinced that high gas prices don't affect them because they've got an electric car: How do you think all the stuff you buy gets to the store?

State agency won't allow Au Train's Brownstone Inn to reopen

AU TRAIN, Mich. (WLUC) - An empty parking lot in the heart of winter is not what Tom Dolaskie envisioned when he [bought Au Train's Brownstone Inn last fall](#).

"We've already lost all of snowmobiling," said Dolaskie. "This is a \$400,000 mistake by the state."

The mistake, Dolaskie says, is by the Michigan Department of Environment, Great Lakes and Energy

"They showed up. Made an assumption. And on nothing more than that assumption, this 88-year-old restaurant cannot operate," he said.

EGLE won't give Dolaskie water supply approval so he can open. Dolaskie says the agency has made assumptions about the Brownstone's well water. He's had it tested.

"Raw water tests directly from the well and this water tests good, and it's tested good multiple times, and that's the only data that exists," he said.

The previous owners hauled water in. Dolaskie says he wants to operate more efficiently.

"We have emerged from a pandemic, from a very trying time in the service industry, and it's still extremely important that the state of Michigan supports us," he said.

EGLE declined an on-camera interview for this story, but an agency spokesperson responded to TV6's questions over email.

EGLE says it has provided Dolaskie with three options to get water supply approval: Continue to haul potable water to the site; utilize the old well with the addition of water treatment technology; or demonstrate to EGLE through a strategic sampling program that the onsite groundwater is not vulnerable to surface water contamination.

"It would make sense that with this well



However, Dolaskie says he has demonstrated his intent to focus on public health, with the Brownstone and his six other food and beverage establishments in Alger County.

"The quickest and most sensible pressure relief valve is issue a deviation and let us operate," he said. "I'm going to continue to have this water tested because I would do that anyway."

InvestUP CEO Marty Fittante says an operating Brownstone is important to the local economy.

"For nearly 90 years, it's been an iconic structure there," said Fittante. "It goes to the heart of placemaking.

We only have so many of those types of those facilities in the Upper Peninsula. It's part of why it's so important to get this open and get it open timely. It's an anchor asset for that community. It's a draw in and of itself, and so that's why we hope that the state can quickly find accommodation."

While he waits for a health officer to issue a deviation, Dolaskie says a dozen Brownstone staff members are on unemployment. No reopening date is in sight.

State Sen. Ed McBroom, R-Waucedah Township, says he has been working with Dolaskie and the EGLE team to find a path forward so the Brownstone can be opened.

"This should be possible with the investments they made in the business and the ability of the Brownstone to provide perfectly good water from the system on site," said McBroom, in a statement. "It seems some bad communication and misunderstandings have caused the Brownstone to miss one of their busiest seasons and employees have been forced to find work elsewhere. There certainly seems to be a workable solution and I am working to get it done as quickly as possible."

consistently passing raw water tests showing that it's good water, that it's absolutely not groundwater under the influence of surface water," said Dolaskie.

EGLE says testing data is valuable, but it cannot predict the future given what is known about the well's vulnerability to surface water bacteria.

"We are not aware there is existing contamination of the well water, but the well needs to adhere to health and safety standards to ensure that customers are protected from potential contaminants," said spokesperson Scott Dean.

Dolaskie says that's where EGLE is making an assumption. He says only one problem with the nearly 80-year-old well has been documented. That happened during a construction project on the property.

"There's clear language that says that the well issue from 1979 was from contaminants at the ground surface, not groundwater under the direct influence of surface water," said Dolaskie.

EGLE says like fire safety, this is about preventing potential harm to the public.

Gladstone business owner claims he bought an illegal liquor license, original owner says it was always legal

GLADSTONE, Mich. (WLUC) - UPDATE: The current owner of The OC, Tracy Thompson, said he was sold an illegal liquor license in 2019.

Now, the attorney for the JDLS Group, which previously held the license is speaking out. Attorney Adrienne Wolf says nothing about the license is illegal.

According to the [Michigan Liquor Control Commission](#), JDLS received a violation in 2019 for allowing another entity to benefit from the license and for selling or transferring the license without the commission's approval. Wolf says the \$300 fine was paid.



The Liquor Control Commission records show the license currently sits in escrow, with an active violation. Records show a separate violation of the license in 2015 was dismissed.

Thompson claims the Delta County Circuit

Court judge told him the license hadn't been valid since 2014. TV6 read through the court transcript from last June and did not see such a comment from the judge.

According to court documents, Thompson's liquor license denial was due to multiple previous DUI convictions.

At the end of the day, without a liquor license, Thompson says he has to close the golf course. The OC Club in Gladstone still has a full restaurant menu and a new buffet.

Make no mistake, the term "election denier" was purposely coined as a form of derision intended to be so hurtful as to discourage any reasoned discussion of corruption in our electoral process.

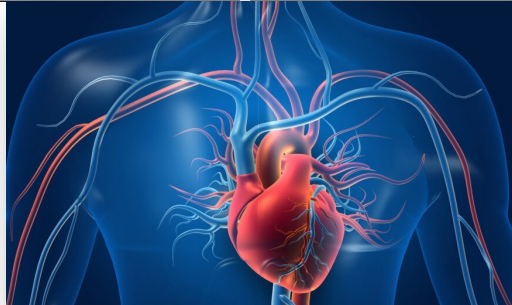

Cardiovascular Disease Increases After COVID-19 Infection, 7 Tips for a Healthy Heart

On Jan. 12, Lisa Marie Presley, daughter of American rock star and the "King of Rock 'n' Roll," Elvis Presley, died of cardiac arrest—once again arousing public attention to [heart](#) disease. Shu Rong, a senior British traditional Chinese medicine (TCM) physician, reminds us of the need to be fully aware of the five distress signals of the heart.



another cardiac work up and was told that the heart condition was better, and no surgery was needed.

Shu said that the heart sends out many warning signs—usually TCM can detect some of those

signs early—but patients also need to be aware of them.

5 DISTRESS SIGNALS SENT BY THE HEART

What warning signals does the heart send out? Shu pointed out the five distress signals:

1. The Tongue

TCM believes that the tongue is the epitome of the whole body, and each part of the tongue corresponds to a different viscera, or cavity of the body.

The tip of the tongue represents the heart—any red spot found at the tip of the tongue indicates that there is a problem with the heart. When the blood circulation is poor, brown thorns appear on the tip of it, which indicates that the blood supply to the myocardium is poor resulting in lack of oxygen.

When the myocardium is congested, the signal is shown by "ecchymosis" thorns appearing on the tip of the tongue. From an anatomical point of view, the tongue is the organ with the most micro vessels in the human body, thus it is an area where we can easily see signs of early cardiovascular lesions.

2. The Earlobes

Shu said that the deep groove on the earlobe,

which is inclined at an angle of 45 degrees, is called "coronary crease," also known as the diagonal earlobe crease. It was first proposed (called the Frank's sign) by Sanders T. Frank, an American, in the 1970s. He observed that the coronary crease on the earlobe is related to coronary artery disease (myocardial infarction, ischemic [heart disease](#)), and later studies showed that it is also related to peripheral vascular disease and cerebrovascular disease.

3. The Heart Zone Above the Ear

If the heart zone (see illustration below) on the ear is sunken or turns dull, or there is a feeling of sharp pain like being pierced by a needle when pressed, it is a warning sign of a heart problem.

4. The Face

TCM believes that the face represents the heart. And when there is an abnormally dark red or dull face it indicates a serious heart problem. It is especially serious when the dark red color appears on the cheekbones belonging to the small intestine meridian. In this case, in addition to stagnation of qi and blood, it also means that the heart is beating too frequently, and there is chest pain, shortness of breath, and even heart failure in severe cases.

5. Feet Edema

Heart failure will cause the failure of blood to return normally, and from the well-known physical principle that "fluid will follow downward" by nature, symptoms such as edema are likely to appear on the insteps, ankles, and calves.

After emergency first aid, he was found to have a blocked blood vessel. At that time, the patient was unwilling to undergo surgery, and remembered that Shu had reminded him of his heart problem five years ago—so he returned to Shu for medical care. Rochelle Walensky's Terrible Testimony by Michael Senger | Feb 22 2023

Last week, U.S. Centers for Disease Control and Prevention (CDC) Director [Rochelle Walensky gave testimony](#) to Congress that was jaw-dropping even by the abysmal standards to which we've been accustomed throughout the COVID pandemic. In just a few hours, Walensky managed to tell Congress that the CDC's guidance to mandate masks in schools would never change regardless of new evidence, that the CDC had conducted no randomized controlled trials (RCTs) as to whether masks were effective because it was so obvious that they worked, and that COVID vaccines had been added to the child immunization schedule so they could be given to uninsured children.

First, in light of the recent [Cochrane review](#) including 78 peer-reviewed RCTs with over 600,000 participants concluding masks made "little to no difference" in preventing COVID or flu, Walensky told Rep. Cathy Rodgers that the CDC's guidance to mandate masks in schools would "not change with time" regardless of the new evidence.

Walensky's response is astonishing for several reasons. First, to say that the CDC's masking guidance "does not change with time," despite the recent Cochrane review, is effectively to admit that the CDC's guidance does not change with new data or evidence, either. This is a far cry from the commitment to "science" that the American people had long been told they were following.

If that's not bad enough, Walensky's statement is, of course, also flatly untrue. After discouraging Americans from obtaining face masks in the initial weeks of COVID, the CDC made an abrupt about-face in April 2020, and face masks soon became mandatory for day-to-day activities, which the CDC at the time had attributed to a change in "science." Making all this even more horrific is the fact that the United States stands out conspicuously as the only developed nation in which its national public health agency recommends masking children as young as 2 years old.

Next, Walensky goes on to tell Rep. Gary Palmer that no one in the U.S. federal government would have thought to propose an RCT to determine if masks were effective because "there wasn't equipoise to the question anymore."



Effectively, Walensky is saying that the CDC wouldn't consider conducting an RCT, widely considered the "[gold standard](#)" of evidence-based medicine, because it was so obvious that masks worked. It's unclear if Walensky's butchering of the word "equipoise" was simply a result of her trying to use a big word in order to sound scientific. But if taken literally, the actual meaning is even worse: To say there was no "equipoise" to the question is to say that conducting an RCT to determine if masks worked would have been a violation of research ethics.

As has been known since early 2020 that COVID poses virtually zero risk to young children. That there have been 2,000 pediatric deaths from COVID is belied by the [CDC's own data](#)—and the vast majority of these children had severe comorbidities.

But moreover, adding COVID mRNA vaccines to the routine immunization schedule has broad implications far beyond simply making them available to uninsured children. Seeing these shots on the routine immunization schedule is certain to make it more likely for individual schools and municipalities to mandate those shots for young children to attend school, while affording legal protection to those that do. Health care providers will also be more likely to lump those shots in with other routine childhood vaccinations, giving them to young children with only minimal disclosure and parental consent. And finally, having COVID mRNA vaccines on the routine immunization schedule may afford certain legal protections to vaccine manufacturers, such as Pfizer and Moderna, for any harm they might cause.

Walensky has a long history of testimonies nearly as terrible as these. Back in 2021, Walensky couldn't explain to the Senate

why the CDC hadn't conducted any field studies on natural immunity from COVID.

In Senate hearing, Director Walensky can't say why CDC hasn't conducted field study of natural immunity.

And then there was the time when Walensky explained that the CDC's initial bravado for vaccine passes, mandates, and grandiose promises about vaccine efficacy back in 2021 had been based on a "CNN feed" claiming the vaccines were "95 percent effective."

Galling testimonies aside, it's not surprising why Walensky was picked to be the CDC director. On the surface, she's articulate and presentable. So it's a real testament as to how far public health has fallen over these last three years that someone in her position would be telling these kinds of falsehoods and defending such atrocious policies.

Yet for all her poise, Walensky demonstrated at least one horrendous error in moral judgment that may help illuminate how she wound up on this path. In 2020, Walensky was a signatory to the [John Snow Memorandum](#), a kind of rebuttal to the Great Barrington Declaration.

The John Snow Memorandum endorsed the efficacy of lockdowns, denied evidence of natural immunity following COVID infection, and essentially acted as the blueprint for "zero COVID." All of these positions were, of course, resoundingly discredited in the ensuing years.

Walensky's signing of the John Snow Memorandum was in keeping with what may be her most damning quote of all. In a radio interview just before being appointed as CDC director, Walensky contrasts Sweden's light-handed response to COVID negatively with China's "really strict lockdowns," and gives her stamp of approval to the Chinese Communist Party's (CCP) data purporting to show that the lockdown of Wuhan had succeeded in eliminating the virus from all of China.

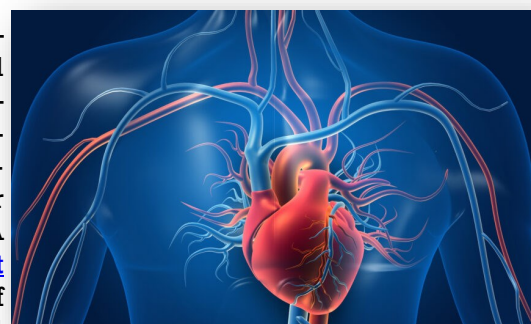

Report: FBI Tried to Arrest 140 People Just for Riding a Bus to the January 6

The [report](#) by Hannah Dreier admits:

These workers are part of a new economy of exploitation: Migrant children, who have been [coming into the United States](#) without their parents in record numbers, are ending up in some of the most punishing jobs in the country, a New York Times investigation found. This shadow work force extends across industries in every state, flouting child labor laws that have been in place for nearly a century. Twelve-year-old roofers in Florida and Tennessee. Underage slaughterhouse workers in Delaware, Mississippi and North Carolina. Children sawing planks of wood on overnight shifts in South Dakota.

In November 2020, Dreier posted an [excellent report](#) on child workers for [ProPublica.org](#).

The expanding population of child workers has been an open secret in Washington D.C. for several years. Breitbart News has [extensively covered](#) the official support and [media tolerance](#) for this child labor force.

The silence is ensured by Democrats' claim they are merely protecting "unaccompanied" children in a "Nation of Immigrants." But that claim is entwined with Democratic donors' demands for more immigrant workers, renters, and consumers.

Biden's progressive deputies have admitted roughly 320,000 migrant children since January 2021. "About two-thirds of all unaccompanied migrant children ended up working full time," the newspaper reported.

Instead, the newspaper drops the blame on Xavier Becerra, secretary of the Department of Health and Human Services, which is supposed to protect child migrants. "Staff members said in interviews that Mr. Becerra continued to push for faster results, often asking why they could not discharge children with machine-like efficiency," the newspaper reported.

Many of the teenagers are being released by Biden's deputies to recognized labor traffickers — not to friendly relatives, the newspaper says. The traffickers force the teenagers to work long hours at low wages and also take debt payments from the children before they can send cash back to their poor families.

UP PATRIOT'S WUPHD OVERSIGHT COMMITTEE REPORT WUPHD BOARD PASSES SUPERIOR ENVIRONMENTAL HEALTH CODE

At the Monday February 27th 2023 meeting of the WUPHD Board the board passed with only one dissenting voice the Superior Environmental Health Code with changes. Before the regular meeting of the board a public hearing was held to gear final arguments for and against the new code.

Strangely, online, were people from not only downstate but from across the country, tipping the scales in favor of the code. One has to wonder how these professionals were informed about the changes in our local health code and felt so strongly one way or the other to actively seek attendance and put forth comments. Strange, indeed.

There seemed to be only one aspect of the code that caught the interest of the professionals in that being septic and sewage systems. One would think that the code only covered this aspect and nothing else. In reality it covers not only septic and sewage systems but privies, water supplies and wells, (a note needs to be inserted here: The list so far is the same things that were covered in the Superior Environmental Health Code that we are currently using, the rest was ADDED TO THE CURRENT BOOK NOW CALLED "THE UPPER PENINSULA ENVIRONMENTAL HEALTH CODE")

Article VI: Public Health Nuisance/Imminent Danger

Article VII: Food Service

Article VIII: Public Swimming Pools and Hot Tubs

Article IX: Campgrounds

Article X: Septic Tank Pumping and Land Application of Septage

Article XI: Body Art

Article XII Cemeteries and Burials

XIII: Clandestine Drug Related Contamination

If these things were not under the Superior Environmental Health Code, then under what code were they found? Why are they adding them to the new code? More importantly, who wrote the template that they are following now?

I couldn't help but feel while listening to the conversation between HD board officials that they never read the booklet. Tanya Rule made a point to say it was reviewed by at least two attorneys and was passed (funny that they could even find the simple typo that gave the HD jurisdiction over only its own physical HD grounds nor the redundancies nor the structure errors)

I submitted some corrections and ideas on how to maintain control of the "employees" of the HD by the board, but most were overlooked or not understood. I was not allowed to explain why I wrote the things I did due to them thinking they were no longer in control of their board.

In the end of the day, some of the things I suggested was adopted and other were not. We have to wait until the booklet comes out to see what changes were implemented and what else still needs to be accomplished.

Which needs me to not something else. The HD Board passed a code without reading it. They passed it by saying they pass it with corrections. This is never an acceptable thing to do in any group let alone something as important as health code.

We still have leverage in that it MUST BE PASSED BY EACH COUNTY COMMISSIONER'S BOARD. If only one commissioner's board rejects, it the code must go back to the Board of Health for revision.

Lengthy Lansing update, buckle in...

Yesterday the Senate voted to spend another \$1.5 billion of your money.
