Resolution supporting local 2nd Amendment Rights to be presented at upcoming Houghton County Commissioners' Meeting. A resolution to affirm support of all constitutional rights, including the right to keep and bear arms, is set to be presented to the Houghton County Board of Commissioners on April 11th.

We are urging everyone who supports 2nd Amendment rights to attend the meeting on April 11th at 4:00 pm to show their support for the resolution, which would declare, that the BOARD OF COUNTY COMMISSIONERS OF HOUGHTON COUNTY supports the lawful exercise of discretion not to enforce an unconstitutional law against any law abiding person within Houghton County.

It is expected to be a full meeting, with the commissioners also voting on the Health Department's new health code, which has been much contested as it includes verbiage.

The vast majority of residents in the Copper Country support the 2nd Amendment, but since this is a much-debated topic, I was informed that there will be a strong showing of gun-control advocates to be at the meeting. It is time to make a clear statement to Lansing that the people of Houghton County uphold the Second Amendment and support all constitutional rights.

We want to make a strong showing in support for the 2nd Amendment to counter the gun-control advocates, and we invite everyone who is able to attend the meeting.

If we stand together on April 11th, we can prevent a small group of gun control zealots from shouting over our voices and prohibiting us from being heard. Please plan to attend and show the commissioners that Houghton County overwhelmingly supports the 2nd Amendment.

Michigan Democrats and the Chinese Communist Party

On March 2nd 2023, the Michigan State House of Representatives voted in passage of HB 4016: an appropriations bill that allowed hundreds of millions of Michigan taxpaver's dollars to a Chinese Battery Plant in Big Rapids. The fact that we are not reinvesting in American and Michigan ingenuity and business is a tough sell on its face. Couple that with the ongoing issues we have with China and their leader Xi Jinping, the rising costs of inflation, the economic hardship Michiganders are dealing with every day, and China's ever increasing cozy relationship with Russia and Vladimir Putin, and you have taken a bad idea at face value and turned it into a terrible and dangerous situation in Michigan.

Michigan's State Senate had previously **vot**ed in its passage and a young Senator from Branch County, Senator Lindsey introduced By Jon Rocha

an amendment to the bill. He was willing to vote for the plant but only if three stipulations were met. One being that there is **no direct or indirect national security threat**, and that Michigan runs an assessment to ensure that. Two, that Michigan would certify that neither the plant nor a partner beneficiary would benefit from forced or slave labor. And three, that neither the direct nor a partner beneficiary would work directly or indirectly with the Chinese Military. Though this was a very bipartisan and common-sense amendment, the <u>Senate passed the bill without</u> <u>the amendment</u>.

Now, it has been discovered, in the bylaws of the newly voted on battery plant, that the company shall "Set up a Party Organization and carry out Party activities <u>in accordance</u> to the Constitution of the Chinese Com-

> munist Party. The Party shall ensure necessary conditions for carrying out Party activities." Among other tidbits in the bylaws are requirements for the company to "Strengthen the construction of Party organization and Party members at the grass-roots level of the Company" and oversee growing the "Communist Youth

<u>League and other mass work of the Company".</u>

Senator Lindsey was more than justified to ask for safeguards to this multi-million dollar appropriation bill. Now we know one of two things must be true: either **the Democrats are complacent and negligent** in their investigation of this company they voted on or they are involved directly with helping a foreign government adhere, on US soil, to **the direct destruction of our Constitutional Republic** by fostering and **growing the Chinese Communist Party**. Neither is good and the people of Michigan deserve better.

It is time to demand answers from your legislators. Ask them why they would vote to use taxpayer funds to usher in the growth of the Chinese Communist Party. If they answer they did not know then, ask them why they didn't ask the tough questions. Ask why they didn't allow safeguarding amendments like Senator Lindsey's to help protect the people of Michigan. But more importantly, get involved and vote them out! Outrage brewing over plans for China-linked battery company in Michigan: <u>'Don't want CCP in our small town'</u>

Former Republican gubernatorial candidate Tudor Dixon blasted Michigan Gov. Gretchen Whitmer Wednesday for moving forward with plans to allow \$715 million dollars of taxpayer money to fund a Chinese Communist Party-linked business in the state.

"These are not going to be American jobs. They're bringing Chinese nationals in to take these jobs. And they will be housed at the local university where the local university has just so happened to be telling people 'this is such a good idea, you have to have this corporation here,'" she told host Tucker Carlson. Gotion put the planned construction in Big Rapids on hold in February after the town board unanimously voted days earlier to request a federal review for any potential national security risks associated with having a <u>Chinese-owned company</u> in the area, according to a report by The Detroit News.

Dixon shared the whole thing seems "suspect."

"Now you have the community rising up. So, Big Rapids actually said, 'You know what, we don't want this in our town. We

Dixon, however, said a CCP-linked business <u>shouldn't be allowed to operate</u> in the state and called out Whitmer for allowing the company to come to Michigan.

"In the company by-laws that are on the company website, it clearly states that when they get to Michigan, they have to have a CCP organization on site, a Chinese Communist Party organization on site, a propaganda arm of the CCP, right in the center of the country in Michigan," she explained on "Tucker Carlson Tonight."

Dixon added that the battery plant was "nowhere near" any of the state's major <u>au-</u> tomobile manufacturers and questioned what the company would be doing.

She claimed Gotion was also bringing in 250-300 Chinese nationals who would be filling some of the jobs and would be stay-

More than 100 residents of Green Charter Township and Big Rapids in rural Mecosta County, Michigan, showed up to a March 14 board meeting to <u>voice concerns over the</u> <u>presence</u> of the Chinese-owned company.

"The thing that drives me the most crazy about this is that this is a Chinese-owned company. A Chinese-owned company is a communist company. Why would you bring a communist company to Big Rapids, Michigan, when we have troops mobilizing right now to fight China?" one resident, who identified himself as an Iraq War veteran, told the town's board members. don't... we want this to move out.' Goshen said, 'We're going to move to the town next door,'" she stated.



Report: U.S. Marshals Were Told Not to Arrest Protesters Outside Supreme Court Justices' Homes By Paul Bois | 29 Mar 2023



U.S. Marshals assigned to guard Supreme Court justices during the controversy over *Roe v. Wade* last year were reportedly told not to arrest protesters that gathered outside their private homes. "The law states that it is illegal, 'with the intent of influencing any judge to: 'picket or parade "'n or near a building or residence occupied or used by such judge, juror, witness, or court officer," it added, "'or with such intent,' to resort"to any other demonstration in or near any such building or residence."

According to documents obtained by Alabama Republican Sen. Katie Britt, Attorney General Merrick Garland ordered U.S. Marshals not to arrest protesters, telling them it should "not" be a priority. Per the <u>Washington Times</u>:

> Mr. Garland told senators earlier this month that his prosecutors couldn't bring cases unless the marshals made arrests, and the marshals on the scene didn't think there was a reason to do that.

guidelines that the law could face legal challenges and discouraged them from using that as a base to make an arrest. Sen. Britt also said that the guidance told agents to coordinate with federal prosecutors before making an arrest, which also contradicts Garland's claim that the agents were free.

"Any contemplated [marshals] enforcement action should be coordinated in advance with the appropriate USAO," the guidance said.

Last year, individual Supreme Court Justices were targeted by protesters after an illegal leak of a draft decision aiming to overturn *Roe v. Wade* before it had been officially decided. At the time, even the left-wing <u>Washington Post</u> admitted such protests were likely illegal according to <u>Title 18</u>, <u>Section 1507, of the U.S. Code</u>.

"While protest is indeed ingrained in American democracy, legally speaking, the comparison between protesting a politician at home and a member of the judiciary at home is inexact. And experts say the latter category of protests is probably illegal regardless of how peaceful the demonstrations are," the *Post* admitted. Ms. Britt said the guidance documents show they were directed not to.

"They were actively discouraged from doing so," she said.

A section of the guidance given to marshalls even <u>said that</u> arrests were "not the goal" of their deployment, with another section advising that arrests should be "a last resort to prevent physical harm."

Regarding the law barring Americans from pressuring judges to influence a court decision, the attorney general told agents in the there to murder the sitting judge to protect Roe v. Wade.

"A California man carrying at least one weapon near Brett M. Kavanaugh's Maryland home has been taken into custody by police after telling officers he wanted to kill the Supreme Court justice," reported the Washington Post at the time.

"Two people familiar with the investigation said the initial evidence indicates the man was angry about the leaked draft of an opinion by the Supreme Court signaling that the court is preparing to overturn *Roe. v. Wade*," continued the *Post.*

Police and court documents say that Roske had in his possession a Glock-17 pistol, a tactical knife, pepper spray, zip ties, and a crowbar.



I'm quitting Disney after seeing it boast about pushing 'gender theory'

The Walt Disney Co. just refuses to let it go.

On Tuesday, <u>Christopher Rufo</u>, known for his exposés on schools and corporations under the spell of critical race theory, released internal Disney videos in which those in charge discuss how they insert the "not-at-all-secret gay agenda" into children's programming.

Those were the words used by Disney Television Animation executive producer Latoya Raveneau, who said she is "adding queerness" wherever she can — with Disney's blessing, as the company is "going hard" to be supportive.

The executives made the remarks in a company-wide virtual meeting Monday about Floritainment. And why should Disney be in the business of sexualizing kids in any direction?

Raveneau, the producer who's "adding queerness" wherever possible, spoke of the "momentum" she felt: "I don't have to be afraid to have these two characters kiss in the background." She's the executive producer of the upcoming series "Rise Up, Sing Out," which will appear on Disney Junior a brand the company says is aimed at kids ages 2 to 7.

"Disney is a cautionary tale about ideological capture," Rufo told me. "Disney executives created identity-based activist organizations within the company, delegated moral authority to their representatives, and now those groups have taken the corporation hostage to their ideologies. They wield 'trauma' and 'oppression'; the white male CEO caves."

So far, 15 states and the District of Columbia have adopted National Popular Vote legislation. The system they developed – the one our country has used for more than 230 years – gives smaller states a say in the election, preventing larger states from dominating the process. 

SHTF Survival: 10 Disturbing Threats That You're Probably Not Ready For

When planning for a SHTF Survival situation, there is really only one thing that you can be absolutely sure of: Survival is going to be a much bigger and tougher challenge than you ever thought possible. While there are some things you can do to prepare yourself for the chaos ahead, the reality of the situation is that when things go bad, there are going to be things happening that none of us prepared for or could have ever imagined.

What is SHTF?

SHTF has multiple survival meanings, but the acronym itself means Shit Hits The Fan. The meaning is pretty straight forward, but basically, it's just a prepper/survivalist's way of saying that during a long term survival crisis or collapse of society things are going to get bad, real bad! How bad none of us really know, and what dangers we will face is only speculation at this point, but one thing we do know for sure is that most people have no real clue to the dangers they will face during a collapse scenario.

Prepping for SHTF Scenarios

It's not hard to imagine things going bad during a long-term disaster or collapse situation; all you have to do is look at how quickly things turn south during normal yearly disasters to get a sense of how bad things could get. Even during somewhat predictable events like summer storms, flooding and hurricanes we see a large section of the population turn desperate. From people who failed to prepare totally losing their shit in the grocery store when they find the shelve empty to the assholes who take advantage of every disaster to hit the streets looting and attacking innocent civilians, you can find plenty of examples that should at least get you thinking of what you need to be prepared to face.

10 Realistic SHTF survival situations that most people Don't Prepare or Plan for!

While many of the threats you will face can be easily predicted by looking at recent events, we wanted to look at some very likely SHTF scenarios that very few think about, and almost nobody prepares for. These are threats they may present themselves during short-term disasters, but in all likelihood, these threats will be the ones that start to pop up during those extreme long-term situations where people lose hope and become desperate.

SHTF Law Enforcement Issues

1. No Law Enforcement

During an extreme SHTF scenario, it is very likely that law enforcement and emergency responders will be pretty hard to find; in fact, I would go even further and say that they will become nonexistent. Even during small-scale disasters, law enforcement officers often leave to take care of their own families first. When things go bad (empty grocery stores, no utilities, mass riots, violence, etc.) you are more than likely going to have to defend and take care of yourself. You have to be able to quickly determine who are the real law enforcement officers or be prepared to stay away from people at all costs.

3. Law Enforcement and the Military Will Try to Take Your Guns.

Think it can't happen? It already has!

In the aftermath of Hurricane Katrina, New Orleans Police Superintendent Eddie Compass ordered all local law enforcement, including the U.S. Marshalls office and the National Guard, to seize all civilian firearms.

Without warrants, armed National Guard troops and New Orleans law enforcement officials forcibly confiscated over 1,000 legal firearms from law-abiding citizens. The New Orleans gun confiscation should serve as a warning to how the government and law enforcement officials will react during a large-scale national disaster.

It's very high on the probability list that they will come for your guns!

SHTF PERSONAL SAFETY ISSUES

4. Gangs & Raiders

When things go bad, there will likely be more people who mean to do you harm than there will be people who are prepared. This is something that you must accept and learn to deal with. The fact is, most people have no idea what it really takes to survive, and once their safety net is removed, they will become increasingly desperate and unpredictable. Even your once jolly neighbor will become a threat when he is faced with surviving without knowledge or supplies.

Let's face it, even during the good times there's a certain segment of our population that's just downright insane. From the idiots who go nuts and riot after their team loses a game to the violent criminals and gangs who are already terrorizing big cities throughout America, there's little doubt that a total collapse will make urban living almost impossible.

5. You need to be able to Defend Yourself.

During an extreme emergency situation, the lunatics of the world are going to be roaming the streets looking for easy victims to target. If you're serious about survival, you need to train yourself in multiple self-defense styles and techniques. <u>Preparations underway for Trump's arraignment in N.Y. court on Tuesday</u>

Secret Service tour courthouse where former president will appear after surrendering to face criminal charges By <u>Carol D. Leonnig, Josh Dawsey, Shayna Jacobs</u> and <u>Perry Stein</u> | Updated March 31, 2023



Former president Donald Trump plans to fly to New York on Monday and stay overnight before appearing in <u>a specially secured</u> <u>Manhattan courthouse to be arraigned</u> on still-unspecified criminal charges, people briefed on the arrangements said.

The first-ever indictment of a former president — who is also a 2024 White House hopeful — brings unusual security challenges to the courthouse complex in Lower Manhattan, even as it continues to roil the political landscape.

On Friday, Trump <u>lashed out on social media at the judge</u> assigned to the case and a prosecutor from the office of Manhattan District Attorney Alvin Bragg. Republican lawmakers focused their ire on Bragg, an elected Democrat, while Bragg's deputy pushed back against demands from GOP committee chairs that the district attorney come to Capitol Hill and explain his investigation.

Being charged with, or convicted of, a crime would not disqualify Trump from running for president or holding the office. But the optics and logistics of campaigning while navigating a legal case could get complicated. For the moment, Trump and his advisers are ramping up their fundraising efforts and making the rounds of GOP lawmakers and party leaders, leaving his lawyers to negotiate his

dent's travel between Mar-a- Lago, his Florida home and private club, and New York.

The <u>indictment announced Thursday even-</u> ing remains under seal, which means the charges have not been made public. But a Manhattan grand jury has been hearing evidence about <u>a payment made before the</u> <u>2016 presidential election to Stormy Dan-</u> <u>iels, an adult-film actress</u>, to keep her from publicly discussing an affair she says she had with Trump years earlier.

<u>Bragg</u> and his investigators have spent months probing whether Trump falsified business records connected to the Daniels payment in a way that could constitute a campaign-finance violation.

The New York probe is one of <u>multiple</u> <u>criminal investigations</u> that have engulfed Trump's post-presidency. He is also the focus of investigations in <u>Georgia</u> and <u>D.C.</u> related to his efforts to overturn Joe Biden's ple involved with the plans have said will happen on Tuesday afternoon. The former president will be fingerprinted, photographed and brought to the courtroom of Supreme Court Justice Juan Merchan upon surrendering before the proceeding, where he is expected to enter a not-guilty plea. If the charges have not already been made public, they will be unsealed by the time of the arraignment.

On Friday, Secret Service Director Kimberly Cheatle briefed her deputies about plans for Tuesday, the law enforcement official said, telling them that the agency will take "the necessary steps" to protect Trump from harm, including placing agents and officers in a bubble formation to separate him from approaching members of the public. But she also stressed that the Secret Service has not sought any special accommodations in the court's standard processing and arraignment procedure, the official said, such as closing off courthouse hallways to the public.

In securing Trump's safety, Secret Service agents will be primarily responsible for his entry to and exit from the courthouse, the official said. Court security officers will manage the former president's movements inside the building, in the company of Trump's security detail, and New York police officers will secure the outside streets surrounding the courthouse and along Trump's motorcade route through the city.

The New York Police Department will have a heavier-than-normal presence around the courthouse, and officers who normally wear street clothes or suits have been directed to come to work in uniform in case there's a need to monitor demonstrations, another law enforcement official said, also

> speaking on the condition of anonymity to discuss security arrangements.

> The streets around the courthouse will be blocked off to traffic and street parking will be suspended, an official said. Court security officers who had scheduled vacation days or time off have been asked to report for duty anyway.

> Trump can still run for president in 2024 after being indict-



surrender to law enforcement and his security detail to coordinate logistics with police.

An advance team of Secret Service agents — mostly comprised of New York field office agents — conducted a site tour of the courthouse on Friday to map Trump's path in and out of the building, according to a law enforcement official involved in the planning.

The official, who spoke on the condition of anonymity to discuss the arrangements, said that "dozens and dozens of agents" will be required to secure the former presi2020 election victory and his <u>handling of</u> <u>classified material</u> at Mar-a-Lago.

Trump denies any wrongdoing and continues to accuse law enforcement agencies that investigate him of conducting political witch hunts. In a statement Thursday evening, he charged that Democrats "have lied, cheated and stolen in their obsession with trying to 'Get Trump,' but now they've done the unthinkable — indicting a completely innocent person in an act of blatant Election Interference. Never before in our Nation's history has this been done."

The next step in the criminal proceeding is Trump's arraignment, which multiple peo-

Arms sent a warning to Senate staffers on Friday that they anticipate "demonstration activity across the country related to the indictment of former President Trump."

"While law enforcement is not tracking any specific, credible threats against the Capitol or state offices, there is potential for demonstration activity," the authorities said, according to a statement first reported by Punchbowl News.

They also told staffers to expect an increase in Capitol Police and law enforcement presence around the Capitol in the coming days. Both chambers of Congress are in recess for the next two weeks in observance of the spring religious holidays.

Trump Is Indicted: Here's What Happens to Him Next in Court

Legal analysts have revealed what will happen next in court after former President Donald Trump was indicted by the Manhattan District Attorney's office on Thursday night, with some saying that the former president will have to get his mugshot taken.

When someone is indicted, the charges are kept sealed by a judge until the defendant makes their first court appearance, analysts have said. It's not clear what charges Trump faces as they've not been made public yet.

The Manhattan District Attorney Alvin Bragg's office acknowledged late Thursday that Trump's lawyers had been told about the indictment. "This evening we contacted Mr. Trump's attorney to coordinate his surrender...for arraignment on a Supreme Court indictment, which remains under seal," a spokesperson said in a statement. "Guidance will be provided when the arraignment date is selected."

Trump's lawyer, Joe Tacopina, told The Epoch Times on Thursday night that the former president is expected in New York City early next week for arraignment. He suggested that Tuesday, April 4, could be his arraignment date, coming two weeks after the initial arrest date that the former president had initially predicted.

According to a Bragg spokesperson, prosecutors and Trump's legal team are negotiating a surrender date, when Trump would have to travel from his Florida home to the district attorney's office in New York to be fingerprinted and photographed.

Trump would then make an initial appearance in court, where he would be formally charged. He would likely be allowed to head home afterward, experts said.

Mugshot?

"He would be arraigned, face a trial date, and face a jury verdict just like anyone else," said University of California, Berkeley law professor Andrea Roth in a <u>statement</u>. "He would have no more or fewer procedural protections than other defendants, and the state has the same powers—subpoena power, for example—it would normally have."

She added: "Of course, the case will be highprofile, but other high-profile defendants have been successfully prosecuted. The defense attorneys will surely raise numerous issues, from intent to defraud to a statute of limitations bar, but that is also true in most high-profile cases. The New York case also has no formal consequence for the election; you can be an indicted or even convicted person and run for president. Eugene Debs, a Socialist candidate, ran from prison in the early 1900s."



Former Harvard Law professor Alan Dershowitz <u>told</u> Newsmax earlier this month: "He will be mugshot and fingerprinted. There's really no way around that." But for Trump's 2024 campaign, that could be a boost, he suggested, adding that Trump could use that photo as a campaign poster.

The U.S. Constitution does not bar a convicted felon from holding political office. It only lists three requirements: that the person is aged 35 or older, a natural-born American citizen, and has had to have lived within the U.S. for at least 14 years.

University Law Professor Craig Green told 6ABC that Trump "will surrender and be photographed, and fingerprinted, and he will make bail, and then he will leave the courthouse." After that, he says that standard legal procedures would play out.

But some analysts have said that it's not clear what the arraignment will look like. In some cases, a defendant is handcuffed and walked to the courthouse for arraignment in a process known as a "perp walk." It's not clear how that would proceed in the case of Trump, a former president who enjoys U.S. Secret Service protection.

Green, however, said that if the case ever makes it to a jury, it could prove to be more complex.

> "If we ever got to a jury trial and he actually was supposed to go to jail, the timeline means this would be well after the election of 2024," Green told the outlet. "So, at least it's theoretically possible you could have a sitting president who would face state criminal charges and have to go to jail."

In an ironic twist, Florida Gov. Ron DeSantis would typically have to give formal approval for an extradition demand in his capacity as governor. In a Twitter post on Thursday, the governor said he would not assist in any extradition request, calling the indictment politically motivated.

What Trump Might Do

John Banzhaf, a law professor at George Washington University, said that Trump's lawyers could file a motion to dismiss the case on multiple legal grounds, likely arguing that it is based on a faulty legal theory that a misrepresentation of an alleged hush-money payment is not by itself a criminal act. They also likely will argue that charges against him—stemming from payments that were made in 2016—are barred by the statutes of limitations.

"Third, and perhaps most importantly, his lawyers will seek a dismissal based upon the argument of prosecutorial misconduct, and especially selective prosecution," said a news release from Banzhaf's office issued Thursday night. "In support they would point to the undisputed facts that several prosecutors (including Bragg himself once) who had reviewed the case declined to prosecute, and that there is no logical reason (e.g. newly discovered evidence) to suddenly reinvigorate what has been called a 'zombie' case now years after the facts became known."

The former president also could argue that "selective enforcement" could be at play, which is when a district attorney or other prosecutors attempt to single out an individual for charges "when they generally choose not to charge other people who committed similar offenses," the release said.

the House of Commons that Finance Minister Chrystia Freeland's office distributed a blacklist to the RCMP naming 201 trucking companies, according to <u>Blacklock's Reporter</u>.

"The RCMP placed no restrictions on the blacklist's distribution, and records show it was distributed to the Canadian officers of some banks headquartered in foreign countries, such as the Bank of China, State Bank of India, and Citibank of New York.

The RCMP wrote in the Inquiry that the blacklisted companies' information was only shared with "entities listed in pursuant to the Emergency Economic Measures Order," and that "no information was shared with any other non-governmental entities."

"Among the 201 blacklisted companies, 198 were Canadian, with the other three being registered out of the United States. (Epoch Times)

Other banks on the distribution list included the France-headquartered BNP Paribas, Habib Bank of Pakistan, Hana Financial Group located in South Korea, ICICI Bank Limited of India, Mizuho Financial Group of Japan, and Wells Fargo & Company headquartered in San Francisco, according to Blacklock's.

In other words, freezing the bank accounts of Freedom Convoy truckers and their supporters was not just a Canadian initiative but one that the Trudeau government sent worldwide to destroy truckers.

"The RCMP also distributed the blacklist to online banking and investment companies, such as <u>Ouestrade</u> and <u>WealthSimple, Inc.</u>, which are both headquartered in Toronto. (Epoch Times)

Of Maple Syrup, Seed Starting, and Baby Goats

Springtime rambling, from a Yooper farmer's perspective by James Niemela

As I write this, it's a grey, cool day outside. Not a cold, bitter day, but more of a damp, dreary early spring day. Last night, we got a little bit of snow, but it's more of a mist now, if the precip starts. We did our first finishing of maple syrup earlier in the week, ended up with 5 gallons. Since we just do it for family use, we are tickled with any amount we get.

Since we had some syrup left from last year, we didn't need to push it too hard this year, it's nice to ride a little easier sometimes. We have some taps set out in our woods, and some set in one of the neighbor's woods. Loads of onions, leeks, peppers, celery and root celery, the first planting of lettuce, beets, and swiss chard, are either up or in the process of germinating. It's a nice time of year to see the new little seedlings coming up. With God's blessing, those little tiny plants will grown to nice big fresh veggies for our customers and for our use.

In about a month and half or so, the onions and leeks can go out. They are quite hardy critters, taking the late frosts of spring in stride. Bulbing onions can be planted later to be sure (and we usually do throw sets in here and there, for green onions or boilers, once the bulk of the planting is done and we have extra space), but the key with onions is they are more of a daylength sensitive crop. Well, old daddy was down river a little from the bigger boys; I leaned over toward the water to break off a

branch that kept snarling my line, and promptly slid down the bank and into the water, backwards. Thankfully I didn't fall full length, just kind of swooshed in and sat down in there. It wasn't deep or fast-moving enough to be dangerous in that area, but it was COLD!!!



We do the work, and trade off syrup to him, so he gets his yearly needs of maple goodness, and is happy as a pig in a mud puddle. It helps us too, since we have mostly soft maple, which make good syrup, just not as much sap as his sugar maples give. It's nice to form win-win situations with folks.

Another elderly neighboring couple has their yard surrounded by big maple trees. The trees drop loads of leaves in the fall; he used to mow them, and try to get them out of there. Not anymore- we use leaves as insulation over our over-wintered carrots to keep them from freezing in the ground until the heavy snows come, so in the fall the bigger children (usually with some smaller fry in tow) run down to their yard, rake the leaves, and haul them home for our needs. In the spring, once the carrots are all done, and the snows leave, we till them into the ground to feed the soil.

It helps our neighbors, and it helps us; plus they love children, so they get the bonus of having them running around the yard. Along with the maple syrup season being underway, the greenhouse is up and running. They start "thinking" about making their bulbs as the days start to shorten after the summer solstice, and the bigger the top, the more energy the plant will have to push into the bulb. So we like to get them out early, to get them established and growing well for the long days before the 3rd week of June, when the solstice rolls around and days start getting shorter.

Soon the suckers will start coming up the river too, we like to catch them, and can lots of them. Some filets we smoke then can, some we just can. It's a good mild fish, we use it in place of tuna.

The key is getting them in the early spring, before the waters get warm and mucky. That snow melt water is cold; one year, we were out there fishing. The water was a little high, and I told Janice I'm not taking the smaller ones today, I don't want anyone to fall in and get swept away. (I'm guessing you can see where this is going.)

I came barreling out like I was shot out of a gun, went hustling toward the boys, hollering that we need to run home quickly. They came hopping up over the bank, thinking I had a whopper fish and was yelling for help, but I just had to go home for some dry clothes. And of course, Janice had to mention with a grin on her face, something about me not wanting the kids to fall in, when I came dripping into the house. I still laugh about it when I think of it. I like to refer to the sucker spawning season as the "UP Salmon run." Lastly, on this past Lord's Day, one of our dairy goats had twin girls.

Sometime they have their young on the worst, snowiest, nastiest days, and you have to wonder if there is some conspiracy to have you be miserable along with them. But, good old Lily birthed on a beautiful, warm sunny day. Hooray for her! Two more goats to kid, hopefully they also have their babies on such nice days. And it's good to have fresh, home-grown milk again!

NMU students hold policing debate

MARQUETTE — Different opinions were expressed during a debate on policing in America hosted by the Northern Michigan University College Republicans Thursday on NMU's campus.

They teamed up with Northern's Turning Point USA against the NMU College Democrats and the Young Democratic Socialists of America.

RCMP have said that the shooter was not licensed to own firearms, but had what appeared to be an assault-style weapon, as well as other guns. The RCMP did not specify which kind, so it is unknown if it will be covered by the ban.

Mr Trudeau campaigned on the ban ahead of last November's election, and he said he was planning on introducing the ban in March, but it was delayed because of coronavirus.

His government had already expanded background check requirements and made it tougher to transport handguns, prior to November's election.

The government is able to ban the weapons immediately through current regulation, but a buy-back programme would require multiparty support in parliament and would likely cost the government hundreds of millions of dollars.

The ban is controversial politically. A petition against the ban started by Conservative MP Glen Motz in December has more than 175,000 e-signatures.

Many of the weapons used in violent crime in Canada were not obtained legally, and Conservative leader Andrew Scheer said Mr Trudeau would do better to focus on stopping guns from coming across the border than on banning law-abiding gun owners.

The Globe and Mail reported that leaked documents show the buy-back programme would be voluntary, and licensed owners would have their guns grandfathered. Mr Trudeau had previously promised the programme would be mandatory.

On Friday, Mr Trudeau would not confirm whether buy-backs would be voluntary, but reiterated the buy-back programme would have to be supported by other parties, and be fair to everyone.

"The next steps need to be ironed out," he said.

Even from the start of the debate, it was clear all four groups would have to not only be civil among themselves, but with the other organizations.

When asked if police receive sufficient training, NMU Dems President LaPlante agreed they do, but see themselves as above the law in some places. He suggested they "enforce the law enforcement...to fix what they're doing on their own." Additionally, both sides agreed that the main cause of neighborhoods with high crime isn't skin color, but poverty. However, they disagree on the reason.

The left argued that poor communities are often made up of people of color because of the systemic racism in the country that keeps them in poverty, causing them to take further lengths to achieve food, money, health care or clothes for their family.

The debate was planned and organized mostly by NMU College Republicans President Matthew Schlenkert. Although not directly affiliated with the Communications Department's Civility Week, it was certainly a peaceful display of a controlled argument between different viewpoints. Both sides did their own research and prepared a list of questions for their opponents. Time was set aside to answer and respond.

Arguing for the right were Roman Menhart, Daniel Golding and Marina Curtis. Representing the NMU Dems were Alec LaPlante and Mitchell Russelburg. For YDSA, participants were Andrew Gordon and Shelby Boggs.

Their conversation began as an acknowledgement from all parties that the police force is a necessary aspect of American society. The disagreement came in when the topics moved to accountability of police officers, systemic racism, funding of law enforcement departments and over-policing of poor neighborhoods. Fellow student from the left, YDSA President Andrew Gordon, added, "I'm going to disagree with that ... I don't think police receive enough training. That being said ... I think taxpayer funding of education will provide that training and education for the police force...At minimum a four-year degree would be ideal...to become an officer."

Gordon backed up his viewpoint with the 2013 U.S. Bureau of Justice report that showed one of the lowest training requirements for police officers in the world.

The NMU Republicans stood their ground, defending the current training requirements to make it easier to recruit more officers during the current personell deficit.

"Nobody wants to be a police officer in today's age because the police are demonized by the media and it's a terrible job to work," Curtis said. The right posited that poor communities are overpoliced only because they are low income and that skin color has no place in the equation whatsoever.

After more respectful back and forth, audience members asked various questions about implicit bias, gun control and the distribution of funds in America.

When the event was done, all debaters shook hands and expressed their gratitude for having an insightful conversation.

Michigan House Bill 4156 (2023)

A bill to enter into the agreement among the states to elect the President by national popular vote; and for related purposes. The people of the state of Michigan enact:

Sec. 1. This act may be cited as the "agreement among the states to elect the President by national popular vote".

Sec. 2. It is the public policy of this state that the one-person, one-vote principle requires that the candidate who receives the most votes nation-wide should become President.

Sec. 3. The agreement among the states to elect the President by national popular vote is enacted into law and entered into with all jurisdictions legally joining in the agreement, in the form substantially as follows:

Agreement Among the States to Elect the President by National Popular Vote
