# 'Real Face of Jesus' Revealed in Newsmax Magazine

New scientific and forensic evidence has "now strongly" revealed the famed Shroud of Turin to be the burial cloth of Jesus more than 2,000 years ago, a new report in Newsmax magazine's April issue reveals.

Appearing on Newsmax's "John Bachman Now" show Tuesday, Newsmax magazine Executive Editor Ken Chandler detailed the publication's findings for its cover story "The Real Face of Jesus."

"We looked at all the latest scientific and forensic evidence that's been done," Chandler told hosts John Bachman and Bianca de la Garza. "There's been a huge advance in research capabilities since the 1970s, when the shroud was originally researched — there's new scanning techniques, there's new photography techniques."

"The evidence now strongly suggests that the Shroud of Turin was, in fact, the burial cloth of Jesus."

The shroud has been a subject of controversy for some time, but Chandler says major media have largely ignored the new scientific and forensic evidence pointing to its link to Jesus of Nazareth.

"The shroud was examined recently by one of the top laboratories in Italy, and they were able — through these new techniques that I just referenced — they're able to date the shroud back 2,000 years ago," Chandler said.

"You know, previously there had been research that suggested the shroud was originated in the 13th century, but we now think that that research was faulty."

Chandler's magazine noted how the 2018 research incorrectly [dated it to the medieval times](#) after the fall of Rome.



"Part of the shroud had been damaged in a fire and new material had been woven in, so, you know, it was very unclear, but this new research really does point to the fact that this is 2,000 years old," Chandler continued.

"And there's all sorts of interesting detail in here, like, for instance, the scientists detected pollen, which is unique to the pollen that's found in the area around Jerusalem."

"There were marks on the shroud that show that Jesus was tortured in a way that the Romans tortured people who are criminals in those days, and it all points to the fact that what happened and where this shroud originated was 2,000 years ago in the Jerusalem area, about the time of Passover in the spring."

Also, the forensic evidence of the bloodstains match another purported shroud that is said to have been wrapped around Jesus' head after crucifixion.

"It's AB blood and, by the way, that blood matches a cloth called the Sudarium, which is another historical cloth which is on display in Spain at the moment," Chandler said.

"The evidence is mounting," he said.

"The researchers that we spoke to, and we spoke to numerous researchers, many of whom have devoted their careers to this, independently, they've come to the conclusion that the shroud is real."

[Newsmax magazine's](#) cover photo vividly depicts a bearded man with long, dark hair as imagined from the reverse image of the Shroud of Turin by a famed illustrator.

"That image was done by an Emmy-winning illustrator who's done a lot of illustrations for medicine, for Big Pharma," Chandler said. "He's helped with a couple of documentaries on the History channel."

"He's an expert in this field, and he put together this picture based on the cloth and the outline of the face on the cloth, and we believe that it's pretty close to the real thing."

# Bombshell Docs Show Biden White House Directly Coordinated With FBI to Set up Trump Raid

New information is being uncovered regarding the Federal Bureau of Investigation's unprecedented raid of President Donald Trump's Mar-a-Lago home last year. According to America First Legal (AFL), a judicial watchdog, an investigation of the raid confirmed that the FBI gained access to NARA records through a "special access request" made by the Biden White House on behalf of the Department of Justice.

"On August 8, 2022, the Federal Bureau of Investigation (FBI) conducted an unprecedented raid of Mar-a-Lago on the ground that potentially classified records existed there. According to press reports, Biden Administration aides were "stunned" to hear of

this development," AFL begins [in a press release](#). "However, new NARA records obtained through America First Legal's investigation into the circumstances surrounding the Mar-a-Lago raid further confirmed that the FBI obtained access to these records through a 'special access request' from the Biden White House on behalf of the Department of Justice (DOJ)."

According to AFL, it appears that "the Biden White House and DOJ coordinated to obtain the Trump records and perhaps create a pretext for the law enforcement raid by way of the 'special access request.'"

In addition to confirming that the White House was involved in setting up Trump, AFL also proves that the National Archives misled Congress about the role the White House played in the raid.

"This stunning revelation suggests that NARA was misleading Congress about the White House's role in the shocking raid of President Trump's home, and the fact that the Biden White House was acting "on behalf of" the DOJ raises significant legal concerns," explains AFL. "The special access statute authorizes special access re-

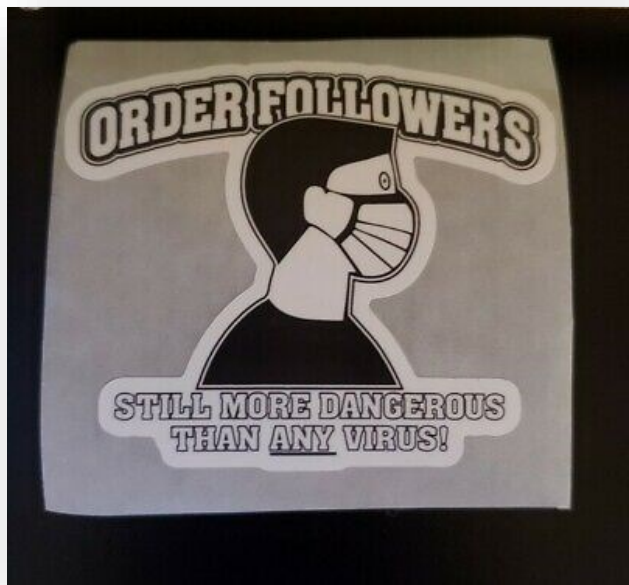
quests to an incumbent president *only* when the records in question are needed for 'the conduct of current business' of the White House. Providing documents to the DOJ for purposes of a criminal investigation is not the 'current business' of the White House."

AFL is now urging the National Archives and Records Administration (NARA) to disclose all records related to the Biden administration's role in the politically motivated raid of former President Trump's home.

"The evidence suggests that the ostensibly nonpartisan National Archives and Records Administration misled Congress about the Biden White House's responsibility for the FBI's raid of former President Trump's home," said Reed D. Rubinstein, Senior Counselor and Director of Oversight and Investigations. "The evidence further suggests that Biden officials in the Executive Office of the President and the Department of Justice unlawfully abused their power and then lied about it to the American people. This government, it seems, acknowledges no limits on its power to harass, intimidate, and silence its political opponents."

We have piles of proof that they stole 2020 from President Trump, Where is the FBI? DOJ? Where is our government who swore an oath to the US Constitution?

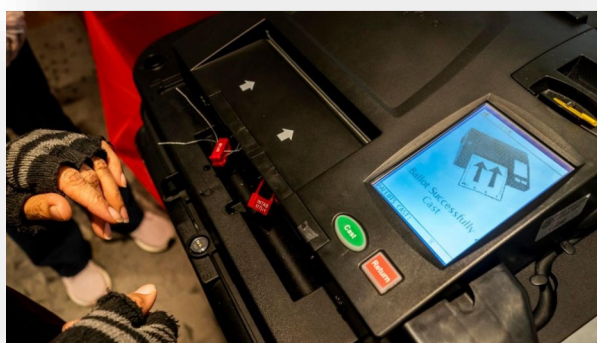
The GOP has the House and we have not heard one iota, not one comment about 2020, our broken election system, etc.

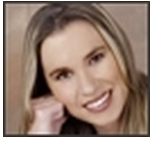

## \$4.7 Million in Small Amounts of Money Donated to Democrats – Apparently Without the Donors' Knowledge

Investigative journalist James O'Keefe and [Election Watch](#) have stumbled upon a bizarre occurrence in Democratic campaign filings; thousands

of small donations totaling often close to a couple of hundred thousand dollars per person made to Democrats from elderly Democrats. It seemed rather strange that these elderly people, who appear to almost all life in average homes and are unemployed, would contribute excessive donations, which average out to multiple donations a day for years. Who makes donations like that? Some people sign up to contribute once a month, which is normal, not multiple times a day.

Suspicious money laundering may have been occurring, with donations made using the old folks' names and addresses since they were less likely to discover them than younger people. O'Keefe, who started OMG Media Group after parting ways with Project Veritas, [showed up](#) at the homes of several of the elderly people, who have been dubbed "Smurfs," to confront them about the excessive contributions. They all appeared to be Democrats of modest means who seemed confused and generally denied making anything but small amounts.

One of the biggest recipients of the small amounts of donations was Janet for Justice, the campaign of Janet Protasiewicz, who narrowly won her Wisconsin Supreme Court race, tipping the balance on the court in favor of Democrats.

Election Watch suspects the money could be coming from overseas interests since the small amounts correlate to currency exchange differences. The strange contributions totaled \$4.7 million. They are all publicly available in plain view on the FEC's website.

O'Keefe and his team showed up at the home of Michael Jamieson in Maryland, who had allegedly contributed 3,000 times totaling 32,000. When asked about the donations, Jamieson, whose employment was listed as "unemployed," opened his run-down-looking door, ranted about Donald Trump, and said, "Stop f\*\*\*\*\* with me."



O'Keefe stopped by the home of Cindy Nowe, who allegedly contributed 1,000 times to ActBlue, totaling \$18,000. She told him she donated to ActBlue for "\$5 once in a while" because she has "various charities" she likes to give to. When he asked her if she'd donated \$18,000, she said no.

O'Keefe visited Carolyn Lenz in Tucson, who reportedly donated \$170,000 through 18,000 separate contributions within the past seven years. When confronted by O'Keefe's team, she said, "no, no, no, no" and kept repeating, "Absolutely not."

Garland Riggs, who is 80 years old, allegedly made 31,000 contributions totaling \$230,000. He told O'Keefe he didn't make those donations and that his wife may have donated to ActBlue. His wife said it was no way near that amount, not even \$1,000 a year.

Brightline Investigations' Kyle Corrigan, part of the Election Watch team, [confronted](#) a man named Richard in Wisconsin about allegedly donating 8,000 times. He responded, "That seems a little odd; that seems too high. Maybe \$800." He said he only donates once a month.

Corrigan also confronted Wisconsin resident Dale Wing about 11,000 donations over seven years, which is about four times a day. He appeared to deny it. Cindy Grossberg, also in Wisconsin, said it didn't sound accurate that she had made 4,000 donations and said she does not have contributions debited monthly from her account.

In Southern California, citizen journalists [tracked down](#) Penelope Harms in southern California about 1,800 donations totaling \$13,000. Harms responded, "That doesn't sound right." They also stopped by the home of Lori Ball, who allegedly made about 500 donations totaling \$7,000. Ball denied donating seven times in one day, and said she merely donates \$5 per month.

Similarly, Jan Weisburg in Southern California, who reportedly contributed \$60,000 to \$5,000 per month over the past year, said, "No, I can't do that" and suggested, "someone is using my name."

The story is getting legs, with [RealClearPolitics](#), [The Post Millennial](#), [The American Spectator](#) and others covering it. The American Spectator's Scott McKay tracked down New Orleans resident Cornelius Maneux who allegedly contributed to ActBlue 800 times within two years totaling \$18,000. Maneux's status is unemployed and the address listed as his home on the campaign finance report is a modest duplex.

Democrats finding themselves on the list are beginning to speak up. One [admitted](#) on Twitter they had not made donations to ActBlue reflected on the FEC's site.

Considering all of the Smurfs discovered so far are over 65, there are concerns that this involves not just campaign finance laws, identity theft, and possible money laundering, but also elder abuse. However, one sleuth [said](#) he attempted to talk to a Smurf and could not get a response since they're now being warned.

This isn't the first time ActBlue has been accused of strange donations. An investigation by the Take Back Action Fund in 2020 [discovered](#) that nearly half of all 2019 donations to ActBlue were made by people claiming to be unemployed, totaling \$346 million. In contrast, only 4% of donations that year to the GOP's WinRed came from people who were unemployed or who did not list their employer.

Concerned parties in Maryland have filed a lawsuit over the strange donations. O'Keefe encourages others to confront the Smurfs [discovered](#) by Election Watch. Election Watch lists the Smurfs on its website.

But will any prosecutors or law enforcement investigate? Left-wing billionaire George Soros, his family, and organizations have been contributing heavily to DA and sheriff races around the country in recent years in order to oust conservatives and replace them with far-left law enforcement. In Arizona, for example, Maricopa County Sheriff Joe Arpaio was defeated and replaced with Democrat Paul Penzone, and the Attorney General is far left Democrat Kris Mayes. This is likely why no law enforcement anywhere around the country appears to have announced an investigation.

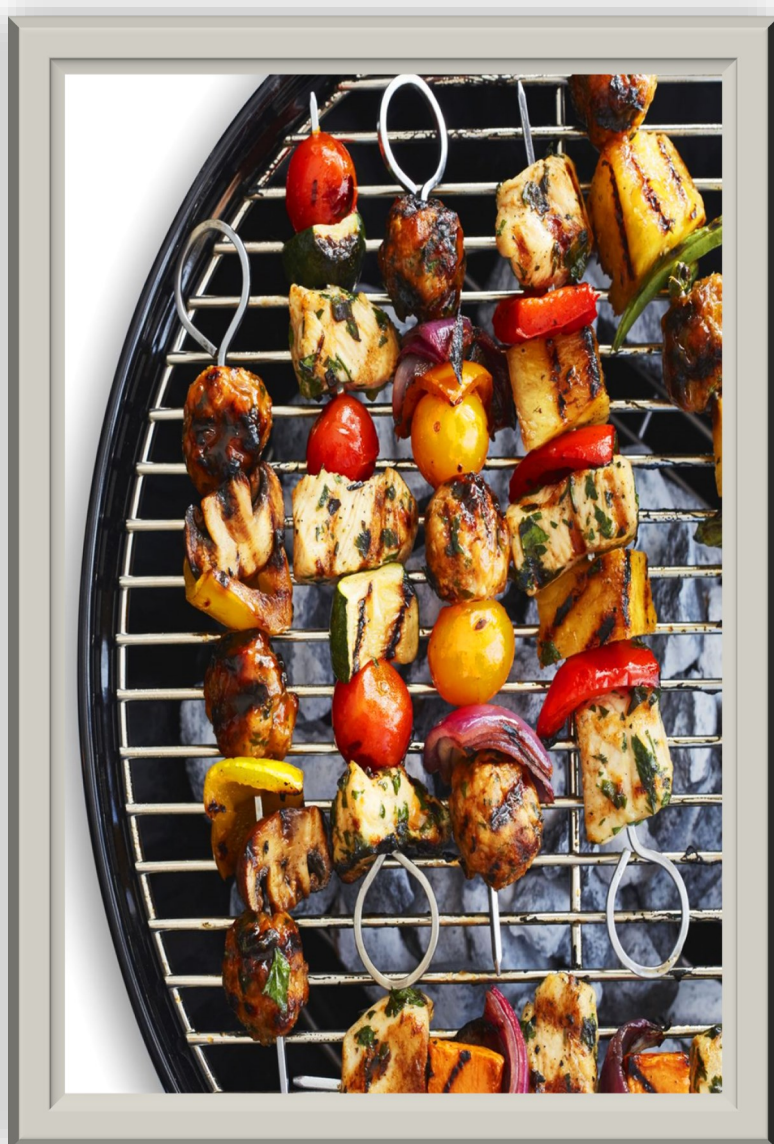

 3 tbsp. olive oil, divided  
 Kosher salt and pepper  
 12 cherry or grape tomatoes + 1 small zucchini, cut into thick half-moons

 1 sweet potato, cut into 1 1/2-in. chunks + 1 medium red onion, cut into 8 wedges, each halved crosswise

**STEP 1:** Heat grill to medium-high. Place chicken in large bowl. Finely grate zest of lemon over chicken. Add scallions, parsley, 2 Tbsp oil, 1/2 tsp salt, and 1/4 tsp pepper and toss to combine. Squeeze lemon juice over top and toss again.

**STEP 2:** Choose a veggie combo and, in second bowl, toss vegetables with remaining Tbsp oil and 1/4 tsp each salt and pepper.

**STEP 3:** Thread chicken and veggies onto skewers. Grill, turning occasionally, until chicken is just cooked through, 8 to 10 minutes

## The dangerous erosion of Democratic Party foundations

As President Biden steers America toward possible global shooting wars with the Chinese and the Russians, tries to incite a second civil war here at home, and drives full steam into American economic collapse and energy shortages, he — with help from progressive Democrats and most mainstream media — is watching the broad-based center of the Democratic Party bleed away.

Recent polls showing Biden's significantly slipping approval by Hispanics, Blacks and women should set off alarm bells. The hint that Hillary Clinton could come after Biden in 2024 with a "centrist" campaign should send the White House and Democratic Party political teams to the bomb shelter. A political collapse of this magnitude in the first year of an administration is unprecedented and should be worrisome to all Americans. Only Sens. Joe Manchin (D-W.Va.) and Kyrsten Sinema (D-Ariz.) seem to have principles and spunk — combined with the political savvy to have run the numbers as quickly as the Clintons.

Polls among Black voters show sharp declines in support for Biden, from a high of 68 percent dropping to a recent low of 48 percent. Key issues are COVID-19, the economy, and jobs. Obviously, Biden is failing miserably on COVID (his advice: vax or else, use Google for help, and Blacks disproportionately resented the vaccine mandates); the economy, with inflation climbing 7 percent and destroying Black wage progress; and jobs, with Black unemployment dramatically higher than under Donald Trump's growth policies. The reliable Black voter foundation of the Democratic Party finally may be eroding.

The Fully Federalized Voting Scam bill (sorry, my words; they actually call it the Freedom to Vote Act), passed by the House, is cleverly named and disguised to appear to help Black voters. But it actually may help

to destroy Black voting power. Voter ID is a case in point. Nearly 90 percent of Black voters have IDs, while whites are a little higher at 95 percent, a small gap that could be made up with a modest effort at getting IDs for those who want to vote. But the Democrats want to get rid of ID requirements entirely.

Who, exactly, are they planning to help? Not Blacks, who actually have or easily can get IDs. Not whites. Not Hispanic citizens. Obviously, large blocs of undocumented voters who do not have and cannot get legitimate IDs. Nothing could dilute and destroy the power of Black voters more than that. New York City makes that clear. It allows 800,000 undocumented residents to vote in local elections. That dilutes the voting power of the 2 million Black voters of New York City by nearly 50 percent. But the policy will keep in power city attorneys and mayors who seem intent to not prosecute street crime or increase neighborhood safety — both of which will fall the hardest on the Black communities with rapidly rising crime rates. The bottom line is that Biden and the Democrats seem serious about voter suppression.

Another elephant in the room is the one that just waded across the Rio Grande. The millions of illegal immigrants not only dilute the Black vote, illegally, but also undercut the job market for poorer Blacks, Hispanic citizens and women. The Biden fully-open-border policies rapidly distribute undocumented immigrants throughout the country and, combined with Biden's failed economic policies, have helped lead to the rising jobless numbers for Blacks.

Democrats take the Black vote for granted, but it will not take forever for traditionally Democratic Black voters to figure out that the party, and many Black Democratic politicians, are not really their friends at all, and that all of the divisive racist rhetoric from Biden is designed to hide a great deal of that deceit.

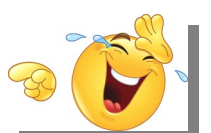
In the case of Hispanics, it appears that Biden and progressive Democrats vastly underestimated their conservative, family-oriented culture. As with Black Americans, Hispanics prefer a strong economy and real jobs, rather than the handouts, shortages and inflation offered by the Democrats. Polls show that Hispanic support for Democrats has plummeted over the first year of Biden's presidency by 17 percent and is now evenly split between the parties.

Finally, Biden and the Democrats are working hard to alienate the key swing vote of white, suburban women. The astoundingly ham-fisted approach of teachers' unions and school boards to political indoctrination of children and closing down classroom teaching, backed by threats from the Department of Justice and FBI to take action against parents, raises questions about potential political corruption in, and the weaponization of, the Justice and Education agencies. Progressives lecturing parents on the prominent role of the state in child-rearing did not end well in the swing state of Virginia last year and probably will be reprised throughout the country in November.

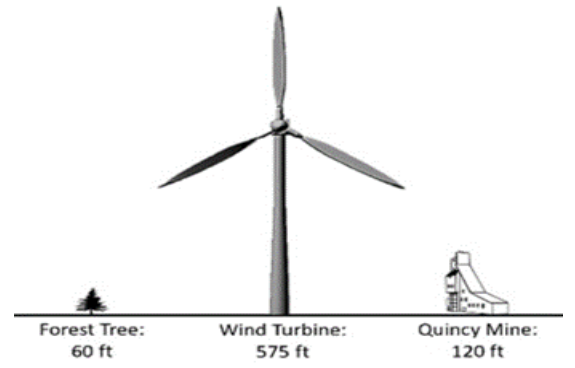
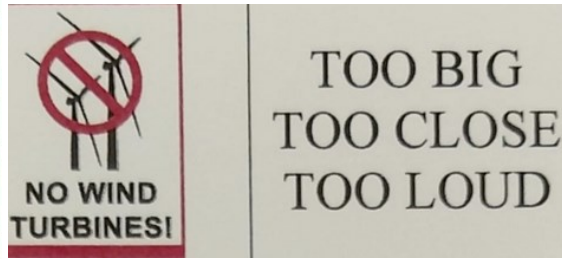
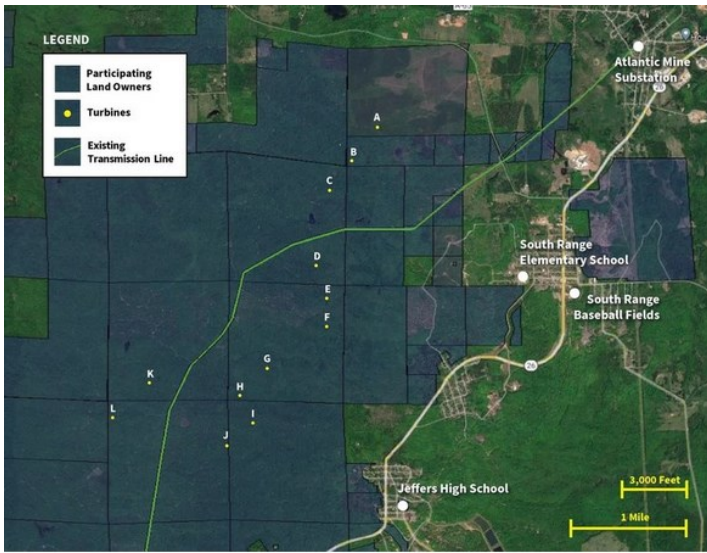

## Senate Democrats seek 'clean' energy mandates as bill plans revealed

Michigan Senate Democrats announced Wednesday a slate of upcoming policy proposals aimed at reducing carbon emissions in Michigan, including a mandate for 100% "clean energy standard" by 2035.

The package, called the Clean Energy Future Plan, takes aim at coal-powered energy plants, energy waste, solar siting issues and [transportation emissions](#), and would grant more power to the [Michigan Public Service Commission](#) to consider the environment, equity and public health when evaluating utilities' plans.

"It allows protection of our residents, protection of our rates and then it allows for us to tackle a very difficult issue, climate," said Sen. Sam Singh, D-East Lansing.

One of the proposals includes phasing out coal-fired electricity generation by 2030, requiring utilities to move toward eliminating greenhouse gas emissions from power generation by 2035 and developing a 100% clean energy standard by 2035.

The 2035 clean energy standard and 2030 phase-out of coal would be a mandate, not goal.

"We'd like that to be a mandate," Singh said. "We do believe it's time for us to be moving beyond just goals."

Nuclear energy will be included as a "clean energy" source that could satisfy that mandate, along with sources like wind and solar, Singh's Chief of Staff Molly Korn said in an email.

That could affect the future of a decommissioned nuclear plant on Michigan's west coast. [Holtec International is pursuing plans to restart operations at Palisades Power Plant in Covert Township](#), which was shut down before Holtec purchased it last year.

Details of the bills were not available at the announcement Wednesday. The bills had not been introduced as of Wednesday afternoon.

The bill package is in line with the [MI Healthy Climate Plan that Gov. Gretchen Whitmer's](#) administration released last year. The plan lays out strategies for meeting carbon neutrality goals Whitmer announced in 2020, which include reducing Michigan's carbon emissions 28% by 2025, 52% by 2030 and achieving carbon neutrality by 2050.

To get there, the plan called for adopting strategies such as cleaning the electric grid, increasing public transit and electric vehicle use, improving energy efficiency and more.

The bills Senate Democrats introduced Wednesday echo the proposals in the state climate plan, such as phasing out coal-powered electricity generation by 2030.



Specifically, the bills would :

Increase the energy waste reduction target required for electric utilities [from 1%](#) to 2% annually and require municipal and cooperative electric utilities to meet an energy waste reduction target.

- Allow the Public Service Commission to evaluate climate, health, equity and affordability in the approval of regulated utility companies' Integrated Resource Plans.
- Codify the Michigan Department of Agriculture and Rural Development plan that allows farmers to rent their land for solar operations while keeping that land in the farmland preservation program under Public Act 116.
- Adopt a clean fuels standard to reduce the carbon intensity of transportation fuels 25% by the end of 2035.

Develop a Michigan Construction Decarbonization Strategic Plan to support a goal of reducing emissions from heating homes and businesses 17% by 2030.

Sen. Sue Shink, D-Northfield Township, said expanding the purview of the MPSC to allow it to consider climate, health, equity and affordability when overseeing utility companies like DTE Energy and Consumers Energy gives residents who weigh in on rate cases more opportunity to voice their concerns about emissions and rate prices.

"Now when they talk about climate change and the effects of power generation on climate change, those details will be considered in

setting the rates, and also in determining how the power will be produced," Shink said. "When our electricity generation results in the release of carbon, it increases the likelihood of catastrophic storms including ice storms."

Warming temperatures mean the atmosphere can hold more water, which increases the likelihood and power of major storms like those that caused widespread power outages this winter. A partnership of federal and university scientists in Michigan have found the amount of precipitation falling in the heaviest 1% of storms [increased 35% from 1951-2017 in the Great Lakes region as air temperatures warmed an average of 2.3 degrees Fahrenheit](#).

Advocates have been pushing for the Legislature to expand MPSC's authority to regulate utilities' impacts on climate, health, affordability and equity, said Derrell Slaughter, Michigan Clean Energy advocate for the Natural Resources Defense Council.

"To actually have that in statute to consider that as part of their decision-making I think is huge," Slaughter said.

Slaughter said the Natural Resources Defense Council supports the Clean Energy Future Plan, but he will review the details when the bill language is available. He wants to see specific programs that will support renewable energy and energy efficiency in low-income communities.

"We want to make sure that transition is equitable, and all folks are able to take part in that clean energy transition," he said.

Senate Democrats said Wednesday they also are developing bills that would promote the purchase and use of electric vehicles and make energy more affordable.

"It is past due that we take action to address climate change and invest in the resources needed to make Michigan a leader in environmental resiliency and sustainability," Singh said. "Creating energy efficiency standards and working to reduce carbon emissions and utility costs for residents will make a significant economic impact."

The Michigan lawmakers' statement described Gotion as a company with " direct ties to the CCP, which presents a national security risk, the plan has come under scrutiny for its secrecy and lack of oversight, which may present environmental and public safety risks as well."

Gotion recently released a statement praising their work with the Taliban, "The representative of the company thanked the leadership of the Ministry of Mines and Petroleum and asked for an investment in the lithium sector of Afghanistan and said that he wants to invest \$10 billion in the Lithium Mines of Afghanistan, which will provide employment for more than 120,000 people directly and one million people indirectly."

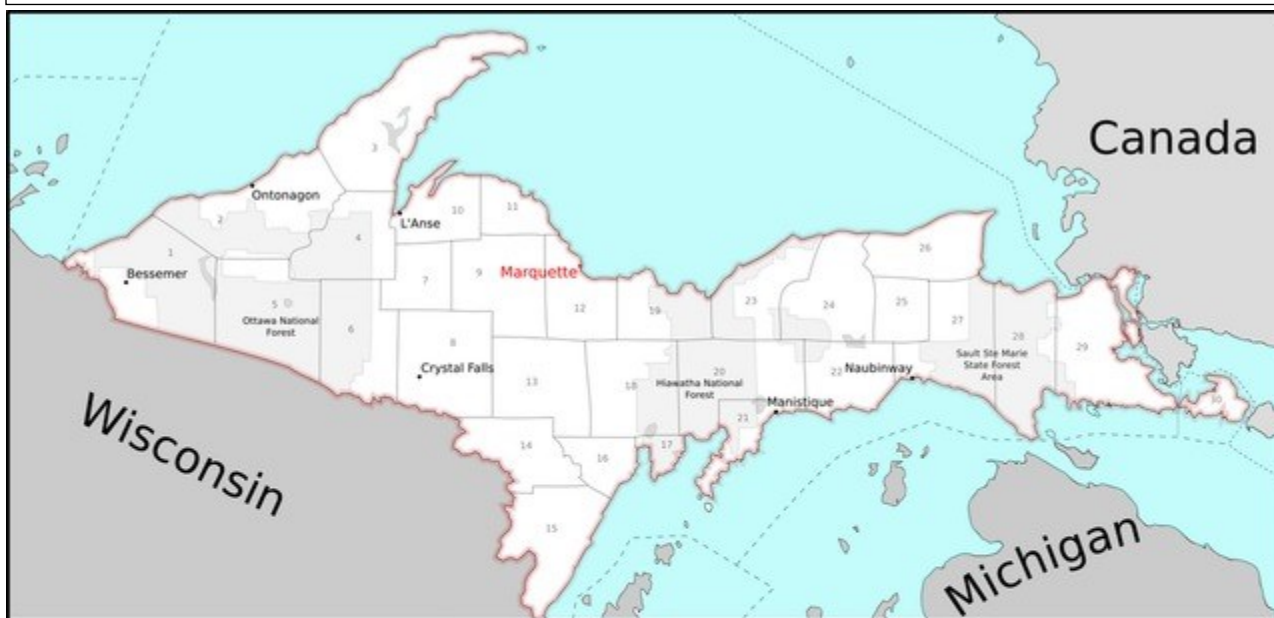

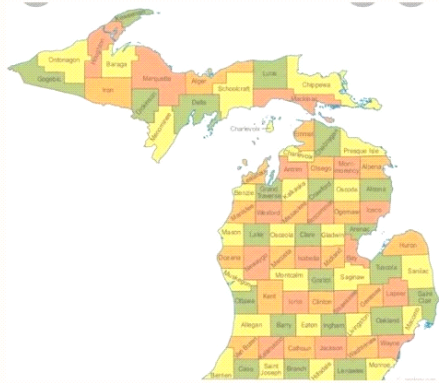

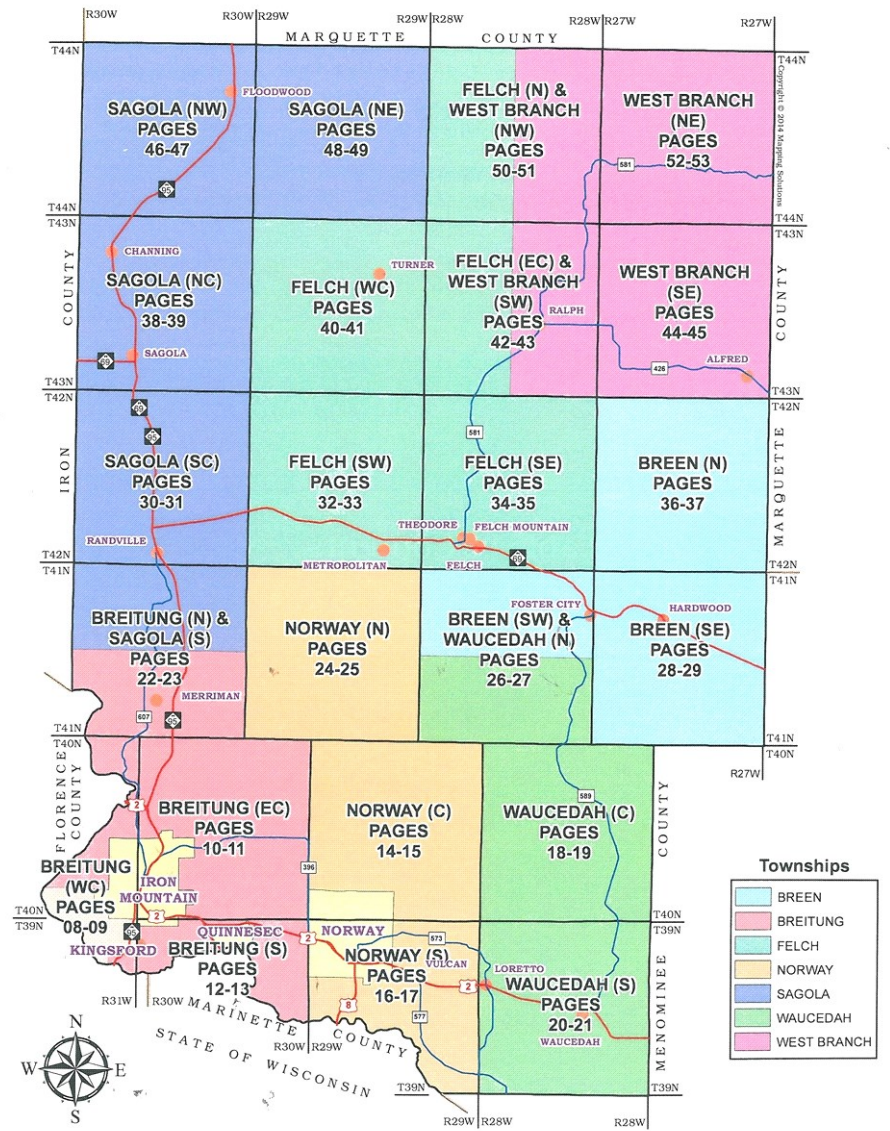

**Federal laws passed over the years help protect Americans' right to vote and make it easier for citizens to exercise that right:**

The Civil Rights Acts created some of the earliest federal protections against discrimination in voting. These protections were first outlined by the Civil Rights Act of 1870 and were later amended by the:

Civil Rights Act of 1957

Civil Rights Act of 1960

Civil Rights Act of 1964

The Voting Rights Act of 1965 prohibited voter discrimination based on race, color, or membership in a language minority group. It also required certain places to provide election materials in languages besides English.

The Voting Accessibility for the Elderly and Handicapped Act of 1984 required polling places to be accessible to people with disabilities.

The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) of 1986 allowed members of the U.S. armed forces and overseas U.S. voters to register and vote by mail.

The National Voter Registration Act (NVRA) of 1993 created new ways to register to vote. It also called for states to keep more accurate voter registration lists.

The Help America Vote Act (HAVA) of 2002 authorized federal funds for elections. It also created the U.S. Election Assistance Commission (EAC). The EAC helps states comply with HAVA to adopt minimum standards on voter education, registration, and ballots.

The Military and Overseas Voting Empowerment (MOVE) Act of 2009 improved access to voting by military and overseas voters.

With over 46 years of significant contribution and recognition in the pro-life movement, **Brad Mattes** is widely known in the United States and worldwide for his passion for the sanctity of life, from preborn to end of life.

Currently serving as president of Life Issues® Institute, Brad was co-founder of the organization along with pro-life pioneer, Dr. John C. Willke, in 1991. The Institute's stated purpose over the past 30 years has been to serve the educational needs of the pro-life movement, developing and distributing effective pro-life educational material.

Heard on over 1,200 radio outlets nationwide, Brad is commentator for the daily Life Issues® program which was recognized by National Religious Broadcasters with the 2016 Radio Impact Award. Annual special productions for "Sanctity of Life Sunday" and other occasions have extended the audio reach of the ministry, along with customized PSAs for a variety of purposes to serve the pro-life agenda.

The global nature of the work is exemplified as Brad also serves as president of the International Right to Life Federation, and formerly served as a chairman of the board of the Terri Schiavo Life and Hope Network. He was formerly assistant director of the National Right to Life Political Action Committee, and served as president of several state Right to Life organizations.

In addition to his speaking engagements across the United States, he's a frequent international speaker and lecturer on abortion and euthanasia issues. He works extensively with other countries to establish pro-life education networks as well as a counseling presence.

His considerable research on abortion's impact on men has made Brad one of few frequently invited to speak to that topic. For a number of years, the Institute produced a weekly pro-life television program, Facing Life Head-On, which Brad hosted and produced. The telecast resulted in three Regional Emmy Awards.

A family man at heart, Brad and his wife, Ellen, have grown four grown sons and five grandchildren. The Montana natives now reside in Florida.

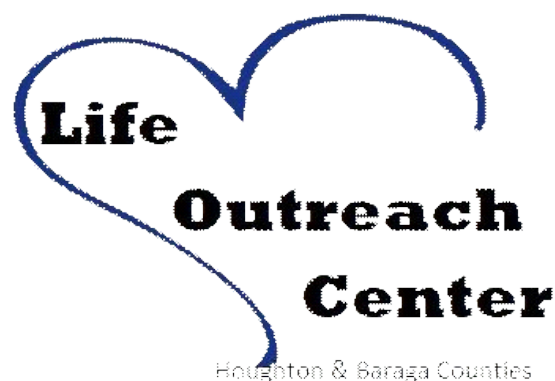
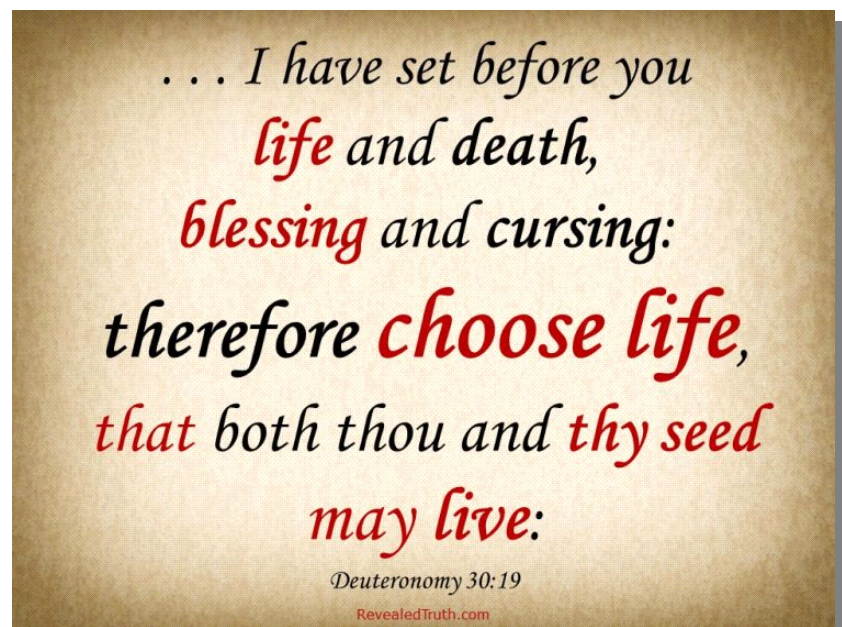

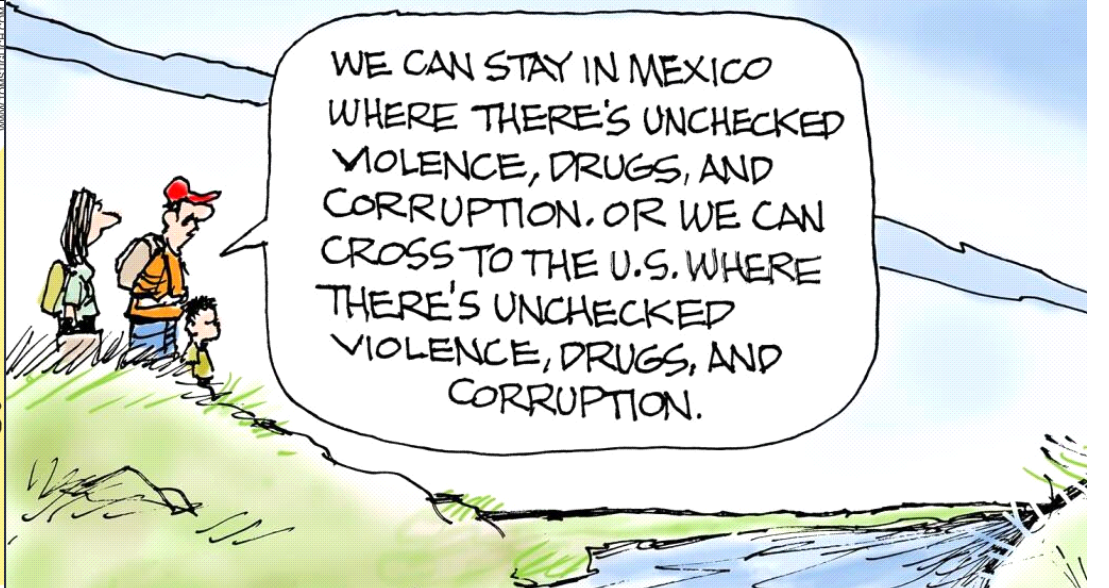

Michigan House Bill 4156 (2023)

A bill to enter into the agreement among the states to elect the President by national popular vote; and for related purposes. The people of the state of Michigan enact:

Sec. 1. This act may be cited as the "agreement among the states to elect the President by national popular vote".

Sec. 2. It is the public policy of this state that the one-person, one-vote principle requires that the candidate who receives the most votes nationwide should become President.

Sec. 3. The agreement among the states to elect the President by national popular vote is enacted into law and entered into with all jurisdictions legally joining in the agreement, in the form substantially as follows:

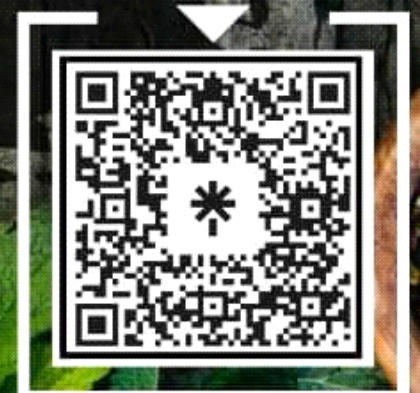

## White Pine Tree Information – Learn How To Plant A White Pine Tree

It's easy to identify a white pine (*Pinus strobus*), but don't look for white needles. You'll be able to recognize these native trees because their bluish-green needles are attached to the branches in bundles of five. Gardeners living in USDA zones 5 through 7 are planting white pines as ornamental trees. The young trees grow rapidly in an appropriate site.

White pines are lovely evergreens with graceful habits. The lush, 3- to 5-inch (7.5-12.5 cm.) needles make the tree look soft and attractive. White pine makes a fine specimen tree, but can also serve as a background plant, given its evergreen foliage.
