## Of Compost and Building a Healthy Soil (Part 2)

Springtime rambling, from a Yooper farmer's perspective by James Niemela



On this 17th day of May, the spring season on the farm is well underway. Monday, another planting of baby lettuces went out into the field, as well as some [pak choi](#) starts, a bunch of white and purple bunching onion seedlings, and we [direct-seeded](#) in more carrots. Yesterday, another planting of broccoli, cabbage, lettuce, and some [Tokyo Bekana mustard](#) were started in the greenhouse.

*My wife Janice loves [Tom Thumb lettuce](#), and Tokyo Bekana, so I started some of each, unbeknownst to her. I'll surprise her someday- if any of y'all reading this see her somewhere, please don't spill the beans. :) She's busy being a homemaker and mom/teacher to the children, so there isn't much danger that she'll be rummaging around in my greenhouse too much, OR, reading this article. I'm guessing my secret is pretty safe unless someone squeals on me. So please don't snitch on me.....the regular treatment for snitches (getting stitches and winding up in a ditch) is a bit harsh for something like this, and while I'd love to threaten leaving a pile of "bunny berries", rotten lettuce heads, or a load of goat manure on your front porch if y'all rat me out, I'd rather keep those here on the farm for my compost piles. So, I'm left to simply trust you to keep my secret. :) That little snippet leads me into the article.....*

Last time around, we talked about feeding organic materials to the soil life, so they can live out their lives and in so doing, build your soil fertility.

As mentioned last time, pretty much anything that was once alive, and is now dead, can be composted; leaves, grass clippings, farm animal manure, food scraps, spent vegetable plants or old cornstalks, hedge clippings, weeds you've pulled from your growing spaces, you name it.

Here's a handy dandy list of materials, with notes regarding their usage: [Compost Materials Chart \(List of Ingredients\)](#)

*(I'll step aside briefly now, to mention something not on the list, that should NOT be composted - human remains!)*

While some pagan minded compost enthusiasts fantasize about composting people's bodies when they pass, in a Christian worldview it is abhorrent to treat human bodies with such desecration as to cremate them ([Amos 2:1](#)), or turn them into compost to fertilize fields with. As the world continues to devolve in greater wickedness and hatred of God and His ways, it's good to be vigilant, and firm in our thinking, rejecting such notions before they become more commonly accepted in society.)

Now that we know what should and should not be composted, here is a link that explains how to compost those organic materials you've collected (*you can scoot past the "fluff" to [How to Compost](#)*)

Time to get creative- collect up those grass clippings, leaves, offer to shovel out your neighbor's hen coop if they'll let you have the manure, things like that.

Save up those potato peelings, stuff that has gone bad ("science experiments") in the fridge, you get the idea.

You can also grow [comfrey plants](#). They are great biomass producers; additionally comfrey has medicinal properties.

However, the FDA poo-poops [comfrey](#), perhaps because comfrey actually works. *(Disclaimer: I am not a certified herbalist or healthcare professional, so please do your own research and come to your own conclusions, and don't take my opinion here as medical advice. :))*

Another plant I want to get more of, is [cup plant](#). It is a great biomass producer. Now, I'm gonna shift gears and briefly mention some products that you can buy, to boost your soil while you're waiting on your compost to finish.

There are pelleted, dried [chicken manure](#) that you can buy. It's been processed, so it won't burn your plants out like raw chicken manure can do.

You can also buy [blood meal](#) (for nitrogen) or [bone meal](#) (for phosphorus), which are by-products of the meat processing industries. [Greensand](#), which is getting harder to come by in these strange times, is a good potassium and trace mineral additive.

And, if you want to grow your soil AND food at the same time, plant beans or peas, especially dry beans where the plant has time to come to full maturity.

Beans and peas are legumes, and can be used to get nitrogen into the soil.

But, I believe the best food for the soil life, and the biggest bang for your buck, is to get compost piles working and use that compost.

Mimicking God's design in Creation, in our gardens, is the best and easiest way to build lasting soil fertility!

# The Preponderance—Planning

While working on my [Master of Public Administration Degree](#) at [Northern Michigan University](#) I attended a Community Planning class taught by [Dr. Stephen DeGoosh](#). It was one of the best classes I've had during my academic career. The value of Public meetings and the emphasis for comprehensive planning was key in assessing a communities preparedness.

*Good leaders always have a flexible plan; idiots don't.* [Me]

Before Democrats took over local governments and lawyers took over the Democrats, and Paul Ryan, Mitch McConnell and other Democrats opened the Border, incorporated cities, townships, and [counties or parishes](#) had paid professionals to complete studies in order to assess assets and projections to prepare for population growth or shrinkage, which includes transportation, housing, public facilities, and land use. The latter is why God invented zoning ordinances and why building permits are required.

What does the comprehensive plan contain? In some states the contents of a comprehensive plan are mandated by enabling legislation, while in others the contents are within the discretion of the local government. While every comprehensive plan is unique, in general, all address four topics: (1) existing conditions, (2) goals and objectives, (3) implementation strategies and (4) the future land-use map. [1]

The lack of understanding and inability to plan leads to bad judgment calls like those provided during the COVID lock-down disasters across the blue states and the murder of thousands because they were denied access to prophylactic prescriptions.

In Michigan, lying and denying was the grand scheme by Democrats:

MDHHS, for its part, couldn't say whether any nursing home deaths were linked to the transfer of COVID-19 patients from hospitals. Instead, the health department cited a University of Michigan Center for Health and Research Transformation report with preliminary analysis that showed no evidence of transmission between COVID-19 patients admitted from hospitals to nursing home residents in hubs. So, why plan?

Since 2001, the US federal government dedicated significant funding and focus toward local, state, federal, and international preparedness for public health emergencies and disasters.<sup>1,2</sup> In the years immediately following the September 11, 2001, terrorist attacks and subsequent anthrax attacks, much of that focus was targeted at addressing terrorism—specifically, bioterrorism.<sup>3</sup>

Over time, priorities, policies, funding, and focus shifted away from terrorism and toward improving public health preparedness for many types of emergencies, as well as toward reinforcing the spectrum of preparedness activities from prevention through response and recovery.<sup>4</sup> [3]

Of-course the outbreak of a SARS virus was nothing new;

2012: October 5: The National Select Agent Registry Program declared SARS-coronavirus a select agent. A select agent is a bacterium, virus or toxin that has the potential to pose a severe threat to public health and safety. [4]

The consequences of no planning, or even bad planning, can have consequences that affects entire communities. The influx of hygienically-challenged illegal aliens into any community poses health and safety concerns, especially [drug-resistant TB](#).

The intentional failure to require the vetting of persons from 161 +/- nations has created a national security threat not seen since the [War of 1812](#). The inability to evaluate and the dysfunctional political atmosphere has the U. S. poised against the execution wall.

Most dangerous is the lack of accountability among the advocates and their enablers.

## The Explosive Durham Report Proves Republicans Can't Afford To Cower In The Fight Against Government Weaponization

When Special Counsel John Durham released his explosive [306-page report](#) about the Russian-collusion hoax on Monday, he merely confirmed what many of us already knew: the Obama Administration colluded with Democrats and the corporate media and weaponized the FBI to take down former President Donald Trump before he was even elected to office.

For years, the government, sworn to protect the people, created a partisan scheme to take down an American citizen because he threatened the deep state's near-total grip on power. Durham's report was critical because it exposed the years of corruption and "[confirmation bias](#)" fueling the "Russia Russia" lies.

Uncovering and punishing, however, are two different things, and Durham, despite bringing charges against two known hoaxers, was mostly successful at establishing that the government levied a massive abuse of power against its citizens.

Now the ball is in the GOP's court. Ever since they took back the House of Representatives in the 2022 midterm election, Republicans have honed in on the corruption that plagues Democrats like President Joe Biden, the Department of Justice, and intelligence agencies like the FBI.

So far, Republican-led investigations are [making good progress](#). Yet, at the end of the day, committee hearings, letter-writing campaigns, and press conferences are empty threats to people like former FBI Director James Comey, who repeatedly [refuses to answer questions](#) about his role in the Russia collusion hoax.

The GOP knows corruption at the DOJ and FBI is deeply rooted and, as evidenced by the FBI's [reported retaliation campaign](#) against whistleblowers, ongoing. This is exactly why Republicans must leverage the momentum they gained from Durham

to punish those who weaponized and continue to weaponize themselves against the American people.

As the 2024 election cycle rapidly approaches, it's likely tempting for Republicans to slow their quest for truth and justice among the swampy ranks of the bureaucracy. Any balking in the face of the copious evidence Durham provided, however, is inexcusable and no better than the GOP establishment's perfidious reaction at the beginning of this years-long scandal.

When allegations that Trump colluded with Russia to steal the 2016 election were first placed in corporate media newspapers on propaganda press TV screens, few Republicans were willing to defend their party's candidate. Even fewer agreed with Trump's decision in early 2017 to fire FBI Director James Comey for his role in the government's vile election interference.

[Veteran Republican legislators](#) like then-Senate Intelligence Committee Chairman Richard Burr, Ben Sasse, Lindsey Graham, Rob Portman, Lisa Murkowski, and John Thune [quite literally knew better](#) than to trust the man suspected of leading a coup against the 2016 presidential candidate. Yet, instead of focusing their efforts on punishing the FBI for warring against the will of the American people, these GOPers said Comey was a "fine man" who didn't deserve the wrath of the new president. Then-Senate Majority Leader Mitch McConnell even recommended Obama-favorite Attorney General Merrick Garland, who is the current subject of multiple weaponization probes by congressional Republicans, to [take over the FBI](#).

Even now, as corporate media outlets [repeatedly spew lies](#) about the circumstances surrounding the FBI's decision to illegally spy on the Trump campaign, Republicans could do more.

"The FBI allowed itself to be hijacked and weaponized by political actors to target a political rival during a presidential election and administration. Restoring its integrity, if that's even possible, will

take humility, transparency and accountability," Sen. Chuck Grassley [said](#) in a statement on Monday.

The FBI has the opportunity to, as Grassley put it, "start today" by responding to Republicans' demands that the FBI hand over information about its lack of investigation into Biden's family corruption.

Grassley asked, "We know the FBI relied on unverified claims to relentlessly target a Republican president. What did the FBI do to investigate claims involving a Democrat President?"

It's a fair question since the Biden administration's FBI and DOJ have remained unresponsive to congressional requests and inquiries related to the Biden family business. Yet, it's a question that will presumably remain unanswered by the FBI without any promise of recourse.

In recent months, Republicans [repeatedly](#) flirted with the notion of defunding the FBI. Every time that threat rises to prominence, however, it is [quietly put to bed](#).

Why is the GOP scared to make an example of a clearly corrupt and partisan agency? The FBI [is clearly not sorry](#) for wasting taxpayer dollars on a blatantly partisan scheme targeting the political opponents of Democrats.

Backing down from the Russia collusion hoax now just because Durham's chapter is closed would signal an unforgivable retreat in the [battle for American democracy](#). Any Republican that chooses the path that the establishment chose in 2017 at the beginning of one of the biggest smears in American history is, at best, a coward, at worst, an accomplice to the Democrats' radical institutional takeover.

If Republicans want to hold the federal government accountable for waging war against its own citizens, they must act now or risk losing the chance forever.

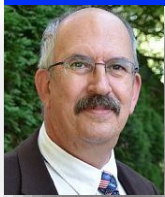

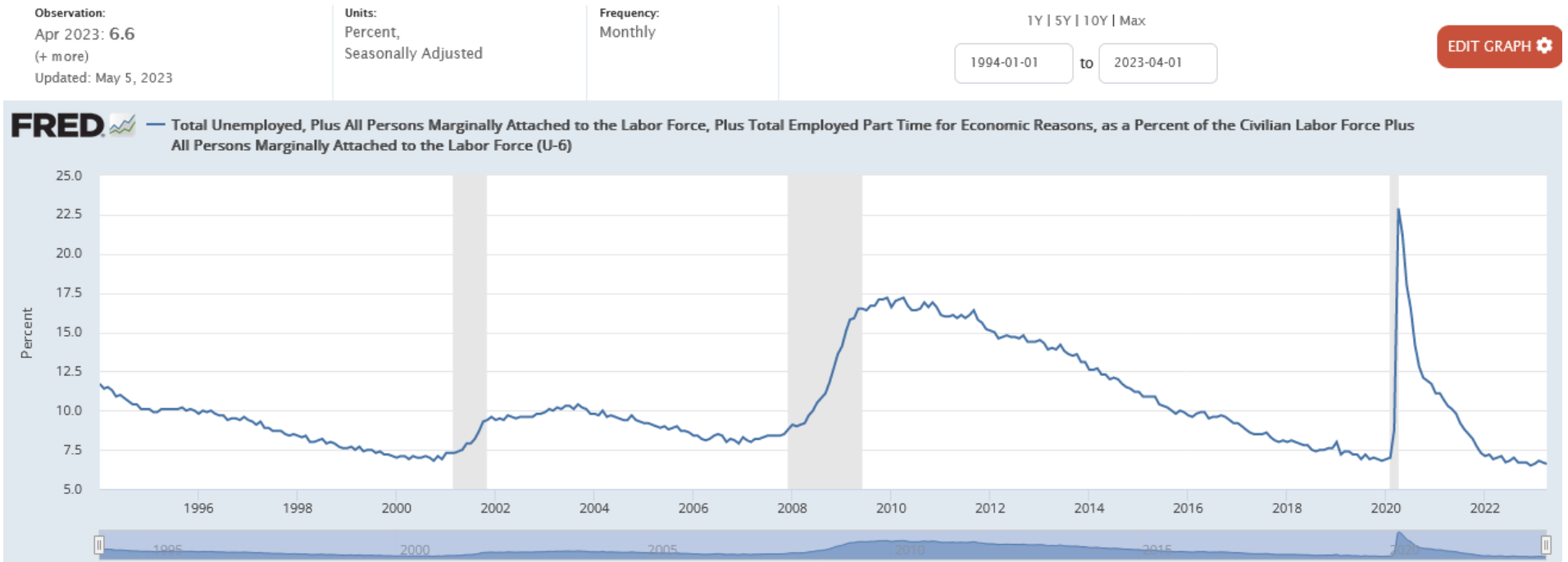
Let's try to fix stupid is 20-easy steps.

- 1.** Red-flag laws must include a 10-year felony and \$10,000 fine for falsely giving testimony accusing any person of being unfit to own or possess a firearm.
- 2.** Election integrity laws must include a 10-year felony and \$10,000 fine for falsely voting, permitting someone to falsely vote, or engaging in any election fraud.
- 3.** Criminal Intent should be reinstated in all criminal cases and anyone who has an intent to falsely accuse a person of a criminal act should face a penalty of 10-years and \$10,000 fine.
- 4.** Telemarketers calling persons on the DONOTCALL.gov listing should face a civil penalty of \$1,000 payable to the residence receiving the call and a \$500 criminal penalty, per violation of the registry.
- 5.** Illness and physical anomalies whereas a person or group of persons knowingly withheld a medicine, treatment, or procedure that would cure an illness or correct a physical anomaly should face a civil penalty of \$1,000 per week payable to the person with the illness or physical anomaly and a criminal penalty of \$500 per week per person.
- 6.** Political sabotage by a person or a group of persons which intentionally misleads the electorate with false claims against an opponent, or false claims on an issue that is to be presented to the voters, or who fails to provide all the information and a clear explanation of the motivation of the proposal should be fined \$1,000 per vote cast after-the-facts have become known.
- 7.** Global Climate Crisis scientific data that is promoted as being legitimate but is learned to be false shall result the re-

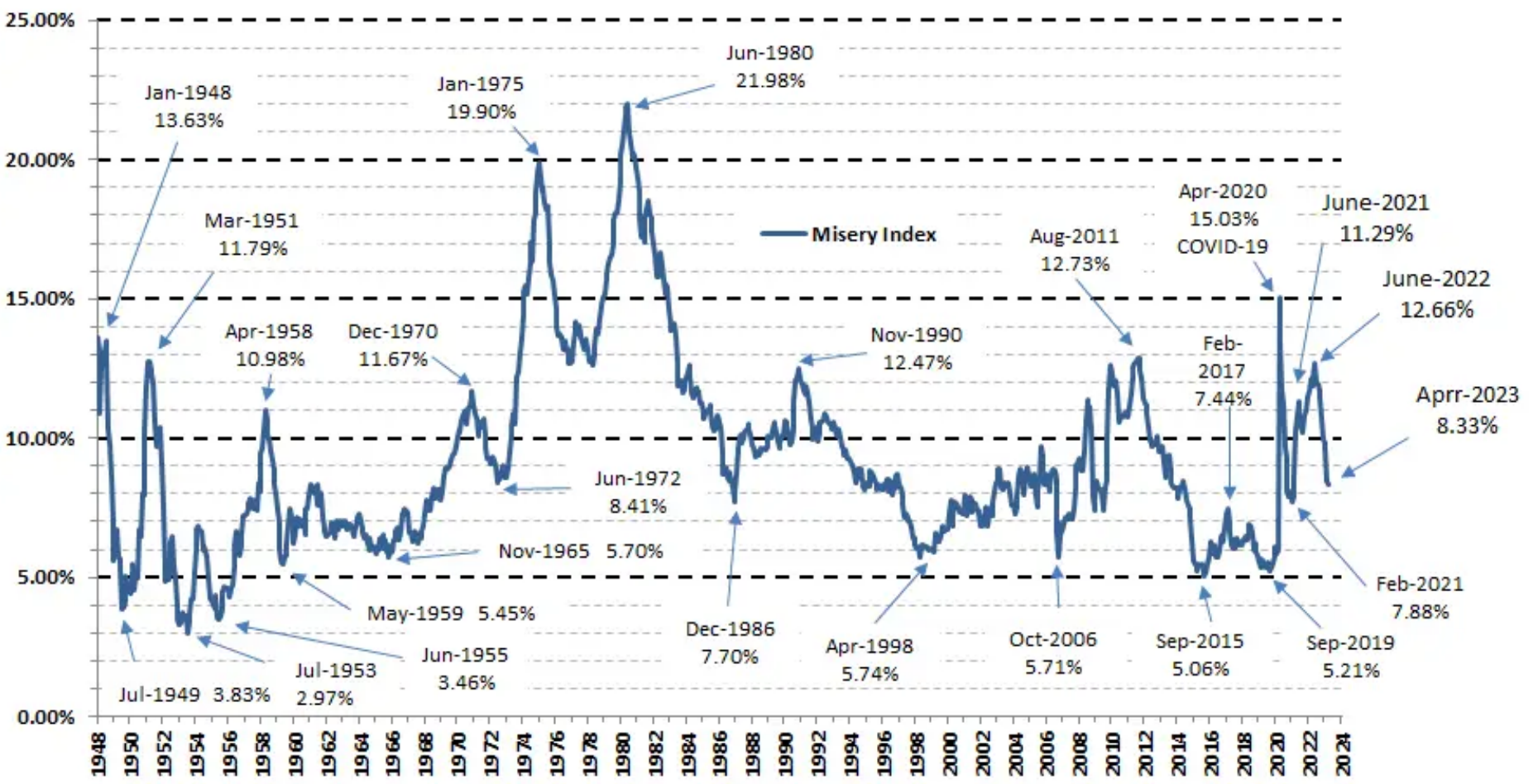
fund of all appropriated monies, including monies from private donors, with a 10% penalty, and each individual that had knowingly falsely substantiated the scientific data in order to receive such funding, or for any other purpose, shall face a 10-year felony and \$10,000 fine.

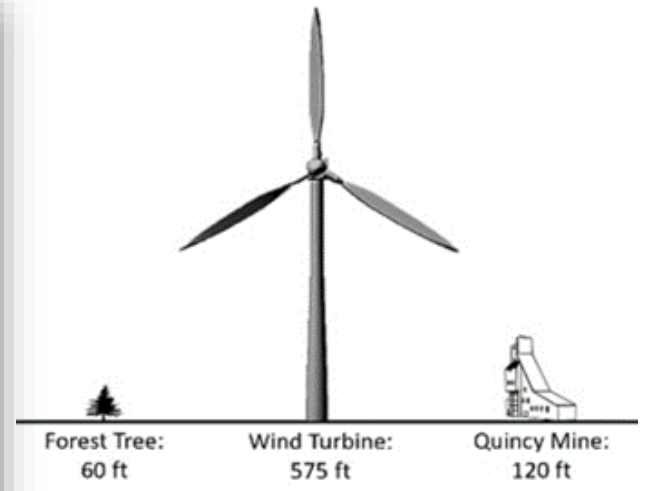
- 8.** Alternative energy endeavors that have proven to be highly efficient but were not marketed for whatever reason shall result in a refunding of the energy costs absorbed by those using the inefficient energy sources from the first day of each calendar each year to the last day of each calendar year by the person or group of persons withholding any such alternative energy.
- 9.** Presidential authority to supersede laws regarding immigration, energy, national sovereignty and security, and getting involved in international conflicts should be rescinded and require a 60% vote of each House to change such policies or laws.
- 10.** Balanced budget should not have to invoked on any legislative body by the voters, it's common sense, but to make sure representatives are dedicated to being more mature about spending, they should pass a law that prevents spending which exceeds the income and failing to do so shall halt all wages and benefits for elected persons until it is accomplished.
- 11.** The U.S. national debt reached the debt ceiling of \$31.41 trillion in January 2023.<sup>1</sup>The U.S. Treasury manages the U.S. national debt through its Bureau of Public Debt. The bureau classifies that amount into two broad types: intra-governmental holdings and debt held by the public. See #10.
- 12.** Spending by governments is way beyond the affordability of the taxpayers; the only appropriations should be for the direct goods and services. Even Social Security and Medicare should dissolve with a new workforce that must invest in their own future without government controls and incentives.

- 13.** Income and sales taxes are way too complex and expensive and they vary from state-to-state; a national flat tax at 10% with no deductions should suffice, even in war time—states are free to do what they wish, but need to conducted a comprehensive state plan to evaluate the cause-and-affect.
- 14.** Eliminate all obsolete, unnecessary, and redundant government departments, agencies, and services.
- 15.** Political party representatives should not be elected until after conventions in order to allow newly elected persons to nominate and elect state and national leaders; the leadership of all pollical parties should have co-chairs consisting of a biological male and a biological female.
- 16.** Remove Primary Elections from the general public and make it a highly partisan Democrat and Republican endeavor for as long as the US wishes to use the political party system. Persons not nominated can seek the nomination of a different party, which should be held within 60-days of the June election.
- 17.** Move the Primary Election day to the second Tuesday in June so candidates have the full summer to campaign, which includes Independence Day. This is especially important for local races.
- 18.** Prevent all legislative action after the 30th of September during an election year, including budgets, to make all actions a matter of public record before the November election.
- 19.** Require any person serving in as an elected official in one capacity who is to run for another position to resign the current position to do so; persons seeking elected office need to do so on their own time and not receive pay.
- 20.** Prohibit governments or persons from any country not the US from purchasing land; only persons earning US citizenship shall enjoy all freedoms.

## U.S. to Purchase 3 Million Barrels of Oil at \$80/Barrel to Replenish Emergency Oil Reserves Depleted by Joe Biden – After Democrats Blocked Trump from Purchasing \$24/Barrel Oil 3 Years Ago

On Monday, the U.S. Department of Energy (DOE) announced that it will purchase up to 3 million barrels of oil for the Strategic Petroleum Reserve (SPR) after the Biden regime aggressively drained the US stockpile.

A record-breaking 180 million barrels were released from the SPR by the Biden regime. According to the US Energy Information Administration, the SPR held about 638 million barrels of oil when Biden took office in January 2021. It has dropped to its lowest level since October 1983 today, at 362 million barrels.

“Today’s announcement advances the President’s replenishment strategy following his historic release from the SPR to address the significant global supply disruption caused by Putin’s war on Ukraine and provide a wartime bridge for domestic production to increase,” according to DOE’s [news release](#).

Adding, “DOE is committed to executing an SPR replenishment strategy that provides the best deal for taxpayers— aiming to repurchase crude at a lower price than the average of about \$95 per barrel it was sold for in 2022, while strengthening energy security by providing certainty to the industry in a way that helps encourage near-term supply. DOE intends to purchase more oil later this year.”

Recall, Joe Biden wanted to fill the Strategic Reserves with [\\$80 per barrel oil](#). Just three years ago the Democrats blocked President Trump from filling the Strategic Oil Reserves at \$24 per barrel.

Reuters [reported](#):

U.S. Energy Secretary Jennifer Granholm had signaled to lawmakers late last week that her department could start [repurchasing](#) oil for the stockpile soon, after a record sale last year during a spike in prices that pushed the level of the reserve to the lowest since 1983.

The new purchase would be for sour crude oil delivered to the Big Hill SPR site in Texas sometime during the



month of August, according to the [announcement](#).

The administration has said it would start to buy oil back into the reserve when prices are consistently at or below \$67 to \$72 per barrel, well-below the level at which the oil had been sold, so that taxpayers can get some benefit.

U.S. crude prices were around \$71 a barrel on Monday.

Granholm last month had signaled that repurchases would happen closer to the end of the year, after maintenance on two of the reserve’s four sites on the coasts of Texas and Louisiana.

Biden waged a war on domestic oil production as soon as he was sworn into office. Biden’s energy policy is to take from the nation’s oil reserves rather than allow American companies to drill and produce American oil.

On his first day in office, Joe Biden killed off [42,100 jobs](#) by ending the construction of the Keystone XL Pipeline.

Biden announced he was going to [open the US oil reserves](#) last 2021 even before the Ukraine-Russia war, in an effort to lower gas prices ahead of the holiday season.

The Gateway Pundit reported that last November 2021 Biden regime had [sold America’s reserves of oil](#) to Asia. How does this make

Biden’s action violated the 1975 Energy Policy and Conservation Act which [established](#) the Strategic Petroleum Reserve (SPR), Mark Robeck — the former deputy general counsel for energy policy at the Department of Energy (DOE) [during](#) the Trump administration — [wrote](#) in a Washington Examiner editorial Thursday. The law prohibits the release of emergency SPR stocks unless there is a severe domestic supply shortage, an act of sabotage or natural disaster, he said.

“In short, Congress imposed a predicate circumstance of a ‘severe energy supply disruption’ for the president and secretary of energy to authorize the sale of crude oil from the SPR, and such a disruption simply does not exist right now,” Robeck wrote in the editorial. “The unlawful release of oil from the SPR threatens national security by depleting the SPR absent a true supply disruption.”

On March 31, Biden [ordered](#) the DOE to release a million barrels of oil per day for six months, the largest release in U.S. history. Biden had also ordered a 30-million-barrel [release](#) on March 1 and a 50-million-barrel [release](#) in late 2021.

## Despite outcry, Michigan approves US\$175 million for Chinese-owned EV battery plant

A proposed Chinese-owned EV battery component plant in Michigan facing public opposition eked out a key legislative win on Thursday when the state's Senate Appropriations Committee approved US\$175 million in incentives by a 10-9 vote.

All six Republican members and three Democrats on the Senate Appropriations Committee voted against financing Gotion Inc's 700-acre project in Green Charter Township in rural Michigan. The vote was the final one needed to approve the transfer of state tax dollars, allowing officials to move forward. The Michigan House approved the funding last month.

Registered in California, the company is an American subsidiary of China-based Gotion High tech. For months, it has faced public and political backlash because of speculation over its alleged ties to the Chinese Communist Party.

At the hearing, Chuck Thelen, Gotion Inc's vice-president for North American operations, announced that the company had received clearance from the Committee on Foreign Investment in the United States (CFIUS), an inter-agency federal panel that reviews transactions involving foreign investments for possible national security threats.

"The committee determined that our proposed transaction was not subject to further review and we may proceed with the proposed transaction," Thelen said of CFIUS.

Before the vote, the senate panel also heard heated testimony from local elected officials, politicians and private citizens opposed to the plan.

"If you choose to give this money to Gotion, you are a traitor to this your republic, you are a traitor to your children's future," Kristina Karamo, chair of the Michigan Republican Party, said.

Marjorie Steele, who identified herself as a resident of Big Rapids, near Green Charter Township, said that people from townships and counties across the state were uniting and sharing their "resources, manpower, and grass roots activism" against Gotion.

A petition to recall Green Charter Township Supervisor Jim Chapman, who along with his board of trustees approved the project in December last year, was under way, Steele said. She warned that any lawmaker who voted in favour of China's Gotion would be considered "a black mole that needs to be expunged from our democratic republic".

Jerrilynn Strong, chairwoman of the board of commissioners in Mecosta County, where Green Charter Township is based, hailed the \$2.3 billion project for the more than 2,000 jobs it would create. She said that only a "small but vocal" group of "professional picketers" were opposed to the plant.

On Wednesday, five Republican state senators wrote to Michigan's US congressional delegation to "use all federal resources available to immediately investigate" Gotion High-tech for "ties or contracts with foreign countries that have an adversarial relationship" with the US.

The proposed plant is in line to receive more than US\$800 million in incentives and tax breaks, including the US\$175 million the committee approved on Thursday.



State Senator Sarah Anthony, a Democrat who chairs the appropriations committee, said her support for Gotion was based on the "transformative impact" of its project, which promises to "double the per-capita income in one of the poorest counties in the state".

In a statement after the vote, US Representative John Moolenaar, a Republican who represents the district where the project would be built, called funding Gotion a "historic mistake".

He noted that the 700-acre site is 100 miles from Camp Grayling where "Michigan National Guard have trained military partners from Taiwan to prepare for possible CCP aggression".

Moolenaar was among a bipartisan group of lawmakers who met with Taiwanese President Tsai Ing-wen in California along with US House Speaker Kevin McCarthy. Beijing considers Taiwan to be a renegade province, to be eventually united with the mainland, by force if necessary.

The charges against Gotion Inc reached new heights of oddness on Tuesday when state Senator Jonathan Lindsey, a Republican, said that the company could be helping the CCP extract lithium in Afghanistan and demanding an investigation into its links to the Taliban. Lithium is a key mineral used in making batteries for electric vehicles.

In response, Thelen told a local news outlet that "it was his understanding that there is a company spelled 'Gochin' that is actively engaged with the Taliban in Afghanistan about buying lithium".

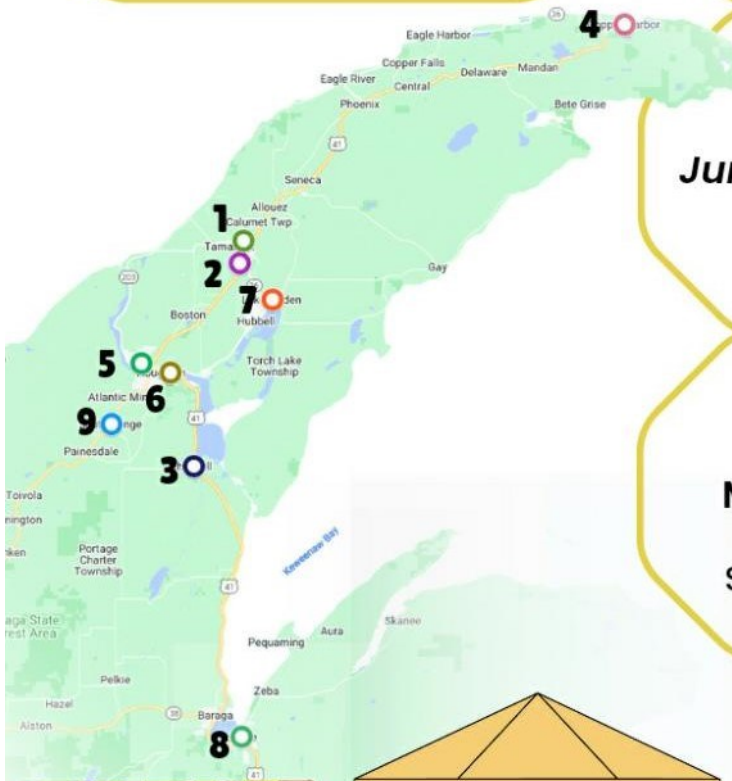

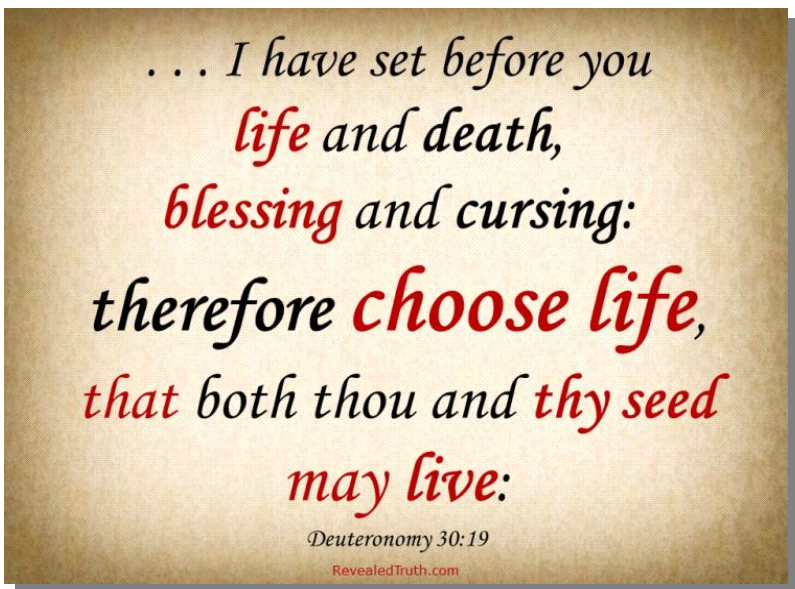

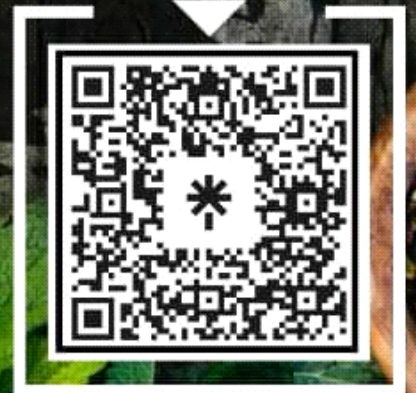

## Thai Iced Tea Recipe

### Ingredients

- 4 cups boiling water
- 2 tea bags, black such as Assam, Orange Pekoe, Ceylon, or 2 teaspoons loose black tea
- 1 fresh lime, or lemon, squeezed for juice
- 1 to 2 whole cloves, or 1 green cardamom pod, smashed, or 1 star anise, or 1/8 teaspoon cinnamon or allspice
- 1/4 to 1/3 cup white sugar, to taste
- A good shake of salt, to taste, for garnish
- Half and half, to taste, optional
- 1 cup Carnation condensed milk, optional
- Coconut milk, to taste, optional
- Ice cubes, to taste

Gather the ingredients.

Boil 4 cups water in a pot. Add the [loose tea](#) or tea bags. Stir and boil at least 5 to 6 minutes while adding the other ingredients.



Squeeze in the lime or lemon juice and add the salt, plus the spice of your choice. Continue boiling 5 minutes.

Add sugar, starting with 1/4 cup. Stir to dissolve. Taste test for sweetness, adding more sugar (1 to 2 tablespoons at a time) until your desired sweetness level is reached.

If you have been using tea bags, use a spoon to press them to the side of the bowl before removing to extract as much of the tea as possible. If using loose tea, strain as you transfer tea into a jug. Refrigerate until cold.

Pour out into glasses. If adding milk, fill between 2/3 and 3/4 of the glass with tea and top up with milk, cream, or coconut

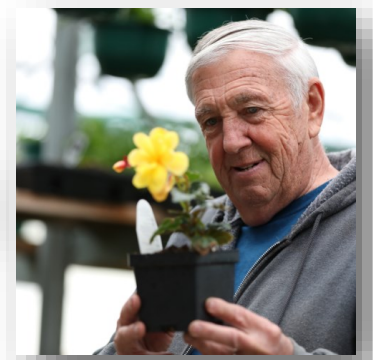
