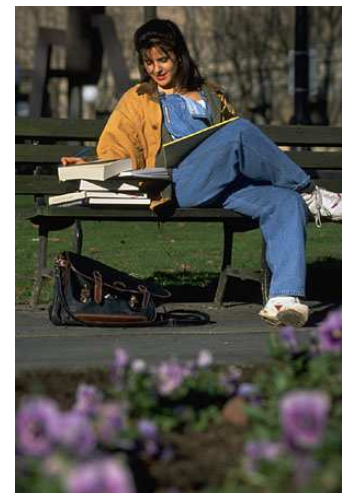


## I X L: I EXCEL—A HERMANSVILLE, MICHIGAN MOTTO

## Coming Soon – UP Big Deal II By C. J. Williams

Have you heard about the latest chunk of Upper Peninsula real estate to go on the market? Yup, 1.1 million acres of U.P. forestland is now up for grabs, and you can bet your swampers that the land grabbing, land-use control-freak, eco-whackos are salivating over it like whoopoorwills in a blueberry swamp.

The hot off the press news didn't exactly burn up the U. P. media wires or make immediate headlines in local dailies, but then maybe the Yooper robot-reporters were too busy defuzzing their navels to pay attention to what's happening in the state, let alone the UP.

However, Detroit Free Press staff writer Hugh McDiarmid got the scoop and spilled the beans on September 23rd, probably after getting a tip from one of the drooling eco-nuts.

According to McDiarmid, the land, which will be sold in two blocks, includes 650,000 acres owned by Escanaba Timber that went on the market in August and another 452,000 acres now quietly being shopped out by International Paper.

A map, also published in the Sept. 23rd Free Press, shows the break-down of the "for sale" timber land as follows: Keweenaw, Ontonagon, Baraga, and Marquette Counties, over 100,000 acres per county; Menominee and Iron Counties, 90,000 to 100,000 acres per; Houghton, Gogebic, Delta Counties, 50,000 to 89,000 acres per; Dickenson and Schoolcraft Counties, 30,000 to 49,000 acres per; and Alger, Luce, Chippewa and Mackinac Counties, 14,000 to 29,000 acres per.

McDiarmid's headline, "UP Land Sale May Put Public Access In Peril", and several paragraphs contain what's known as "language deception" designed to instill a fearful panic that, unless something is done IMMEDIATELY, Yoopers and tourists will be SOL when it comes to communing with nature in an up-close and personal way, like with a fishing pole, hunting rifle, or berry bucket.

We've been on our way to SOL ever since the eco-whackos set up shop in the UP several years ago, so why panic now? Besides, the eco-nuts already have another conservation easement scheme up their slimy eco-green sleeves and a bedside manner that's allowed them to crawl between the sheets with corporate timber barons for years, so

we might as well kick back and watch the show, eh?

Of course, McDiarmid was so taken up by eco-nut language deception that he made no reference to the UP stakeholder tables and skewed "public" meetings where users of public recreational land must fight for traditional access to what's already under government control; for the privilege of temporary access thrown like crumbs to the dumber-down Yooper sheeple so they adjust to land-use control an itty-bitty bit at a time without going completely ballistic.

McDiarmid made no reference to the fact that Michigan can't even afford to operate its state parks or that the feds have had to shut down several campgrounds because money is an issue, or so it's claimed while funding is found for more and more land grabs and eco-nut grants. Then there's that matter of the DNR not being able to afford PILT on what it already owns and also handing management of land over to an "alternative conservation organization", such as the one looking to find alternative funding to make up for a lack of deer hunting license revenue when sportsmen finally figure out what ecosystem habitat management is really all about.

He made no reference to the fact that the UP economy is rapidly grinding to a halt because the tax base gets no boost from new development, residential or industrial-wise, and because sign waving environmentalists don't want paper mills or mines anywhere near their pristinely fragile roost.

Certainly, he made no reference to the UN Biospheres at Isle Royale and the tip of the Lower Peninsula, or mentioned that the eco-whackos and their government agency cronies have been building a bio-reserve of millions of acres to gain control of our natural resources, including all the fresh water in the Great Lakes Basin.

Most definitely, he made no reference to the thousands upon thousands of acres already owned by state and federal agencies and tax-exempt land trusts whose members speak with forked tongue when promising public access forever, all the while turning

the UP into a huge bio-reserve that will eventually be off-limits to human intrusion so the beasties can have their special places to proliferate.

The ink isn't even dry on the last \$58 million land grab scam orchestrated by Forestland Group LLC, the Nature Conservancy, and Governor Granholm, but good ole' Jenny is back in the real estate business once again.

According to Garret Johnson, chief conservation officer for the Michigan Chapter of the Nature Conservancy (TNC), both TNC and Granholm have begun discussing "an effort to protect part of the 1.1million acres". And, according to a Granholm spokeswoman, the governor has already spoken directly with at least one of the timber companies, urging "them" to consider a conservation easement... another one, right after the state has had to cough up \$16 million for the Great UP Land Deal.

Wow, shall we hold our breath and pray to Ghia that the timber lords agree? Fat chance they'll disagree since they've been smoozing land deals with TNC for years; since Mark A. Suwyn, Chairman of Escanaba Timber's Board, is a past president of International Paper's Board, a co-chair of the Oregon TNC's "The heart of Oregon" campaign, and also a TNC Oregon Chapter Trustee; since Pat Noonan, International Paper Director, served as TNC's president for several years and then founded the Conservation Fund; and since both International Paper and Mead have bought pricey seats on TNC's International Leadership Council, a collection of big shots from some of the worst polluting corporations in America.

Both Escanaba Timber and New Page (formerly MeadWestvaco) are controlled by Cerberus Capital Management LP, which is named after a three-headed dog that supposedly guards the gates of hell. Cerberus is a New York based private hedge fund company that specializes in buying the debt of troubled companies (\$2.3 billion last May for MeadWestvaco's Papers business and associated assets) in hopes of profiting on their restructuring.



New Page and Escanaba Timber share some of the same officers and Escanaba Timber LLC, Dayton, Ohio, has entered into a long-term supply agreement with NewPage to ensure that approximately 900,000 acres managed by Escanaba Timber will remain the key source of wood supply to the NewPage mills in Chillicothe, Ohio; Wickliffe, Kentucky; and Escanaba, Michigan.

So now the Guv, who McDiarmid says is struggling to keep the state's economy above water, thinks she needs another conservation easement on more UP land, but what exactly is a conservation easement?

A conservation easement is a restriction deeded to a qualified third party that permanently limits certain activities on real property in order to protect (control) conservation values such as biodiversity, water quality, wildlife habitat, or carbon sequestration.

The restriction stays with the property through successive owners and it reduces the "highest and best" economic use of the property so that the property's value reflects only the allowed uses, which may prohibit all but strictly limited forestry, agricultural, and possibly recreational uses of the property. If the landowner donates the easement as a gift, this reduction in value becomes a charitable tax deduction. An easement also can be sold to non-profit or government agencies to provide revenue.

Diane Katz, director of science, environment and technology for the Mackinac Center for Public Policy had this to say in October 2002 and it bears repeating today: "...state environmental policy should not be rooted in the assumption that only government can be trusted to safeguard natural resources. Both the environment and citizens would derive much greater benefit if the state controlled less, not more property."

## Stand fast: Bills clarifying right to firearm self-defense should pass

Being able to defend yourself in your own home is a long-held principle of common law. Two state House bills co-sponsored by a mid-Michigan lawmaker bolster this self-defense tenet.

Lawmakers should pass this legislation.

House Bills 5142-43 give Michigan residents a good deal of immunity from criminal prosecution or civil lawsuits if they kill or injure someone breaking into their homes. The same law would apply to residents in their cars, and assumes that someone trying to break in means harm to the occupants.

The legislation also eliminates a requirement that someone defending themselves and their property from intruders must retreat before respond-

ing.

It is true that many firearm experts believe it's safer to run, not confront. But in a split-second decision, if a person chooses to stand his or her ground, that person should not be liable.

The legislation, introduced by Rick Jones, R-Grand Ledge, and Tom Casperson, R-Escanaba, is similar to a Florida law that takes effect Oct 1. There is a significant difference in the legislation, however. The Florida law allows Floridians to defend themselves in public places if they think they are threatened.

The Jones-Casperson bills restrict these self-defense measures to one's home or vehicle.

The immunity provided by the legislation is not absolute. For example: The law would not protect a homeowner if the "attacker" turns out to be a police officer who's identified himself and is acting in an official capacity. The bills' self-defense protections might also fall short if the "attacker" is someone who has the right to be inside a home, such as a property owner.

Overall, though, these bills clarify and strengthen the belief that it is no crime to defend oneself when threatened.

## Gun Control Groups Take Aim at Mich. Bill [http://news.yahoo.com/s/ap/20050921/ap\\_on\\_re\\_us/deadly\\_force](http://news.yahoo.com/s/ap/20050921/ap_on_re_us/deadly_force)

Earlier this year, gun control advocates failed to block a Florida bill allowing people to use deadly force in the street to defend themselves. The advocates vow not to let that happen in Michigan.

The battle in Michigan over the so-called deadly force legislation is important for both sides in the gun debate. It could open the doors to similar laws across the country — a top priority for the National Rifle Association — or stop the effort in its tracks.

The Brady Campaign to Prevent Gun Violence and the Million Mom March are sending out news releases criticizing the legislation and are calling lawmakers in an attempt to keep the bills from getting out of the House Judiciary Committee.

"This is a byproduct of having missed the boat in Florida," said Peter Hamm, director of communications for the Washington-based Brady Campaign. "We have been watching like a hawk for this to surface in other states."

The Michigan legislation would eliminate the requirement that people being attacked must retreat before responding with deadly force. It

would allow people who feel threatened, even in a public area, to "meet force with force" and defend themselves without facing criminal or civil prosecution.

State Reps. Tom Casperson and Rick Jones, both Republicans, introduced the bills. They said that although it would be unlikely for a crime victim to face criminal charges for killing someone in self-defense, a law is needed to guarantee it.

"Our intent is to protect crime victims who are in imminent danger of losing their lives," said Jones, a former Eaton County sheriff. "This does not put more guns on the street. This will not create the OK Corral."

The law is identical to the Florida measure, which allows people who feel threatened anywhere — on the street or even in public places such as a bar — to defend themselves with deadly force.

Without the threat of prosecution, some of the thousands of Michigan residents carrying concealed weapons may be more likely to use them, said Sarah Brady, chairwoman of the Brady Campaign.

The group is named for her and her husband, Jim, who as President Reagan's press secretary was shot and

severely injured during a 1981 assassination attempt.

"There are a lot more guns on the street and then you're going to get the right to use them willy-nilly? That doesn't bode real well," Brady said during a telephone interview.

If it passes, Michigan would be the second state with such a measure. A similar bill has been introduced in Alabama, but lawmakers in that state are not scheduled to meet again until January 2006.

The legislation may win approval in the House and Senate, where half of each chamber was recently endorsed by the Michigan Coalition for Responsible Gun Owners, a statewide gun rights advocacy group.

It is unclear whether Democratic Gov. Jennifer Granholm would sign the legislation if it reached her desk. Spokeswoman Heidi Hansen said the administration is reviewing the two-bill measure.

Gun control activists in Michigan are calling their lawmakers and sending them postcards and e-mails to explain their opposition, said Shikha Hamilton, head of the state's Million Mom March chapter.

"The scariest part is that you're removing the duty to retreat. That's

really there to preserve life," said Hamilton. "And if you take someone's life you should have to answer to the police. ... No one is in jail right now for protecting their family."

This year, the Brady Campaign gave Michigan a grade of "D-plus" for not requiring background checks at gun shows, not holding adults responsible for leaving loaded guns around children, and having no safety standards to limit Saturday night specials. Some 111,600 concealed weapon permits were issued in Michigan since 2001.

Rep. William Van Regenmorter, chairman of the House Judiciary Committee and known as a strong supporter of victims' rights, said he is considering the legislation.

"I think there's a fundamental right to protect oneself," Van Regenmorter said. "But I want to know what the practical implications are, and there are probably quite a few."

BATON ROUGE, LA. - The White House announced today that President Bush has successfully sold the state of Louisiana back to the French at more than double its original selling price of \$11,250,000.

"This is a bold step forward for America," said Bush. "And America will be stronger and better as a result. I stand here today in unity with French Prime Minister Jack Sharaq, who was so kind to accept my offer of Louisiana in exchange for 25 million dollars cash."

The state, ravaged by Hurricane Katrina, will cost hundreds of billions of dollars to rebuild.

"Jack understands full well that this one's a 'fixer upper,'" said Bush. "He and the French people are quite prepared to pump out all that water, and make Louisiana a decent place to live again. And they've got a lot of work to do. But Jack's assured me, if it's not right, they're going to fix it."

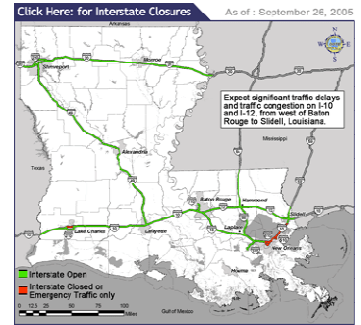
The move has been met with incredulity from the beleaguered residents of Louisiana.

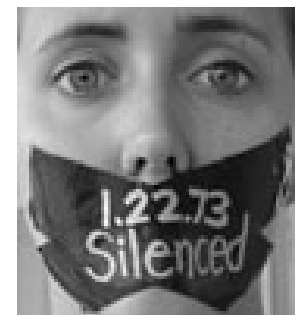

## HOW DESPERATE ARE WE WHEN WE REPRINT AP CRAP?

In most instances the discerning eye would catch the source of our reprinted articles and photos, and at times Associated Press (AP), the nation's leading communist print and radio media, are placed in the Yooper Scooper. Usually, there is an overwhelming irony to the story that poses a substantially clear subjective analysis on issues.
