Illinois Family Institute reported that on September 28 pro-life Senate Majority Leader Bill Frist (R-Tn.) filed a "cloture petition" on S. 403, the Child Interstate Abortion Notification Act (also known as the Child Custody Protection Act).

Agape Press gave the following sad account on October 3: Democrats Kill Parental-Rights Bill as Senate Session Adjourns. "Frist had hoped the procedural move would force a vote on a bill that the Senate had passed earlier on a 65-34 vote -- and the House had passed 264-153 -- but his filing of cloture required at least 60 votes. On Friday, he could only muster 57; fifty-one Republicans and six Democrats ([see roll call vote](#))."

Lanier Swann, Concerned Women of America's director of government relations, blames "partisan antics" for the cloture result.

Swann sees the vote as a victory for child predators. Isn't that exactly what the Democrats were concerned about in Foley's situation?

"There are many ill-intentioned adults who would like to cover up their actions by silencing an impregnated minor," Swann remarks. "The Child Custody Protection Act would have prevented this heinous crime from happening by requiring parental consent in states that already have laws on the books."

Durbin has a 100% scorecard rating from the radical homosexual D.C. lobby group, has a pathetic abortion record and then stopped the parental notification legislation. How dare Senator Dick

Durbin point an accusing finger at Congressman John Shimkus and Speaker Dennis Hastert and the Page Program?

The Louisiana parents of the page in question believe the situation has been properly handled. In the fall of 2005, Congressman Rodney Alexander, whose office sponsored this young man, became aware of the e-mails and he called the parents and told them he thought the e-mails were overly friendly but he did not think - nor did the parents - they were offensive enough to warrant an investigation.

"These instant messages, which have only recently surfaced as a result of the news of the ambiguous e-mails received by our son, are separate matters," the parents said. They continued:

"We would like to express our support for our congressman, Rodney Alexander, whose office sponsored our son's position as a House page. As far as we know, Congressman Alexander's conduct in this matter has been beyond reproach. He has tried his best to do what we have asked him to do from the very beginning: Namely, to protect the privacy of our son and family from the intense media scrutiny we are now having to endure.

As a young man with integrity who had the courage to question the intention of the e-mails, we respect and honor our son as a hero. Despite his courageous actions, he is becoming a victim due to the harassment by some of the media. Please honor our request that we be left alone. There is nothing more that we can contribute to this ongoing matter. He is not the story, and we feel this intense media scrutiny could endanger our son and family. We have no intention of discussing this further. Thank you."

How many parents would send their 16 year old son or daughter to Washington D.C. without knowing exactly who would be their guardian? Would they send them to school, boy or girl scouts, church, an athletic program, or any event that draws pedophiles to the candy store without knowing who would be spending time with them?

The parents of the young man in question were aware of what was happening. They trusted their son's integrity and felt the situation had been properly handled but he is now being victimized by the media.

Study: Fox News Impacted Elections—NewsMax.com

The introduction of the Fox News Channel had a small but significant effect on the presidential election in 2000, a study reveals.

Fox News was introduced into the cable programming of 20 percent of Americans towns between October 1996 and November 2000. Using voting data for 9,256 towns in 28 states, study authors Stefano DellaVigna and Ethan Kaplan investigated whether

Republicans gained votes in towns where the conservative news channel was available by 2000.

They found that in the presidential election, Republicans gained between 0.4 and 0.7 percentage points in the towns where Fox was available.

The researchers also found that Fox News significantly increased the GOP vote share for the U.S. Senate, by 0.8 percentage points.

"Fox News appears to have induced a generalized ideological shift," the National Bureau of Economic Research noted in a report on the study by its two researchers, further stating: "Since Fox News was available in about 35 percent of households in 2000, its impact on the national two-party vote share that year is estimated to be 0.15 to 0.2 percentage points, or 200,000 votes nationwide.

"While this vote shift is small . . . it is likely to have been decisive in the close 2000 presidential elections."

DO DEMOCRATS PUT OUR NATIONAL SECURITY AT RISK? By J. C. Powers

The susceptibility of the United States to terrorism was initiated under Jimmy Carter and ratified under Bill Clinton. Carter helped overthrow the Shah of Iran and advised the top 150 military commanders to acquiesce to the Ayatollah Khomeini. The religious leader summarily murdered the military commanders.

The overwhelmingly incompetent defense leadership during the Clinton Administration augmented the neglect of the national security problems facing the United States. The appointments made by Bill Clinton were of individuals who were politically like-minded, not necessarily competent. The collective group of Clinton appointees facilitated the catalyst for the September 11, 2001 attacks.

Under Bill Clinton our honorable military forces went to war under NATO and UN flags. Clinton also signed onto a pact with the UN that would subject our forces to go before an international court for war crimes. These are only a few of the internationalist moves made during the Clinton years. NAFTA and other agreements have acidic factors that are slowly dissolving our national sovereignty.

The Marine Barracks in Beirut, Lebanon was hit by a terrorist attack on October 23, 1983. The Marines had been deployed there as part of an international peace-keeping force. France was the first country to pull their troops out and was followed by other countries. President Reagan, who had no interest in tucking tail and running, had to make the decision to pull out in the spring of 1984 because the other nations had abandoned their posts. The international forces could have reacted by taking decisive action against terrorism.

Numerous news organizations were well aware of an incident involving Hillary Clinton. A lieutenant general, needing important documents signed, went to the White House residential quarters in uniform. The general was met at the door by Hillary Clinton who proceeded to scold him on their policy of no uniforms on that side of the White House. Mrs. Clinton told the general that if the papers were that important to go and change into something decent and come back. He did and resigned the next morning. Hillary Clinton now serves on the Senate Armed Services Committee.

Two real (as opposed to fake Valerie Plame types) CIA operatives in Northern Iraq advised their supervisors that the Kurds were preparing to launch a strike against Baghdad. The Kurds knew Saddam Hussein would flee the city to a safe house. Once there, the Kurds would level the safe house and free Iraq from the dictator. Each request for permission and support became more urgent. The Clinton White House did not respond. The Kurds decided they could no longer wait for the Clinton Administration to make up their minds and attacked. Their mission was compromised and the Kurds were slaughtered.

The two CIA operatives were ordered back to the states and criminally charged by Janet Reno for inciting a war. This was also the policy regarding the Northern Alliance in Afghanistan, which was also compromised and slaughtered.

Between 1974 and 1983 the Fuerzas Armadas de Liberación Nacional (Armed Forces of National Liberation, FALN) bombed approximately 120 U. S. targets. The group claimed responsibility for at least seven bombings and numerous attempted bombings in New York City alone. On March 15, 1980, the group invaded the Carter-Mondale Headquarters in Chicago and the Bush Campaign Headquarters in New York. In 1999, Bill Clinton ordered clemency (a pardon) for 16 members of this Puerto Rican gang. Jimmy Carter negotiated the pardon, which generated the radicals' support for Hillary Clinton's New York State senatorial bid.

In February, 1993, nearly ten years after the 1983 attack in Beirut, foreign-based terrorism from the Middle East arrived on American soil when the World Trade Center was bombed in the underground parking garage below Tower One. The bombing was not recognized as an enemy attack; it was treated as a criminal act.

In 1991, near the end of Desert Storm, which liberated Kuwait from Saddam Hussein, [Ramzi Yousef](#), born in [Kuwait](#), began planning the bombing. Yousef entered the United States with a fictitious Iraqi passport in 1992. In several letters warning of the impending attack on the WTC, Yousef demanded that the United States stop funding Israel and cease interfering in Middle Eastern countries' interior affairs. Eventually, Yousef's uncle, [Khalid Shaikh Mohammed](#), who gave Yousef both advice and funding to carry out the bombing, was implicated as a key planner of the September 11, 2001 attacks.

Jimmy Carter used the communist Romanian leader, Nicolae Ceaușescu, who also had strong ties with Arab terrorists, to negotiate a peace agreement between Israel and the PLO. Carter also spearheaded an agreement of peace between Israel and Egypt at Camp David, which remains the only successful Middle East agreement.

Jimmy Carter worked with [Leonid Brezhnev](#), the leader of the Soviet Union, to bring the SALT II treaty to fruition. Brezhnev was the leader who had no problem with the fact that his military ordered the shooting down of Korean Airlines, KAL flight 007, with 269 people on board.

Jimmy Carter and U. S. National Security Advisor Zbigniew Brzezinski started a \$40 billion covert training program for Islamic [fundamentalists](#) in Pakistan and Afghanistan. In January of 1981, Carter signed Executive Orders 12276 - 12284, which provided for the transfer of all Iranian funds to the Ayatollah Khomeini's regime. Jimmy Carter also arranged to give the Panama Canal to the Panamanians, who would, in-turn, have to eventually turn the canal over to

the Communist Chinese. Later, Carter won the Nobel Peace Prize.

In 1996, Osama Bin Laden declared war against the United States through a Jihad manifesto. Keeping the religious propensity for validating murder, Bin Laden stepped-in behind the Ayatollah Khomeini to effectuate religious totalitarianism. The religious zealots, who themselves abandoned Muslim fidelity, were becoming bolder. Recruiting efforts occurred within the masques through hate speech, man-made religious edits, and self-promoting interpretations of the Koran.

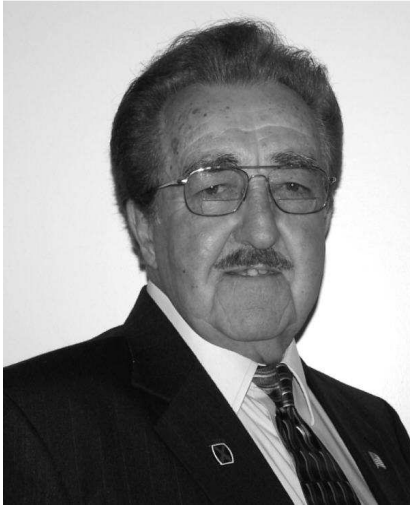

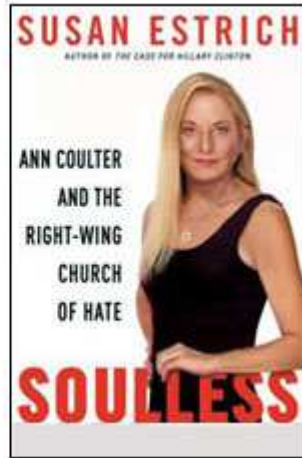
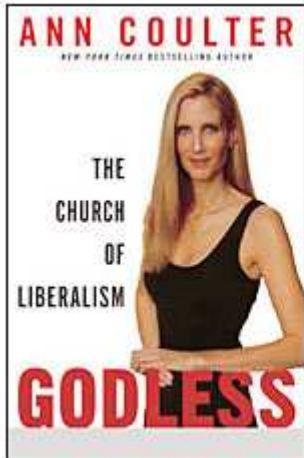

Rep. Gerry Eastman Studds (D-MA), the first openly gay member of Congress, had homosexual relations with a 17-year-old page and made sexual advances to two others. He admitted an "error in judgment", but refused to apologize. Studds, who married his husband, Dean Hara, a week after Massachusetts legalized gay marriages in '05, died on Oct. 14, 2006. Gay activists think Hara should get death bennies.

The list of Republican and Democrat sexual predators and marriage vow breakers is a long one, and no one party is any cleaner than the other. But this doesn't mean taxpayers should foot the bill for a Congressional Page prey-base.
