



### **The Fickle Petroleum Market**



At the close of the day on Friday, May 4, 2007, oil ended the day at \$61.93 bbl. Yet the Citgo gas station in Negaunee was still selling their gas for \$3.18.9 per gallon on Sunday, May 6, 2007.

The word on the street is that the owner(s) of Citgo allegedly dictate the going gas rate in the neighborhood. Although the Michigan Attorney General's office had been made aware of the price-fixing by Krist Oil Company of Iron River, and even provided names of people they should interview nearly two years ago, the extortion of motorists still continues. It probably wouldn't be so bad if you and I weren't spending billions to keep the oil flowing from the Middle East.

There is no doubt that if the petroleum market is so fickle that oil prices fluctuate \$50 and \$75 per barrel, then the U. S. Congress and the President need to re-regulate the gas and oil market. This is especially important for Americans who have no choice but to drive to and from work or make a living delivering pizzas, newspapers and even the mail

Most delivery and service jobs don't pay

very well. It would be safe to assume that nearly a quarter of the citizens need to work 30 minutes to afford one gallon of gasoline; or a full 8 hours to fill a 16-gallon tank with gas.


When the oil prices peaked in 2006, our very own Princess with the Golden Ninny, Jennifer Granholm, contemplated dropping the state gas tax. She never did. Citizens around the country pay an average of \$.62 per

gallon in taxes; in Michigan motorists pay \$.35.2 in state tax, 6% sales tax and a \$.0.875 environmental tax. Oil companies make \$.09.

When we combine all of this with the fact that the American auto industry has failed in their research and development of fuel-efficient auto engines, we once again pay for extreme levels of incompetence, all the way from private business to the halls of Congress and at nearly every point between. If the war in Iraq is being fought over oil like the Democrats say it is, then we should not have to pay more that \$1.49 per gallon for gasoline.

The free-market system is wonderful, as long as the free-market system regulates and polices itself. With the exception of the people themselves, there is no more fundamental need for a good, thriving economy than the economical and abundant access to the fuel that drives that economy.

By May23, 2007, Citgo gas in Negaunee cost \$3.549, while just over three miles away at a small convenience store in Ishpeming, the gas was just \$3.459. The Holiday Station Store in Ishpeming was \$3.469 and the Holiday Station Store directly across from the Citgo station in Negaunee was selling gas for \$3.549 per gallon.

# The Dark Side of Diversity By Patrick J. Buchanan

Since the massacre of 32 students and teachers at Virginia Tech, the mainstream media has obsessed over the fact the crazed gunman was able to buy a Glock in the state of Virginia.

Little attention has been paid to the Richmond legislators who voted to make "Hokie Nation," a Middle American campus of 26,000 kids, a gun-free zone where only the madman had a semi-automatic.

Almost no attention has been paid to the fact that Cho Seung-Hui was not an American at all, but an immigrant, an alien. Had this deranged young man who secretly hated us never come here, 32 people would be heading home from Blacksburg for summer vacation.

What happened in Blacksburg cannot be divorced from what's been happening to America since the immigration act brought tens of millions of strangers to these shores, even as the old bonds of national community began to disintegrate and dissolve in the social revolutions of the 1960s.

To intellectuals, what makes America a nation is ideas – ideas in the Declaration of Independence, Bill of Rights, Gettysburg Address and Dr. King's "I Have a Dream" speech.

But documents no matter how eloquent and words no matter how lovely do not a nation make. Before 1970, we were a people, a community, a country. Students would have said aloud of Cho: "Who is this guy? What's the matter with him?"

Teachers would have taken action to get him help – or get him out.

Since the 1960s, we have become alienated from one another even as millions of strangers arrive every year. And as Americans no longer share the old ties of history, heritage, faith, language, tradition, culture, music, myth or morality, how can immigrants share those ties?

Many immigrants do not assimilate. Many do not wish to. They seek community in their separate subdivisions of our multicultural, multiracial, multiethnic, multilingual mammoth mall of a nation. And in numbers higher than our native born, some are going berserk here.

The 1993 bombers of the World Trade Center and the killers of 9-11 were all immigrants or illegals. Colin Ferguson, the Jamaican who massacred six and wounded 19 in an anti-white shooting spree on the Long Island Railroad, was an illegal. John Lee Malvo, the Beltway Sniper, was flot-sam from the Caribbean.

Angel Resendez, the border-jumping rapist who killed at least nine women, was an illegal alien. Julio Gonzalez, who burned down the Happy Land social club in New York, killing 87, arrived in the Mariel boatlift.

Ali Hassan Abu Kama, who wounded seven, killing one, in a rampage on the observation deck of the Empire State Building, was a Palestinian. As was Sirhan Sirhan, the assassin of Robert Kennedy.

The rifleman who murdered two CIA employees at the McLean, Va., headquarters was a Pakistani. When Chai Vang, a Hmong, was told by a party of Wisconsin hunters to vacate their deer stand, he shot six to death. Peter Odighizuwa, the gunman who killed the dean, a teacher and a student at the Appalachian School of Law, was a Nigerian.

Hesham Hadayet, who shot up the El Al counter at LAX, killing two and wounding four, was an Egyptian immigrant.Gamil al-Batouti, the copilot who yelled, "I put my faith in Allah's hands," as he crashed his plane into the Atlantic after departing JFK Airport, killing 217, was an Egyptian.

Mohammed Reza Taheri-azar, the UNC graduate who ran his SUV over nine people on Chapel Hill campus and said he was "thankful for the opportunity to spread the will of Allah," was an Iranian.

Juan Corona, who murdered 25 people in California to be ranked with the likes of Ted Bundy and John Wayne Gacy, was a Mexican.

Where does one find such facts? On VDARE.com, a website that covers the dark side of diversity covered up by a politically correct media, which seem to believe it is socially unhealthy for us Americans to see any correlation at all between mass migrations and mass murder.

## NewsMax Poll: Just 4 Percent Favor Immigration Plan

# Awarding the Inept c. J. Williams

As of May 23, 2007, Michigan replaced Mississippi for having the highest unemployment rate nation-wide. Michigan's per-capita income is 6 percent below the national average, yet the average state employee in Michigan receives a salary and benefits package worth nearly \$75,000 and school employee retirement benefits, funded with your tax dollars, will eat up 30 percent of education payrolls by the year 2020.

Michigan citizens pay Lansing legislators a base salary of \$79,650 per year, making the lawmakers the second-highest paid legislators in America. Those in leadership positions receive more; for instance, the House speaker is paid a base salary of \$106,650 and the Senate majority leader is paid \$105,650. In some cases, these men and women also benefit financially from their private business enterprises and investments.

Though I was unable to find current data on benefits other than salary, which our state legislators receive from taxpayers, I did track down information pertaining to two years ago.

In 2005, Michigan lawmakers could claim \$1,000 a month for meals and other expenses without showing receipts, just as they can do today. They could also claim mileage for one round trip between home and Lansing each week and be reimbursed for travel within their districts at a rate of 40.5 cents per mile. Taxpayers foot the bill for their health benefits, too.



On top of this in 2005, Michitaxpayers were giving each the 110 House of Representative members almost \$95,000 annually to run their office and the 38 senators

each being given close to \$60,000 per year.

Although there isn't a universal definition of what constitutes a "full time" legislature, the Michigan legislature is one of only eleven in the nation that's considered as working full-time. In 2005, that amounted to less than a third of the year for members of the House, which was in session 109 days, and less than a third of the year for members of the Senate, which was in session for a mere 93 days.

The inaction of our well-paid legislators to make things better for struggling Michigan citizens, not worse, is inexcusable. While they have more than adequate income to meet their own needs, it seems they and Two-Penny Jenny would rather waste time bickering over whether or not to increase taxes and/or broaden the scope of service fees than to do anything constructive for taxpayers' wallets.

The feet dragging in Lansing amounts to nothing more than a childish game of wrangling over who has the best toys, the Democrats or Republicans, and while they're playing tug-of-war with their respective budget proposals, more and more families go under or move out of state in search of a better "quality of life".

Are you being paid \$79,650 to work only 93 days? Is anyone handing you \$95,000 to pay household expenses or \$1,000 a month for incidental costs such as eating in a restaurant? Is anyone reimbursing you 40.5 cents per mile to get to the grocery store or to public meetings? Unless you're one of our fat-cat politicians, vou're not.

Michigan taxpayers are sorely in need of a legislature that's able to get its head out of its nether regions and realize that its collective constituency has about had all it can stand of funding inept lawmakers who don't have to worry about where their next meal is coming from because they're feeding from the public trough; inept lawmakers who are awarded an annual salary and bennies worth millions upon millions of dollars each year, but only work "full-time" a quarter or third of the year promoting their party's platform and doing very little to help Michigan taxpayers keep a little jingle in their pocket after they pay their bills. ~CI

If you are one of those Americans who don't pay much attention to politics, you have been blessed in many ways. Michigan's Rainy Day Fund and the state's constitutionally required balanced budget have disappeared.

Reliance on foreign oil and high gas prices.

Excessive fees and interest rates charged by credit card companies. American companies moving their industries to foreign lands and importing the goods back into America.

7. Illegal immigration, unsecured borders and a reluctance to enforce immigration laws.

Mr. Stupak campaigned years ago for his first term in Congress by proclaiming that he was going to put Social Security in a locked box. Spending excess Social Security money has been the standard of Congress since the Lyndon Johnson Administration.

Michigan's Rainy Day Fund was in place to help get the State through bad economic times. The voters passed an Amendment to the State's Constitution requiring a balanced budget; no more borrowing or overspending. Granholm campaigned last year on the premise that she has a plan to rescue Michigan from its impoverished and anemic economy. Evidently taking a page from the John Kerry and Clinton playbook, Granholm is waiting for the right moment to share her plan.

Long lines at the gas pumps prevailed during the Jimmy Carter Administration. It was obvious thirty years ago that America needed to do something about our reliance on oil in general and on foreign oil more specifically. Carl Levin has been Michigan's US Senator since 1979. Bart Stupak was identified as the advocate in two recent newspaper articles, which suggested that he is now going to inves-

tigate the high gas prices. Evidently the issue of high gas prices is new to Stupak; much like the ocean-going vessels emptying their ballast tanks in the fresh water of the Great Lakes, effectively unloading invasive species into the fresh water was suddenly new to Stabenow and Levin a few years ago.

Legislators at state and national levels are climbing all over each other to impose health mandates on citizens. Like the tobacco tax that directly targeted consumer pocket books, that success has given the politicians the incentive to punish consumers of fatty foods. Alcohol is taxed well enough at this point, so it is unlikely that the number one factor in fatal accidents and domestic violence will be

targeted yet. Michigan, Republi-Michelle can McManus has sponsored a bill to ban smoking on beaches the Michigan. Meanwhile, a Democrat in California is trying to criminalize the spanking of children.

Senator Carl Levin sent out an e-mail to those he thought would be interested in his campaign to tighten up controls

over credit card interest and fees. Credit Cards have been charging around 19% interest for years, about 1% less than Guido the knee-cap specialist.

There is a combination of high wages and an unprecedented tax burden on industries located within the borders of America; the first is just the cost of doing business. Although the export of jobs and import of goods has been a festering problem, no one in Congress has stood up and at least denied the import of goods from nations that do not have a duly elected representative government. #### **New Michigan State Park Proposed:**

But, we can't fund what we already have! C. J. Williams

In a move that defies understanding and logic at anytime, but particularly when the state is mired in a major budget crisis, three Michigan senators and two representatives have proposed a legislative package to develop a new state park, complete with a "voluntary" user fee. If their plans come to fruition, it won't be just your run of the mill state park and the majority of the people who might want to visit it definitely won't be able to pitch a tent or sit around the campfire there, either.

On April 24<sup>th</sup>, Sen. Michelle McManus (R- 35<sup>th</sup> District) introduced SB 429 to establish that the bottoms of the Great Lakes within the boundaries of Michigan would be considered a "Great Lakes State Park."

The McManus bill would amend 1994 PA 451, entitled the "Natural Resources and Environmental Protection Act" and add Section 7147, which would create another park.

The park boundary would include all of the swamp or submerged land lying along the borders of Lakes Erie, Huron, Michigan, Superior and St.

Clair, except the Lake St. Clair Flats and areas purposefully set apart for public shooting and hunting, and extend outward to the state boundary on the lakes. The park premises described don't include any islands in the lake to which the state doesn't have title, unless the state first acquires the title, but will include swamp or submerged lands owned or acquired by the state that border upon the lakes or in or upon the bayous emptying into the lakes.

To compliment the McManus bill, SB 430 was introduced by Sen. Patricia Birkholz (R-24<sup>th</sup> District) to create a segregated fund, the money in which would be used for management of the underwater "state park". Money in the fund could be used to promote tourism, pay for the intentional sinking of vessels as diving destinations, for law enforcement, and other purposes specified in the bill.

Another complimentary bill, SB 431, has

been proposed by Upper Peninsula Sen. Mike Prussi (D-38<sup>th</sup> District) to authorize the creation and sale of an optional, voluntary Great Lakes State Park "pass", which would depict some aspect of underwater aquatic life or recreation, and sell for \$15. It wouldn't be necessary to acquire the pass to dive on the Great Lakes bottomlands that presumably will become a state park should this balderdash be passed.

Jumping on the bandwagon in support of



these three bills is Sen. Jason Allen, a Republican who represents the 37<sup>th</sup> District that encompasses the UN's University of Michigan Biosphere near Petosky.

Additional legislation surfaced in the House of Representatives on April 24th. Rep. Steve Lindberg, (D- Marquette County) introduced HB-4638 to increase the size and revise the makeup of the state Underwater Salvage and Preserve Committee, and rename it the "Great Lakes State Park and Salvage Advisory Authority", provided SB 429 passes.

The fifth bill, HB 4639, was introduced on the same day by Rep. Dan Acciavatti (R-District 32) to revise references in the law regulating abandoned or sunken vessels or other property in the Great Lakes to reflect the "Great Lakes State Park and Salvage Authority" and park proposed through the Lindberg and McManus bills.





Now, folks, is it really necessary to create a new state park, complete with the bloated bureaucracy of an advisory authority to compliment it, in order to promote diving "tourism" in Michigan? Is it advisable to add to the state's budget woes with another park and the park management onus that would

ensue? Is it in your best interest to create another fund supported by "user fees" to pay for more of what the state already can't financially support, namely our state parks and the law enforcement entities that police them?

Do some of our legislators believe the Michigan Sheeple are so dumbed-down that we don't realize that, should SB 429 pass, it will be only a matter of time before bouncing bait off the bottom of the Great Lakes will be outlawed, as will be putting down an anchor that would disturb the pristine lake bottom? Do they truly believe we'll buy into the idea of a voluntary "user fee' staying voluntary for long or that we for even one minute think we'll never have to pay to put a boat in the water or pay to park

Could this legislation be part of the groundwork for the coming "Heart of the Continent" Wilderness Park, a bi-national initiative promoted by the Canadian Parks and Wilderness Society and the Wildlands Project, which will encompass the entire Upper Peninsula? Is it yet another attempt to control fresh water resources in the state? You betcha it could be and likely is!

If those who represent us in Lansing have nothing better to do than sit around and drum up idiotic legislation such as these bills appear to be, maybe it's time to put them on a part time basis. Obviously, several of them have way too much time on their hands and would rather enact new asinine laws than balance the state budget or improve Michigan's economy that's already in the bottomlands.  $\sim$  CJ

## What's UP By J. C. Powers


On the morning of Sunday, May 20, 2007, some residents of the Upper Peninsula woke up to temps around 27F degrees and snow on the ground. We're used to dramatic changes in temperatures and weather conditions here in the U. P.; in fact, we even have a saying that goes, "If you don't like the weather, wait five minutes and it'll change."

Although we have experienced some very warm days, primarily on those days when the sun is shining and our government sprays us with chemicals used for weather modification experiments, we still see the typical changes in our weather. However, most storms that now approach us are cyclonic. That is, they spin and we sometimes get hit two or more times by the same storm as it spins across the northern tier states.
